1 AN ACT concerning

2 **Built to Learn Act of 2020**

3 FOR the purpose of requiring certain public school construction projects in Prince George's
4 County to comply with a certain memorandum of understanding under certain
5 circumstances; authorizing, on or before a certain date, the Prince George's County
6 government, the Prince George's County Board of Education, and a private entity to
7 enter into a certain public-private partnership agreement; requiring a certain
8 public-private partnership agreement, if entered into by certain parties, to be
9 reviewed by the Maryland Stadium Authority and approved by the Interagency
10 Commission on School Construction in order for certain provisions of law to apply;
11 requiring the Authority to deposit certain amounts into certain funds under certain
12 circumstances during certain fiscal years; requiring the Prince George's County
13 government and the Prince George's County Board to deposit certain amounts
14 required under a certain public-private partnership agreement into a certain fund
15 under certain circumstances during certain fiscal years; requiring the Interagency

3 George's County government, the Prince George's County Board, and the
4 Interagency Commission on School Construction to submit a certain report on a

1 Authority are payable only from certain funds; specifying that certain bonds issued
2 under this Act are a limited obligation of the Authority payable solely from certain
3 pledged money and are not a debt, liability, moral obligation, or pledge of the faith
4 and credit or taxing power of the State, the Authority, or any other governmental
5 unit; requiring the Authority to obtain approval from the Board of Public Works
6 before each issuance of bonds to finance improvements to public school facilities;
7 authorizing the Authority to issue bonds to finance improvements to a public school
8 facility on or after a certain date; prohibiting the debt service for all outstanding
9 bond issues related to improvements to public school facilities from exceeding a
10 certain amount under certain circumstances; requiring the Comptroller to deposit
11 certain amounts into a certain fund on or before certain dates each year; authorizing
12 the Authority to transfer certain funds under certain circumstances; requiring the
13 Authority and county boards of education to take certain actions in connection with
14 public school facility projects; providing for the payment of certain costs; requiring
15 the Authority to submit a certain report on or before a certain date each year;
16 requiring the Authority to complete a certain evaluation on or before a certain date;
17 requiring the Interagency Commission on School Construction to submit a report on
18 a certain evaluation on or before a certain date; requiring the Interagency

34 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 35 That Section(s) 4–126.1 and 5–206, respectively, of Article – Education of the Annotated
 36 Code of Maryland be renumbered to be Section(s) 4–126.2 and 5–324, respectively.

37 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
 38 as follows:

Article – Education

2 4–126.

3 (a) (1) In this section the following words have the meanings indicated.

4 (2) “Alternative financing methods” includes one or more of the following
5 methods:

6 (i) Sale–leaseback arrangements, in which a county board agrees to
7 transfer title to a property, including improvements, to a private entity that simultaneously
8 agrees to lease the property back to the county board and, on a specified date, transfer title
9 back to the county board;

10 (ii) Lease–leaseback arrangements, in which a county board leases
11 a property to a private entity that improves the property and leases the property, with the
12 improvements, back to the county board;

13 (iii) Public–private partnership agreements, in which a county board
14 contracts with a county revenue authority or a private entity for the acquisition, design,
15 construction, improvement, renovation, expansion, equipping, or financing of a public
16 school, and may include provisions for cooperative use of the school or an adjacent property
17 and generation of revenue to offset the cost of construction or use of the school;

18 (iv) Performance–based contracting, in which a county board enters
19 into an energy performance contract to obtain funding for a project with guaranteed energy
20 savings over a specified time period;

21 (v) Preference–based arrangements, by which a local governing body
22 gives preference first to business entities located in the county and then to business entities
23 located in other counties in the State for any construction that is not subject to prevailing
24 wage rates under Title 17, Subtitle 2 of the State Finance and Procurement Article;

25 (vi) Design–build arrangements, that permit a county board to
26 contract with a design–build business entity for the combined design and construction of
27 qualified education facilities, including financing mechanisms where the business entity
28 assists the local governing body in obtaining project financing; and

29 (vii) Design–construct–operate–maintain–finance arrangements that
30 permit a county board to contract with a county revenue authority or a private entity for
31 the design, construction, operation, and maintenance of a public school under terms agreed
32 to by the parties.

33 (b) (1) Except when prohibited by local law, in order to finance or to speed
34 delivery of, transfer risks of, or otherwise enhance the delivery of public school construction,
35 a county board, with the approval of the county governing body in accordance with
36 subsection (d) of this section, may:

1 (i) Use alternative financing methods;

2 (ii) Engage in competitive negotiation, rather than competitive
3 bidding, in limited circumstances, including construction management at-risk
4 arrangements and other alternative project delivery arrangements, as provided in
5 regulations adopted by the Interagency Commission on School Construction;

6 (iii) Accept unsolicited proposals for the development of public
7 schools in limited circumstances, as provided in regulations adopted by the Interagency
8 Commission on School Construction;

9 (iv) Solicit proposals for the development of public schools;

10 (v) Lease property from a county revenue authority or a private
11 entity for use as a public school facility; and

12 (vi) Use quality-based selection, in which selection is based on a
13 combination of qualifications and cost factors, to select developers and builders, as provided
14 in regulations adopted by the Interagency Commission on School Construction.

15 (2) The alternative financing methods described under paragraph (1)(i) of
16 this subsection may include reserves sufficient to cover operation, facility renewal,
17 maintenance, and energy costs as part of a contract.

18 (c) Use of alternative financing methods under this section may not be construed
19 to prohibit the allocation of State funds for public school construction to a project under the
20 Public School Construction Program.

21 (d) A county board may not use alternative financing methods under this section
22 without the approval of the county governing body.

23 (e) (1) (i) Except as provided in paragraphs (2) and (3) of this subsection, §
24 2-303(f) and Title 5, Subtitle 3 of this article and the regulations that govern the Public
25 School Construction Program do not apply to projects that use alternative financing
26 methods under this section.

27 (ii) Nothing in this section may be construed to authorize or require
28 State approval before an alternative financing method may be used by a local school system.

29 (2) If a project that receives State funding uses alternative financing
30 methods under this section, the project shall be submitted to the Interagency Commission
31 on School Construction for review.

32 (3) (i) Projects that use alternative financing methods under this
33 section and receive State funding shall comply with the following requirements:

1 1. Except as provided in subparagraph (ii) of this paragraph,
2 the State and local cost–share established for each county in regulations;

3 2. Except as provided in subparagraph (ii) of this paragraph,
4 the maximum State construction allocation for each project approved for State funding;

5 3. Except as provided in subparagraph (ii) of this paragraph,
6 the approval of project funding by the Interagency Commission on School Construction;

7 4. Smart growth requirements;

8 5. Minority business enterprise requirements;

9 6. Prevailing wage requirements;

10 7. Environmental requirements; and

11 8. A requirement for a procurement process that includes
12 public notice and results in the most advantageous proposal.

13 (ii) In Prince George’s County, projects that use alternative
14 financing methods under this section and receive State funding for a yearly availability
15 payment:

16 1. Do not have to comply with the requirements under
17 subparagraph (i)1 through 3 of this paragraph;

18 2. Shall comply with the requirements under subparagraph
19 (i)4 through 8 of this paragraph; and

20 3. [Shall] **EXCEPT AS PROVIDED IN SUBPARAGRAPH (III)**
21 **OF THIS PARAGRAPH, SHALL** comply with a three–party memorandum of understanding
22 entered into and signed by the Prince George’s County Board, Prince George’s County, and
23 the Interagency Commission on School Construction that:

24 A. Specifies the roles, rights, terms, and responsibilities of
25 each party with respect to school projects undertaken with a private or public entity using
26 alternative financing methods, including any amounts the parties are required to deposit
27 into the Prince George’s County Public–Private Partnership Fund established under §
28 **[4–126.1] 4–126.2** of this subtitle;

29 B. Specifies that § 2–203(f) and Title 5, Subtitle 3 of this
30 article and regulations governing the Public School Construction Program are not
31 applicable to projects using alternative financing methods;

1 C. Requires the Prince George's County Board to submit
2 projects to the Interagency Commission on School Construction for review before
3 commencement of the project;

4 D. Specifies the time frames in which the Interagency
5 Commission on School Construction shall complete its review of projects;

6 E. Requires the Prince George's County Board to submit
7 annual reports to Prince George's County and the Interagency Commission on School
8 Construction during the term of the alternative financing method contract with the public
9 or private entity; and

10 F. Identifies a dedicated source of State funding for an
11 availability payment.

12 **(III) IN PRINCE GEORGE'S COUNTY, FOR A PROJECT THAT USES**
13 **ALTERNATIVE FINANCING METHODS UNDER THIS SECTION AND RECEIVES STATE**
14 **FUNDING FOR A YEARLY AVAILABILITY PAYMENT FROM THE SUPPLEMENTAL**
15 **PUBLIC SCHOOL CONSTRUCTION FINANCING FUND UNDER § 10-658 OF THE**
16 **ECONOMIC DEVELOPMENT ARTICLE, THE PROJECT SHALL COMPLY WITH THE**
17 **PROJECT MEMORANDUM OF UNDERSTANDING UNDER § 10-650 OF THE ECONOMIC**
18 **DEVELOPMENT ARTICLE.**

20 **(A) IN THIS SECTION, "PUBLIC-PRIVATE PARTNERSHIP AGREEMENT"**
21 **MEANS AN AGREEMENT IN WHICH A COUNTY GOVERNMENT AND A COUNTY BOARD**
22 **OF EDUCATION CONTRACT WITH A PRIVATE ENTITY FOR THE ACQUISITION, DESIGN,**
23 **CONSTRUCTION, IMPROVEMENT, RENOVATION, EXPANSION, EQUIPPING, OR**
24 **FINANCING OF A PUBLIC SCHOOL, AND MAY INCLUDE PROVISIONS FOR OPERATION**
25 **AND MAINTENANCE OF A SCHOOL, COOPERATIVE USE OF THE SCHOOL OR AN**
26 **ADJACENT PROPERTY, AND GENERATION OF REVENUE TO OFFSET THE COST OF**
27 **CONSTRUCTION OR USE OF THE SCHOOL.**

28 **(B) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, § 4-126 OF THIS**
29 **SUBTITLE APPLIES TO A PUBLIC-PRIVATE PARTNERSHIP AGREEMENT ENTERED**
30 **INTO IN ACCORDANCE WITH THIS SECTION.**

31 **(C) (1) THIS SECTION APPLIES ONLY IF, ON OR BEFORE JULY 1, ~~2021~~**
32 **2022, THE PRINCE GEORGE'S COUNTY GOVERNMENT AND THE PRINCE GEORGE'S**
33 **COUNTY BOARD ENTER INTO A PUBLIC-PRIVATE PARTNERSHIP AGREEMENT WITH**
34 **A PRIVATE ENTITY TO ENHANCE THE DELIVERY OF PUBLIC SCHOOL CONSTRUCTION**
35 **IN PRINCE GEORGE'S COUNTY.**

1 **(2) BEFORE ENTERING INTO A PUBLIC-PRIVATE PARTNERSHIP**
2 **AGREEMENT UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE PUBLIC-PRIVATE**
3 **PARTNERSHIP AGREEMENT SHALL BE REVIEWED BY THE MARYLAND STADIUM**
4 **AUTHORITY AND APPROVED BY THE INTERAGENCY COMMISSION ON SCHOOL**
5 **CONSTRUCTION.**

6 **(D) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, IN FISCAL**
7 **YEAR 2024 AND EACH FISCAL YEAR THEREAFTER THROUGH NOT LATER THAN**
8 **FISCAL YEAR 2053, IF THE PRINCE GEORGE'S COUNTY GOVERNMENT, THE PRINCE**
9 **GEORGE'S COUNTY BOARD, AND THE PRIVATE ENTITY REMAIN IN THE**
10 **PUBLIC-PRIVATE PARTNERSHIP AGREEMENT DESCRIBED UNDER SUBSECTION (C)**
11 **OF THIS SECTION, THE MARYLAND STADIUM AUTHORITY SHALL DEPOSIT THE**
12 **AMOUNT UNDER § 10-658 OF THE ECONOMIC DEVELOPMENT ARTICLE FROM THE**
13 **SUPPLEMENTAL PUBLIC SCHOOL CONSTRUCTION FINANCING FUND ESTABLISHED**
14 **UNDER § 10-658 OF THE ECONOMIC DEVELOPMENT ARTICLE INTO THE PRINCE**
15 **GEORGE'S COUNTY PUBLIC-PRIVATE PARTNERSHIP FUND ESTABLISHED UNDER §**
16 **4-126.2 OF THIS SUBTITLE.**

17 **(2) PARAGRAPH (1) OF THIS SUBSECTION APPLIES ONLY IF THE**
18 **PUBLIC-PRIVATE PARTNERSHIP AGREEMENT DESCRIBED UNDER SUBSECTION (C)**
19 **OF THIS SECTION INCLUDES:**

20 **(I) A MINIMUM OF ~~10~~ 6 SCHOOLS THAT WILL BE IMPROVED,**
21 **CONSTRUCTED, OR RENOVATED AND OPERATED AND MAINTAINED UNDER THE**
22 **PUBLIC-PRIVATE PARTNERSHIP AGREEMENT; AND**
