1 AN ACT concerning

2 **St. Mary's County – Metropolitan Commission – Collection of Fees, Assessments,**
3 **and Nonsubstantive and Clarifying Revisions**

4 FOR the purpose of revising, restating, and recodifying certain terms; updating the plans,
5 regulations, and ordinances of St. Mary's County in accordance with which a
6 connection to a completed water main or sewer of the St. Mary's County Metropolitan
7 Commission shall be made under certain circumstances; clarifying that the
8 Metropolitan Commission shall have full and complete jurisdiction over certain
9 appurtenances with certain systems of the Metropolitan Commission; updating the
10 plans and budgets in which certain projects are identified and on which certain
11 calculations are based with regard to certain charges imposed by the Metropolitan
12 Commission; clarifying that the Metropolitan Commission may commence a certain
13 ~~court~~ third-party action before a property is sold for purposes of collecting certain
14 unpaid connection charges under certain circumstances; revising, restating, and
15 recodifying certain waiver, additional sewer charge, and exemption provisions;
16 updating a certain approval process for the incorporation of a certain plan and
17 certain budget into the St. Mary's County Comprehensive Water and Sewerage Plan;
18 defining certain terms; making stylistic changes; making conforming changes; and
19 generally relating to the St. Mary's County Metropolitan Commission.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article 19 – St. Mary’s County**

4 **113–1. DEFINITIONS.**

5 **FOR THE PURPOSES OF THIS CHAPTER THE FOLLOWING DEFINITIONS SHALL**
6 **APPLY:**

7 **A. CAPITAL CONTRIBUTION CHARGE. THE TERM “CAPITAL**
8 **CONTRIBUTION CHARGE” SHALL MEAN AN AMOUNT BASED ON CAPITAL COSTS THAT**
9 **IS IMPOSED AND COLLECTED ON A NEW CONNECTION TO A WATER SUPPLY OR**
10 **SEWERAGE SYSTEM UNDER THIS CHAPTER.**

11 **B. CONNECTION CHARGE. THE TERM “CONNECTION CHARGE” SHALL**
12 **MEAN A CAPITAL CONTRIBUTION CHARGE OR CONNECTION FEE.**

13 **C. CONNECTION FEE. THE TERM “CONNECTION FEE” SHALL MEAN AN**
14 **AMOUNT BASED ON THE COST OF CONNECTION THAT IS IMPOSED ON A NEW**
15 **CONNECTION TO A WATER SUPPLY OR SEWERAGE SYSTEM UNDER THIS CHAPTER.**

16 **D. COUNTY. THE TERM “COUNTY” SHALL MEAN THE COMMISSIONERS OF**
17 **ST. MARY’S COUNTY.**

18 **E. DWELLING. THE TERM “DWELLING” SHALL MEAN A PRINCIPAL**
19 **RESIDENCE OF A HOMEOWNER AND INCLUDES THE LOT ON WHICH A HOUSE IS**
20 **SITUATED.**

21 **F. EDU. THE TERM “EDU” SHALL MEAN EQUIVALENT DWELLING UNIT**
22 **AND SHALL EQUATE TO THE GENERALLY ACCEPTED AVERAGE VOLUME IN GALLONS**
23 **PER DAY, OF WASTEWATER GENERATED BY ONE (1) RESIDENTIAL DWELLING UNIT,**
24 **AS DETERMINED AND ALLOCATED BY THE ST. MARY’S COUNTY DEPARTMENT OF**
25 **LAND USE AND GROWTH MANAGEMENT.**

26 **G. FACILITIES PLAN. THE TERM “FACILITIES PLAN” SHALL MEAN A PLAN**
27 **PREPARED PERIODICALLY BY THE METROPOLITAN COMMISSION, IN CONJUNCTION**
28 **WITH THE ST. MARY’S COUNTY DEPARTMENT OF LAND USE AND GROWTH**
29 **MANAGEMENT TO EVALUATE, IDENTIFY AND PRIORITIZE RECOMMENDED CAPITAL**
30 **IMPROVEMENTS TO PUBLIC WATER AND SEWER SYSTEMS IN ST. MARY’S COUNTY,**
31 **OVER A SPECIFIED TIME PERIOD.**

1 **H. HOMEOWNER.** THE TERM “HOMEOWNER” SHALL MEAN A PERSON WHO
2 RESIDES IN A DWELLING AND HAS AN OWNERSHIP INTEREST IN THE DWELLING,
3 INCLUDING A LIFE ESTATE, JOINT TENANCY, TENANCY IN COMMON, TENANCY BY
4 THE ENTIRETY, OR FEE SIMPLE INTEREST.

5 **I. METROPOLITAN COMMISSION.** THE TERM “METROPOLITAN
6 COMMISSION” SHALL MEAN THE ORGANIZATION KNOWN AS THE ST. MARY’S
7 COUNTY METROPOLITAN COMMISSION, TO INCLUDE THE STAFF OF THE
8 METROPOLITAN COMMISSION.

9 **J. PRINCIPAL RESIDENCE.** THE TERM “PRINCIPAL RESIDENCE” SHALL
10 MEAN A HOUSE THAT IS OCCUPIED BY A HOMEOWNER FOR MORE THAN SIX (6)
11 MONTHS OF A CONSECUTIVE TWELVE (12) MONTH PERIOD, UNLESS THE REASON
12 FOR NON-OCCUPANCY IS THE RESULT OF HOSPITALIZATION OR RESIDENCY IN A
13 LONG-TERM HEALTH CARE INSTITUTION.

14 **K. PUBLICATION.** THE TERM “PUBLICATION” SHALL MEAN NOTICE TO ALL
15 PERSONS HAVING ANY INTEREST IN A PROPERTY.

16 **L. READY-TO-SERVE CHARGE.** THE TERM “READY-TO-SERVE CHARGE”
17 SHALL MEAN THE MINIMUM CHARGE FOR WATER SERVICE.

18 **M. REMOTE AREA.** THE TERM “REMOTE AREA” SHALL MEAN AN AREA IN
19 WHICH IT IS ECONOMICALLY NOT FEASIBLE TO PROVIDE SERVICE AT THE UNIFORM
20 RATE BECAUSE OF THE DISTANCE OF THE AREA FROM THE PRINCIPAL FACILITIES
21 OF THE METROPOLITAN COMMISSION.

22 **N. REMOTE AREA CHARGE.** THE TERM “REMOTE AREA CHARGE” SHALL
23 MEAN AN ADDITIONAL SERVICE CHARGE TO MEET THE ADDITIONAL COST OF
24 PROVIDING SERVICE TO A REMOTE AREA PROPERTY.

25 **O. SERVICE AREA.** THE TERM “SERVICE AREA” SHALL MEAN ANY AREA OF
26 ST. MARY’S COUNTY IDENTIFIED AS A GROWTH AREA IN THE ST. MARY’S COUNTY
27 COMPREHENSIVE LAND USE PLAN.

28 **P. SERVICE CHARGE.** THE TERM “SERVICE CHARGE” SHALL MEAN THOSE
29 CHARGES AND FEES PRESCRIBED IN THIS CHAPTER WHICH ARE ASSESSED AND
30 COLLECTED TO PAY THE OPERATIONAL COSTS OF THE METROPOLITAN
31 COMMISSION.

32 **Q. SPECIAL SERVICE AREA.** THE TERM “SPECIAL SERVICE AREA” SHALL
33 MEAN AN AREA TO WHICH THE METROPOLITAN COMMISSION HAS DETERMINED IT
34 TO BE ECONOMICALLY INFEASIBLE TO EXTEND OR CONSTRUCT A PUBLIC WATER OR
35 SEWER SYSTEM.

1 **R. SPECIAL SERVICE AREA FEE. THE TERM “SPECIAL SERVICE AREA**
2 **FEE” SHALL MEAN THE FEE ASSESSED AND COLLECTED BY THE METROPOLITAN**
3 **COMMISSION TO OFFSET THE COSTS OF CONSTRUCTING A WATER OR SEWER SYSTEM**
4 **TO SERVE A SPECIAL SERVICE AREA.**

5 **S. STAFF. THE TERM “STAFF” SHALL MEAN ANY AND ALL EMPLOYEES OF**
6 **THE METROPOLITAN COMMISSION TO INCLUDE THE DIRECTOR AND ANY SUCH**
7 **ASSISTANT DIRECTOR(S), GENERAL COUNSEL, DEPARTMENT HEADS AND**
8 **SUPPORTING STAFF AS SHALL BE DEEMED NECESSARY AND APPROPRIATE, FROM**
9 **TIME TO TIME, TO FULFILL THE REQUIREMENTS OF THIS CHAPTER.**

10 **T. SYSTEM IMPROVEMENT CHARGE. THE TERM “SYSTEM IMPROVEMENT**
11 **CHARGE” SHALL MEAN THE MONTHLY PER EDU CHARGE, COLLECTED BY THE**
12 **METROPOLITAN COMMISSION TO PAY FOR THE COSTS OF CAPITAL PROJECTS FOR**
13 **THE COMPREHENSIVE IMPROVEMENT OR REPLACEMENT OF EXISTING WATER OR**
14 **SEWERAGE SYSTEMS AND CENTRAL TREATMENT AND PROCESSING FACILITY**
15 **EXPANSIONS AND UPGRADES.**

16 [113–1.] **113–2.** Commission; appointment; tenure; staff.

17 **A. (1)** For the purpose of carrying out the provisions of this chapter, the
18 sanitary districts created are under the jurisdiction of the **METROPOLITAN** Commission
19 **BOARD** of seven (7) voting members and one (1) nonvoting member.

20 **(2) (A)** Each voting member of the **METROPOLITAN** Commission
21 **BOARD** shall be appointed by the [Board of County] Commissioners of St. Mary’s County
22 as follows:

23 **(I)** one (1) member from each of the first, third, sixth, seventh
24 and eighth districts,

25 **(II)** one (1) member from the second and ninth election
26 districts, and

27 **(III)** one (1) member from the fourth and fifth election districts.

28 **(B)** Each voting member shall reside in the election district [he] **THE**
29 **MEMBER** represents, be a resident taxpayer of [the] **ST. MARY’S** County and be a qualified
30 voter.

31 **(C)** The voting members of the **METROPOLITAN** Commission
32 **BOARD** shall be appointed and shall serve at least one (1) three–year term and shall serve
33 until their successors are appointed and have qualified.

1 **(3)** The nonvoting member of the [commission] **METROPOLITAN**
2 **COMMISSION BOARD** shall be the commanding officer of the Patuxent River Naval Air
3 Station or a designated representative of the commanding officer. The nonvoting member
4 shall represent the interests of the United States Navy with respect to the water and sewer
5 services provided by the **METROPOLITAN** Commission to the Patuxent River Naval Air
6 Station and the Webster Field Annex. The nonvoting member shall serve until the
7 succeeding commanding officer is appointed. If the commanding officer designates a
8 representative, the representative shall serve at the pleasure of the commanding officer
9 and may be replaced at any time.

10 **(4)** Those persons serving as members of the **METROPOLITAN**
11 Commission **BOARD** immediately prior to June 1, 1976, shall continue to serve in their
12 respective positions until the expiration of their terms. As the term of each voting member
13 expires, [his] **THE MEMBER'S** successor shall be appointed by the [Board of County]
14 Commissioners of St. Mary's County.

15 **(5)** Except for a nonvoting member, any vacancy in the membership of the
16 **METROPOLITAN** Commission **BOARD** shall be filled by appointment by the [Board of
17 County] Commissioners of St. Mary's County for the unexpired term.

18 B. [Representative of Board of County] **OFFICERS. THE METROPOLITAN**
19 **COMMISSION BOARD SHALL ELECT ONE (1) OF ITS VOTING MEMBERS AS CHAIRMAN**
20 **AND ONE (1) OF ITS VOTING MEMBERS AS VICE CHAIRMAN, WHO SHALL SERVE IN**
21 **THE ABSENCE OR DISABILITY OF THE CHAIRMAN. EACH VOTING MEMBER SHALL**
22 **SERVE AS A REPRESENTATIVE OF THE Commissioners OF ST. MARY'S COUNTY AND**
23 **as A liaison with THE METROPOLITAN Commission.**

24 C. [Officers and personnel. The Commission shall elect one (1) of its voting
25 members as Chairman and one (1) of its voting members as Vice Chairman, who shall serve
26 in the absence or disability of the Chairman.] **STAFF.**

27 **(1)** The **METROPOLITAN** Commission shall appoint and fix the
28 compensation of a Director, a Secretary, and engineering, legal, clerical and other personnel
29 which the **METROPOLITAN** Commission deems necessary to carry out the provisions of
30 this chapter.

31 **(2)** The **METROPOLITAN** Commission may offer a contract to the Director
32 and Assistant Director. The **METROPOLITAN** Commission may, by contract, appoint and
33 fix the compensation of a General Counsel, Treasurer or Chief Financial Officer, Chief
34 Engineer, and any other department director.

35 **(3)** The Director may not serve concurrently as the Director and as General
36 Counsel to the **METROPOLITAN** Commission. The Director shall be the immediate
37 supervisor of the General Counsel, Treasurer or Chief Financial Officer, Chief Engineer,
38 and any other department director.

1 D. **(1)** The annual compensation of each voting member of the [St. Mary's
2 County] Metropolitan Commission shall be determined by the [Board of County]
3 Commissioners of St. Mary's County. The annual compensation shall be payable quarterly,
4 or more frequently as may be prescribed by the [Board of County] Commissioners **OF ST.**
5 **MARY'S COUNTY.**

6 **(2)** A nonvoting member may not receive compensation.

7 E. **(1)** The Treasurer appointed by the **METROPOLITAN** Commission shall be
8 the collector of all charges and assessments made by the **METROPOLITAN** Commission
9 and shall receive and account for all moneys which shall be due and payable to the
10 **METROPOLITAN** Commission from any source. The **METROPOLITAN** Commission may
11 appoint the same person Secretary and Treasurer, in which case the official title of that
12 person shall be Secretary–Treasurer. The **METROPOLITAN** Commission may appoint also
13 a Deputy Treasurer to act in the absence of the Treasurer.

14 **(2)** All moneys deposited shall be protected by a depository bond or by other
15 securities approved by the **METROPOLITAN** Commission. The Treasurer and any Deputy
16 Treasurer appointed by the **METROPOLITAN** Commission shall give bond to the State of
17 Maryland, the **METROPOLITAN** Commission and the [Board of County] Commissioners of
18 St. Mary's County to the amount of twenty–five thousand dollars (\$25,000.00) or a greater
19 amount that the [County] Commissioners **OF ST. MARY'S COUNTY** prescribe, with a good
20 and sufficient surety, to be approved by the [County] Commissioners **OF ST. MARY'S**
21 **COUNTY.** The bond shall provide, in a form approved by the Maryland Insurance
22 Administration and the County Attorney, that if the individual giving the bond shall well
23 and faithfully execute that individual's office and account to the **METROPOLITAN**
24 Commission for all moneys received on behalf of the **METROPOLITAN** Commission without
25 fraud or delay, the required bond obligation shall be null and void, but shall otherwise
26 remain in full force and effect. The bond, when approved, shall be recorded in the Office of
27 the Clerk of the Circuit Court for St. Mary's County.

28 **(3)** The person so appointed, before entering upon the duties of his office,
29 shall take an oath before the Clerk of the Circuit Court for [the] **ST. MARY'S** County, in
30 form similar to that taken by Collectors of Taxes, except for the title of the office.

31 **(4)** The **METROPOLITAN** Commission may pay the premiums on all bonds.

32 **(5)** All checks issued by the **METROPOLITAN** Commission shall be
33 countersigned by the Chairman or other member of the **METROPOLITAN** Commission
34 authorized by the **METROPOLITAN** Commission to sign checks in place of the Chairman.

35 **(6)** The **METROPOLITAN** Commission shall publish annually a statement
36 of its revenue and expenditures in a newspaper published in [the] **ST. MARY'S** County.

1 F. Audits. An audit of the official financial affairs of the **METROPOLITAN**
2 Commission shall be performed annually by a certified public accounting firm in the State
3 appointed by the [Board of County] Commissioners **OF ST. MARY'S COUNTY**. The
4 **METROPOLITAN** Commission shall recommend a qualified accounting firm to the [Board
5 of County] Commissioners **OF ST. MARY'S COUNTY** on or before June 1 of each year. The
6 audit shall be submitted to the [Board of County] Commissioners **OF ST. MARY'S COUNTY**
7 on or before November 1 of each year. The costs of the audit shall be paid by the
8 **METROPOLITAN** Commission.

9 [113-2.] **113-3.** Same; powers and duties.

10 A. The members of the **METROPOLITAN** Commission are a body politic and
11 corporate, by the name of the "St. Mary's County Metropolitan Commission" [(referred to
12 elsewhere in this chapter as the "Commission")], with the right to use a common seal, to
13 sue and be sued and to do any and all other corporate acts for the purpose of carrying out
14 the provisions of this chapter, including, without limiting the generality of the foregoing,
15 the right and power to make and enter into all contracts or agreements as the
16 **METROPOLITAN** Commission determines with the Federal government, the State of
17 Maryland or any agency or instrumentality of either thereof or with any municipal
18 corporation, county, private corporation, copartnership, association or individual, on terms
19 and conditions which the **METROPOLITAN** Commission approves, relating to the
20 performance of the **METROPOLITAN** Commission's duties, the execution of its rights and
21 powers, the use by the Federal government, the State government or any Federal or State
22 agency, municipal corporation, county or private entity or individual of any water supply
23 or sewerage system constructed or acquired by the **METROPOLITAN** Commission under
24 this chapter or the services therefrom or the facilities thereof or the use by the
25 **METROPOLITAN** Commission of any water supply or sewerage systems owned or operated
26 other than by the **METROPOLITAN** Commission.

27 B. (1) Whenever it is deemed necessary by the **METROPOLITAN** Commission
28 to take or acquire any land, structure or buildings, or any streambed, waterway, water
29 rights or watershed, either in fee or as an easement, within or outside of St. Mary's County,
30 for the construction, extension or maintenance of any water main, sewer or appurtenance
31 thereof, or any sewage treatment plant, reservoir, water treatment plant, storage tank or
32 pumping station, or for the execution by the **METROPOLITAN** Commission of any other
33 power or function vested in it by this chapter, the **METROPOLITAN** Commission may
34 purchase it from the owners or, failing to agree with the owner or owners thereof, may
35 condemn it by proceedings in the Circuit Court for the county in which the land, structures
36 or buildings, streambed, waterway, water rights or watershed is located, as are provided
37 for condemnation of land by public service corporations in the Public General Laws of
38 Maryland.

39 (2) The **METROPOLITAN** Commission may likewise condemn the interest
40 of any tenant, lessee or other person having any right or interest in the land, structures or
41 buildings, streambed, waterway, water rights or watershed. At any time after ten (10) days

1 after the return and recordation of the verdict or award in the proceedings, the
2 **METROPOLITAN** Commission may enter and take possession of the property so
3 condemned, upon first paying to the Clerk of the Court the amount of the award and all
4 costs taxed to that date, notwithstanding any appeal or further proceedings upon the part
5 of the defendant. At the time of payment, however, the **METROPOLITAN** Commission shall
6 give its corporate undertaking to abide by and fulfill any judgment in such appeal or further
7 proceedings.

8 C. When the **METROPOLITAN** Commission plans to borrow any money, the
9 **[Board of County]** Commissioners of St. Mary's County shall review and approve any loan
10 application before the **METROPOLITAN** Commission submits the loan application to a
11 lender.

12 **[113-3.] 113-4.** Sanitary districts.

13 A. St. Mary's County is divided into the following ten (10) sanitary districts in
14 accordance with the resolution adopted by the **[Board of County]** Commissioners of St.
15 Mary's County on September 14, 1972, recorded in Liber No. 1, page 189, entitled "County
16 Commissioner Resolutions," as set forth on a plat of St. Mary's County showing the sanitary
17 district lines, which plat was recorded among the land records of St. Mary's County,
18 Maryland, in Plat Book D.B.K. No. 10, Folio 43, on April 26, 1973. The resolution of the
19 **[Board of County]** Commissioners **OF ST. MARY'S COUNTY** adopted and approved a
20 resolution of the **[St. Mary's County]** Metropolitan Commission duly adopted on August 16,
21 1972. The sanitary districts are also set forth on a plat of St. Mary's County showing the
22 same sanitary district lines and recorded among the land records of St. Mary's County,
23 Maryland, in Plat Book D.B.K. No. 10, Folio 42A, on February 4, 1976. The plat recorded
24 on April 26, 1973, identifies the sanitary districts by reference to the sewage treatment
25 plants (S.T.P.) serving the sanitary districts (e.g., Luckland S.T.P.); the plat recorded on
26 February 4, 1976, and other plats recorded from time to time in connection with the St.
27 Mary's County Water and Sewerage Plan identify the sanitary districts by the names set
28 forth in this section.

29 (1) Luckland Run Sanitary District No. 1.

30 (2) Dukehart Creek Sanitary District No. 2.

31 (3) Leonardtown Sanitary District No. 3.

32 (4) Flood Creek Sanitary District No. 4.

33 (5) Piney Point Sanitary District No. 5.

34 (6) Lake Conoy Sanitary District No. 6.

35 (7) Carroll Pond Sanitary District No. 7.

1 (8) Pine Hill Run Sanitary District No. 8.

2 (9) Manor Run Sanitary District No. 9.

3 (10) Indian Creek Sanitary District No. 10.

4 B. The creation of the sanitary districts is adopted, approved, ratified and
5 confirmed. The sanitary districts are designated and constituted for the purpose of this
6 chapter to be separate sanitary districts and are subject to all of the provisions of this
7 chapter.

8 C. The Mattapany Sanitary District, previously created and described in Chapter
9 342 of the Laws of 1967, was enlarged to include all that portion of St. Mary's County
10 designated as the Pine Hill Run Sanitary District No. 8 and was and is now to be known as
11 the "Pine Hill Run Sanitary District No. 8."

12 D. If the service conditions of any system in a sanitary district are substantially
13 different than conditions of other systems in the district, the [St. Mary's County]
14 Metropolitan Commission, by resolution, may divide the district into subdistricts. Service
15 conditions include financial aspects of instituting and maintaining service.

16 [113-4. Sanitary district boundary lines.]

17 E. The sanitary district boundary lines of any sanitary district may be changed
18 by the adoption by the **METROPOLITAN** Commission of a resolution which shall refer to a
19 plat of St. Mary's County upon which the revised sanitary district lines are shown clearly
20 and which sets forth findings that the change in the boundary lines of any sanitary district
21 is necessary or desirable for the public health, safety and welfare of the residents within
22 the revised sanitary districts and the revised sanitary districts are feasible from an
23 engineering and financial standpoint. The resolution is not legally effective until it is
24 approved by the [County] Commissioners of St. Mary's County after public hearing held
25 following not less than ten (10) days' notice in one (1) or more newspapers having a general
26 circulation in St. Mary's County and until a copy of the resolution and plat is recorded
27 among the land records of St. Mary's County. Upon approval by the [County]
28 Commissioners of St. Mary's County and filing of the plat and resolution as provided in this
29 subsection, the revised sanitary districts are designated and constituted for the purpose of
30 this chapter to be separate sanitary districts, and are subject to all the provisions of this
31 chapter. The filing of the plat and resolution constitutes legal notice to the public of the
32 action of the **METROPOLITAN** Commission and the [County] Commissioners **OF ST.**
33 **MARY'S COUNTY.**

34 113-5. New facilities; studies; plans.

35 A. (1) The **METROPOLITAN** Commission shall cause studies, plans and
36 estimates to be made for water supply and sewerage systems in those portions of St. Mary's
37 County in which the **METROPOLITAN** Commission determines that the facilities are

1 necessary and may divide each sanitary district into water and sewerage districts in such
2 a way as shall, in its judgment, best serve the needs of the various communities and shall
3 promote convenience and economy of installation and operation.

4 **(2) (A)** Whenever, and as, the studies and plans are completed, the
5 **METROPOLITAN** Commission shall give notice by publication in one (1) newspaper
6 published within [the] **ST. MARY'S** County for three (3) weeks.

7 **(B)** The **METROPOLITAN** Commission shall state in the notice the
8 probable cost of the contemplated improvements and shall further state in it that plans of
9 the improvements may be inspected at the **METROPOLITAN** Commission's Office and that
10 any person interested in the improvements will be heard by the **METROPOLITAN**
11 Commission at a time to be specified in the notice, but not less than ten (10) days after first
12 publication of it.

13 **(3) (A)** If ten (10) residents and landowners in the sanitary district in
14 which the improvements are contemplated, within ten (10) days after the last of the
15 publications of the notice, file a petition with the **METROPOLITAN** Commission protesting
16 against the proposed improvements, the **METROPOLITAN** Commission shall grant them a
17 hearing within fifteen (15) days after the petition is filed in the office of the
18 **METROPOLITAN** Commission and after not less than five (5) days' notice of the time and
19 place of the hearing by advertisement published in one (1) newspaper published within
20 [the] **ST. MARY'S** County and by personal notices addressed to any one (1) or more persons
21 whose names are signed to the petition.

22 **(B)** After due hearing, the **METROPOLITAN** Commission shall
23 decide upon the reasonableness of the objections stated in the petition and shall dispose of
24 them by written order concurred in by a majority of the [Commissioners] **MEMBERS OF**
25 **THE METROPOLITAN COMMISSION BOARD**. The order shall be published in the same
26 manner as notices are required to be published, and a copy of which shall be mailed to any
27 one (1) or more of the petitioners.

28 **(C)** If the petitioners are not satisfied with the **METROPOLITAN**
29 Commission's decision, they have the right to take and enter, within ten (10) days after the
30 last publication of the order, an appeal to the [County] Commissioners of St. Mary's
31 County, who shall review the **METROPOLITAN** Commission's decision and decide on the
32 necessity and propriety of the improvements contemplated. The decision of the [County]
33 Commissioners **OF ST. MARY'S COUNTY** is final.

34 **B.** For the purpose of providing for the studies, plans, organization and any other
35 expenses or costs of any water or sewerage facilities, the [County] Commissioners **OF ST.**
36 **MARY'S COUNTY** may furnish the **METROPOLITAN** Commission from time to time any
37 sum that the [County] Commissioners **OF ST. MARY'S COUNTY** deem proper, all of which
38 shall be repaid out of the next bond issue, if any. If the [County] Commissioners **OF ST.**
39 **MARY'S COUNTY** do not expect bonds to be issued within two (2) years of the date on which

1 the sum is furnished to the **METROPOLITAN** Commission, the [County] Commissioners
2 **OF ST. MARY'S COUNTY** may waive repayment of the advances. The authority for
3 advances granted by this subsection is in addition to other advances authorized by this
4 chapter.

5 C. (1) For the purposes of carrying out the provisions of subsection A. of this
6 section, after bona fide efforts to notify the owner and occupant, an agent or employee of
7 the **METROPOLITAN** Commission may enter on any private land to make test borings and
8 soil tests and obtain information related to the tests for the purpose of determining soil
9 characteristics and suitability of the surface and subsurface of the land for the installation
10 of public water supply or sewerage systems.

11 (2) If an agent or employee is refused permission to enter or remain on
12 private land for the purposes authorized by subsection C.(1), the **METROPOLITAN**
13 Commission may apply to the St. Mary's County Circuit Court for an order directing that
14 its agent or employee be permitted to enter and remain on the land to the extent necessary
15 to carry out the purposes authorized by this subsection. The court may require that the
16 **METROPOLITAN** Commission post a bond in an amount sufficient to reimburse any person
17 for damages reasonably estimated to be caused by test borings, soil tests and related
18 activities.

19 (3) If any person enters on any private land under the authority of this
20 subsection or of any court order passed pursuant to it and damages or destroys any land or
21 personal property on it, the owner of the property has a cause of action for damages against
22 the **METROPOLITAN** Commission.

23 (4) Any person who knows of an order issued under this subsection and
24 who obstructs any agent or employee acting under the authority of the order may be
25 punished for contempt of court.

26 113-6. Bonds; authorized, restriction, issue.

27 A. (1) For the purpose of providing funds for the design, construction,
28 establishment, purchase or condemnation of water supply and sewerage systems in any of
29 the sanitary districts, the **METROPOLITAN** Commission, upon the approval of the
30 Commissioners of St. Mary's County and in accordance with § 27-11 of the Code of St.
31 Mary's County, Maryland, is authorized and empowered to incur debt, from time to time,
32 upon the full faith and credit of St. Mary's County, in such amounts as it may deem to be
33 necessary to carry on its work, but at no time shall the total debt outstanding for all
34 purposes under this chapter exceed twenty-five (25) percent of the total value of the
35 property assessed for County taxation purposes within all of the sanitary districts in which
36 public water or sewer facilities are located.

37 (2) Subject to the conditions contained herein, the form, tenor, manner and
38 all other matters relating to the incurrence of debt, including but not limited to the issuance

1 of bonds under this chapter, shall be prescribed in a resolution to be adopted by the [St.
2 Mary's County] Metropolitan Commission prior to incurring additional debt.

3 (3) Except as provided in § 27-11 of the Code of St. Mary's County,
4 Maryland, the issuance of bonds may not be subject to any limitations or conditions
5 contained in any other law, and the **METROPOLITAN** Commission may incur debt in such
6 manner and for such price as it may determine to be for the best interests of the
7 **METROPOLITAN** Commission as approved by the Commissioners of St. Mary's County.

8 (4) Any bonds issued shall be serial bonds issued upon the serial maturing
9 plan and in such denominations as shall be determined by the **METROPOLITAN**
10 Commission.

11 (5) (A) Any debt incurred by the **METROPOLITAN** Commission may be
12 prepaid or redeemable before maturity, as permitted by the debt instrument, at the option
13 of the **METROPOLITAN** Commission at such price and under such terms and conditions as
14 may be fixed by the **METROPOLITAN** Commission prior to the incurrence of debt. Any
15 related interest owed shall be at such rate or rates payable not less than semiannually, as
16 shall be determined by a resolution of the [St. Mary's County] Metropolitan Commission
17 adopted prior to the incurrence of debt.

18 (B) All debt incurred by the **METROPOLITAN** Commission shall
19 mature in not more than forty (40) years after date of issue and shall be forever exempt
20 from State, City and County taxation as hereinafter provided.

21 (C) All debt instruments and related documentation to evidence any
22 indebtedness shall be issued under the signature and seal of the **METROPOLITAN**
23 Commission and shall be unconditionally guaranteed as to payment of both principal and
24 interest by the Commissioners of St. Mary's County, a political subdivision of the State of
25 Maryland, which guaranty shall be endorsed on any such debt as may be issued in the
26 following language: "The payment of interest when due and the principal at maturity is
27 guaranteed by the Commissioners of St. Mary's County, Maryland." Such endorsement
28 shall be signed on any bonds issued by the Commissioners of St. Mary's County within ten
29 (10) days after any bonds are presented by the **METROPOLITAN** Commission for such
30 endorsement.

31 B. The principal amount of any **METROPOLITAN** Commission debt as permitted
32 hereunder, the interest payable thereon, and any income derived therefrom, including any
33 profit made by the **METROPOLITAN** Commission in the sale or transfer thereof, shall be
34 and remain exempt from taxation by the State of Maryland and by the several counties and
35 municipal corporations of this State.

36 113-7. Same; levy of taxes; penalty.

1 A. **(1)** For the purpose of retiring the debt authorized by this chapter and
2 paying the interest thereon, the **METROPOLITAN** Commission, by and through the
3 Commissioners of St. Mary's County, shall cause to be levied, against all assessable
4 property within the sanitary districts in which public water or sewer facilities are located,
5 so long as any of the debt is outstanding and not paid, an annual tax sufficient to provide
6 the sum which the **METROPOLITAN** Commission may deem sufficient and necessary, in
7 conjunction with any amounts as the **METROPOLITAN** Commission may estimate that it
8 will be able to collect out of the System Improvement Charges, Capital Contribution
9 Charges, and charges levied by it but not yet paid and any further funds then available for
10 the purpose, to meet the periodic principal and interest payments on the debt as they
11 become due.

12 **(2)** The tax shall be determined, levied, collected and paid over in the
13 manner following, that is to say: the **METROPOLITAN** Commission shall determine the
14 amount which it deems necessary to be raised during the ensuing year for the payment of
15 principal and interest on all outstanding debt, after deducting all amounts in hand, or
16 reasonably expected to be received, applicable to payments of the principal and interest on
17 the debt outstanding; as hereinbefore and hereinafter in the chapter provided, it shall
18 determine the number of cents per one hundred dollars (\$100.00) necessary to raise the
19 amount needed and shall certify same to the Commissioners of St. Mary's County.

20 **(3)** The Commissioners of St. Mary's County in their next annual levy shall
21 levy the tax on all land and improvements and all other property assessed for County tax
22 purposes within the sanitary districts in which public water or sewer facilities are located,
23 which tax shall be levied and collected and have the same priority rights, bear the same
24 interest and penalties and in every respect be treated the same as County taxes. The tax
25 so levied for the ensuing year shall be collected by the tax collecting authorities, and every
26 one hundred twenty (120) days they shall remit the whole amount of the tax so collected to
27 the **METROPOLITAN** Commission.

28 **(4)** From the money so received, together with the amount in hand to the
29 credit of fund or funds for the payment of the principal and interest on the outstanding
30 debt, the **METROPOLITAN** Commission shall first pay all of the principal and interest on
31 the outstanding debt as it becomes due and shall then deposit the residue of the monies in
32 some insured banks or other financial institutions to the joint credit of the Commissioners
33 of St. Mary's County and the **METROPOLITAN** Commission.

34 **(5)** Nothing contained in this section or in this chapter shall be construed
35 as in any manner relieving the Commissioners of St. Mary's County of its unconditional
36 pledge of its full faith and credit and unlimited taxing power to the payment of principal
37 and interest on any outstanding debt of the **METROPOLITAN** Commission pursuant to
38 Section 161 Section 161.

39 B. In each year in which any debt is outstanding and unpaid, the Commissioners
40 of St. Mary's County shall levy and collect a tax upon all property subject to assessment for
41 taxation by St. Mary's County in rate and amount sufficient to provide an amount, if any

1 be necessary, which, together with any other amounts lawfully available and applied for
2 the purpose, shall be sufficient to provide for the payment of the principal and interest on
3 all such outstanding debt when the debt becomes due and payable.

4 C. Penalty. In order that the prompt payment of principal and interest on all
5 outstanding debt shall be assured, the prompt and proper performance of the respective
6 acts and duties heretofore defined is specifically enjoined, and any failure upon the part of
7 any person, persons, body corporate or agent to perform the necessary acts and duties
8 hereafter set forth to pay over the funds as required, or to use the funds for the payment of
9 the principal and interest on the outstanding debt, is hereby declared a misdemeanor and
10 punishable as other misdemeanors are punishable by Section 176.

11 113-8. Bids and contracts.

12 A. Whenever the studies and plans for water supply or sewerage systems for any
13 sanitary district shall have been completed and the **METROPOLITAN** Commission shall
14 have decided, after opportunity for a hearing has been given, to proceed with the
15 construction thereof, it shall advertise, by notice in one (1) newspaper of general circulation
16 published in St. Mary's County or such newspapers or other forms of print or electronic
17 media or press as it may deem proper, for bids for the construction of said system or
18 systems, in part or as a whole, as in its judgment may appear advisable.

19 B. The contract shall be let to the lowest responsible, responsive bidder providing
20 the best value to the **METROPOLITAN** Commission or the **METROPOLITAN** Commission
21 may reject any and all bids, and if, in its discretion, the prices quoted are unreasonable or
22 unbalanced, it may readvertise the work or any part of it, or may do or cause to be done
23 any part or all of the work by the competitive procurement of goods, materials, or services
24 in accordance with a procurement policy as duly adopted and amended from time to time
25 by the **METROPOLITAN** Commission.

26 C. All such contracts shall be protected by such bonds, penalties and conditions
27 as the **METROPOLITAN** Commission may require, all of which shall be enforced in any
28 court having jurisdiction.

29 113-9. Water and sewer connections financing.

30 A. The **METROPOLITAN** Commission may offer connection incentive programs
31 and other financing mechanisms to assist owners of existing residential properties
32 currently served by septic and/or well systems, with all or a portion of the costs of
33 connecting to available public sewer and water systems within planned service areas as
34 designated and defined by the St. Mary's County Comprehensive Water and Sewerage
35 Plan.

36 B. (1) For extensions, expansions and upgrades of water or sewerage systems
37 to existing residential properties **IN ANY OF THE SANITARY DISTRICTS**, the
38 **METROPOLITAN** Commission may, upon a voluntary petition from the property owners to

1 be benefited **AND SUBJECT TO THE APPROVAL OF THE COMMISSIONERS OF ST.**
 2 **MARY'S COUNTY**, approve special benefit assessment charges or service extension fees for
 3 the repayment of costs associated with the:

4 [(i)] **(A)** design,

5 [(ii)] **(B)** permitting,

6 [(iii)] **(C)** land acquisition,

7 [(iv)] **(D)** materials testing,

8 [(v)] **(E)** inspections, or

9 [(vi)] **(F)** construction of such extension, expansion or upgrade[, in
 10 any of the sanitary districts, subject to the approval of the Commissioners of St. Mary's
 11 County].

12 **(2) (A)** In the exercise of the powers granted by this subsection, the
 13 **METROPOLITAN** Commission, by proper procedure, may adopt all necessary rules and
 14 conditions for the acceptance, construction and maintenance of the proposed improvements.

15 **(B)** The procedure shall provide for the method of determination of
 16 the special benefit assessment charges or service extension fees levied against the
 17 properties benefitting from the improvements for the purpose of reimbursing the
 18 **METROPOLITAN** Commission for the costs of the improvements and the time and manner
 19 of payment, but not to exceed twenty (20) years.

20 **(3)** Special benefit assessment charges or service extension fees are a first
 21 lien upon the property against which they are assessed, until paid, subject only to prior
 22 State and county taxes, and if any property is sold for State and county taxes and there
 23 remains a surplus, the **METROPOLITAN** Commission may petition the circuit court to
 24 secure payment of the lien.

25 C. Any financing programs, incentives or mechanisms shall be subject to the
 26 availability of funds and may vary based upon location, financial eligibility or other
 27 qualifying criteria, as established and approved by the **METROPOLITAN** Commission.

28 113-10. Connections required.

29 A. (1) The **METROPOLITAN** Commission may provide, for property abutting
 30 upon a street or right-of-way in which under this chapter a water main or sewer is laid, a
 31 water service pipe or sewer connection. The water service pipe or sewer connection shall be
 32 extended as required, from the water main or sewer to the property line of the abutting lot.

1 (2) The service pipe or connection with sewer shall be constructed by and
2 at the sole expense of the **METROPOLITAN** Commission, but subject to a reasonable charge
3 for the connection as provided in § 113–12 of this chapter. This charge shall be paid by all
4 property owners at the office of the **METROPOLITAN** Commission before the actual
5 connection with any pipe or private property is made or by the property owner under such
6 reasonable conditions and charges as are deemed appropriate by the **METROPOLITAN**
7 Commission. The method of construction and payment shall be determined by the
8 **METROPOLITAN** Commission.

9 (3) When any water main or sewer is declared by the **METROPOLITAN**
10 Commission complete and ready for the delivery of water or the reception of sewage, every
11 abutting property owner for whom a water or sewer connection has been provided may
12 make an application for connection of all spigots or hydrants, toilets and waste drains with
13 the water main or sewer **IN ACCORDANCE WITH THE ST. MARY’S COUNTY**
14 **COMPREHENSIVE WATER AND SEWERAGE PLAN, ST. MARY’S COUNTY**
15 **SUBDIVISION REGULATIONS, AND THE ST. MARY’S COUNTY COMPREHENSIVE**
16 **ZONING ORDINANCE**. Where connections are proposed, those fixtures which do not exist
17 or are of a nature which, in the judgment of the **METROPOLITAN** Commission, is improper
18 or inadequate, satisfactory equipment shall be installed by the owner on the premises. The
19 premises shall include at least one (1) water closet and one (1) sink or washbasin, both of
20 which shall be properly connected with the sewer of the **METROPOLITAN** Commission.
21 Where connections are proposed, all cesspools/septic systems, sink drains and privies
22 located on properties connected to sewers provided by the **METROPOLITAN** Commission
23 shall be abandoned, closed and left in a sanitary condition so that no odor or nuisance shall
24 arise from them.

25 B. If the private water or sewage disposal system of a property abutting upon a
26 street or right-of-way in which a water main or sewer is laid fails to comply with State
27 regulations, as determined by the appropriate federal, State or county regulatory authority,
28 connection to the water main or sewer shall be immediately required, subject to the
29 availability of equivalent dwelling units.

30 113–11. Permits and regulations of use.

31 A. Permits. Before any plumbing, waterworks or sewer construction is done upon
32 any property within any area served by a public water or sewer system in any sanitary
33 district, whether or not owned or operated by the **METROPOLITAN** Commission, the
34 person, firm or corporation doing the construction shall first obtain a permit from the
35 **METROPOLITAN** Commission and pay whatever reasonable sum the **METROPOLITAN**
36 Commission prescribes. The work shall be done under and pursuant to the rules,
37 regulations and requirements, if any, that the **METROPOLITAN** Commission formulates
38 and subject to any inspections which it deems necessary. Connection of any kind may not
39 be made with any public water main or sewer without a permit. Any connection permitted
40 by the **METROPOLITAN** Commission shall be done under conditions that the
41 **METROPOLITAN** Commission authorizes.

1 B. Control of usage. To eliminate leakage, loss of water or improper use of
2 waterlines or sewers the **METROPOLITAN** Commission or its agents or employees may
3 require changes in all plumbing, waterworks or water or sewer connections which it deems
4 necessary. The **METROPOLITAN** Commission shall exercise control of the water supply at
5 all times. In case of a shortage of water or if, for any other reason, the **METROPOLITAN**
6 Commission, in the exercise of its discretion, determines that the water supply should be
7 conserved, the consumers, upon notice from the **METROPOLITAN** Commission, its agents
8 or employees, or upon notice published in one (1) newspaper published in the county for
9 one (1) insertion, shall comply with any order passed by the **METROPOLITAN** Commission
10 to conserve the water supply. Any violation of the order is a misdemeanor punishable under
11 § 113–21 of this chapter. In addition to the penalty prescribed, the **METROPOLITAN**
12 Commission may turn off the water supply of any person violating the order at any time
13 without further notice.

14 C. Private installations. A private or semipublic water supply or sewerage
15 installation, intended for use of two (2) or more buildings or premises, may not be
16 constructed in any sanitary district without the person, firm or corporation doing the work
17 having first obtained a permit from the **METROPOLITAN** Commission and paid a
18 reasonable charge for it. The plant shall then be installed, maintained and operated under
19 rules and regulations, if any, which the **METROPOLITAN** Commission requires or devises.
20 Private systems and additions to existing private systems constructed after May 31, 1976,
21 as a condition of the permit may be required to be dedicated to the **METROPOLITAN**
22 Commission at a time as, in the judgment of the **METROPOLITAN** Commission, public
23 ownership of the systems and the additions is deemed to be in the best interest of the
24 county.

25 D. Hydrants. The **METROPOLITAN** Commission shall have full and complete
26 jurisdiction over all fire hydrants connected with any of its water systems, and a person,
27 firm or corporation may not operate, use or make connection with them without the written
28 authority of the **METROPOLITAN** Commission. These restrictions do not apply to any bona
29 fide fire department in the discharge of its duties. A person, firm or corporation may not
30 tamper with, deface, damage or obstruct any fire hydrant.

31 E. Meters and valves. The **METROPOLITAN** Commission shall have full and
32 complete jurisdiction over all meters and valves connected with any of its systems, and a
33 person, firm, or corporation may not tamper with, attempt to bypass, or modify them
34 without the written authority of the **METROPOLITAN** Commission. A person, firm, or
35 corporation may not deface, damage or obstruct any sewer or water meter.

36 F. **OTHER APPURTENANCES. THE METROPOLITAN COMMISSION SHALL**
37 **HAVE FULL AND COMPLETE JURISDICTION OVER ALL OTHER APPURTENANCES WITH**
38 **ANY OF ITS SYSTEMS, INCLUDING BUT NOT LIMITED TO GRINDER PUMPS, GRAVITY**
39 **SEWERS, FORCE MAINS, MANHOLES, AND CLEANOUTS.**

1 **G.** Penalties. Any violation of any of the provisions of this section is a
2 misdemeanor punishable under Section 176.

3 113–12. Connection charges.

4 A. [(1) In this section, the following words have the meanings indicated:

5 (2) **CAPITAL CONTRIBUTION CHARGE** means an amount based on
6 capital costs that is imposed and collected on a new connection to a water supply or
7 sewerage system under this chapter.

8 (3) **CONNECTION CHARGE** means a Capital Contribution Charge or
9 connection fee.

10 (4) **CONNECTION FEE** means an amount based on the cost of connection
11 that is imposed on a new connection to a water supply or sewerage system under this
12 chapter.

13 (5) **EDU** means an equivalent dwelling unit.

14 (6) **PUBLICATION** means notice to all persons having any interest in the
15 property.

16 **B.]** (1) For every new water or sewer connection made under this chapter, the
17 **METROPOLITAN** Commission may, in its sole discretion, impose and collect a reasonable
18 connection fee, that is not less than the actual cost of connection.

19 (2) The connection fee shall be uniform for connections of those sizes and
20 classes for which average costs reasonably may be ascertainable, and for all other
21 connections, the connection fee shall be an amount not less than the actual cost of the
22 connection.

23 (3) The **METROPOLITAN** Commission may revise the connection fee
24 annually.

25 (4) Connection fees collected by the **METROPOLITAN** Commission shall be
26 applied to paying the actual cost of the connections.

27 (5) The connection fee shall be due and payable to the **METROPOLITAN**
28 Commission at the time the property owner makes an application or is otherwise required
29 to connect to a water main or sewer.

30 (6) If the property owner fails to make the connection by the time required
31 by the **METROPOLITAN** Commission as set forth in section 113–10 of this chapter, the
32 connection fee shall become due and payable on the connection deadline date, shall be

1 assessed immediately, and shall be subject to the rules of collection provided in subsection
2 [D.] C. of this section.

3 [C.] B. (1) In addition to the connection fee, the **METROPOLITAN**
4 Commission shall impose and collect a Capital Contribution Charge for each new
5 connection to a water supply or sewerage system under this chapter.

6 (2) The Capital Contribution Charges collected shall be used by the
7 **METROPOLITAN** Commission to pay:

8 (A) The capital costs of construction of new water supply or sewer
9 collection systems, to the extent that the projects are identified in the **METROPOLITAN**
10 Commission's [six-year capital improvement plan] **5-YEAR CAPITAL IMPROVEMENT**
11 **PLAN AND ANNUAL CAPITAL IMPROVEMENT BUDGET**;

12 (B) The capital cost of central treatment facility capacity expansion,
13 as the projects are identified in the **METROPOLITAN** Commission's [six-year capital
14 improvement plan] **5-YEAR CAPITAL IMPROVEMENT PLAN AND ANNUAL CAPITAL**
15 **IMPROVEMENT BUDGET**;

16 (C) Existing bonds issued as of October 1, 2007, to fund the costs of
17 central treatment facility capacity expansions, but limited to, that portion of existing debt
18 corresponding to any unallocated capacity that exists on October 1, 2007; and

19 (D) Existing bonds issued as of October 1, 2007, to fund the costs of
20 constructing water supply or sewer collection systems, but limited to, that portion of
21 existing debt corresponding to any unallocated capacity that exists on October 1, 2007.

22 (3) (A) The Capital Contribution Charge shall be a uniform charge
23 assessed equally to properties of similar classification throughout all sanitary districts.
24 There shall be a uniform rate applicable to residential properties and a uniform rate
25 applicable to commercial properties. The **METROPOLITAN** Commission may create
26 additional uniform rates for other property classifications that the **METROPOLITAN**
27 Commission considers necessary and appropriate.

28 (B) The **METROPOLITAN** Commission may revise the Capital
29 Contribution Charge annually.

30 (C) The Capital Contribution Charge shall be due and payable in full
31 to the **METROPOLITAN** Commission:

32 (i) At the time a property owner makes an application for
33 connection;

34 (ii) At the time a property is connected to a water main or
35 sewer; or

1 (iii) As of the date the property is sold or transferred if the
2 Capital Contribution Charge is subject to section 113–9 of this chapter.

3 (D) If a Capital Contribution Charge is not paid in full at the time of
4 application for connection and is not subject to section 113–9 of this chapter:

5 (i) The property owner must pay the **METROPOLITAN**
6 Commission an amount equal to not less than 50% of the total Capital Contribution Charge
7 at the time of application for connection; and

8 (ii) The property owner must pay the **METROPOLITAN**
9 Commission the total remaining portion of the Capital Contribution Charge upon
10 connection to a water main or sewer or upon sale or transfer of the property.

11 [(e)] **(E)** If a connection is not made to a water main or sewer within
12 six (6) years of the date of application for connection, the property owners shall pay the
13 **METROPOLITAN** Commission, at the time of connection, an amount equal to the difference
14 between:

15 [(a)] **(I)** the amount which the property owner has paid
16 toward the Capital Contribution Charge and

17 [(b)] **(II)** the Capital Contribution Charge rate in effect at the
18 time of connection.

19 (4) For purposes of determining the Capital Contribution Charge, the
20 capital costs referred to in [paragraphs] **PARAGRAPH (2)(A)** and **(B)** of this subsection shall
21 include the principal of, interest on, and any redemption premium or other costs with
22 respect to any bonds of the **METROPOLITAN** Commission issued after October 1, 2007.

23 (5) (A) When bonds have not been issued at the time the Capital
24 Contribution Charge is calculated, the **METROPOLITAN** Commission may, in calculating
25 the Capital Contribution Charge, establish a schedule for the principal of, interest on, and
26 other costs of bonds the **METROPOLITAN** Commission plans to issue.

27 (B) The schedule and related Capital Contribution Charge provided
28 in subparagraph (A) of this paragraph may be adjusted by the **METROPOLITAN**
29 Commission when planned future bonds are issued.

30 [D.] **C.** (1) The connection charges set forth in subsections [B.] **A.** and [C.]
31 **B.** of this section shall be payable at the Office of the **METROPOLITAN** Commission at a
32 time that is determined by the **METROPOLITAN** Commission.

33 (2) If any connection charges remain unpaid for a period of thirty (30) days
34 after the payment is due, in addition to any other charges, the **METROPOLITAN**

1 Commission may impose a late charge not to exceed one and one-half (11) percent per
2 month until all delinquent charges are paid.

3 (3) If all or any part of a connection charge remains unpaid after thirty (30)
4 days after the due date of payment, the entire unpaid connection charge shall be overdue
5 and in default, at which time the **METROPOLITAN** Commission may proceed to enforce
6 payment.

7 (4) Any statute of limitations to the contrary notwithstanding, and subject
8 only to prior State and County taxes, the connection charge shall be a first lien on the
9 property against which it is assessed until paid.

10 (5) For purposes of collection:

11 (A) The connection charges shall be treated as County taxes and be
12 advertised in the same manner as and with County taxes;

13 (B) **[All] UNLESS THE METROPOLITAN COMMISSION**
14 **COMMENCES A THIRD-PARTY ~~COURT~~ ACTION SEEKING TO RECOVER THE**
15 **CONNECTION CHARGES, ALL** property subject to the connection charges shall be sold for
16 the connection charges at the same time and in the same manner as the properties are sold
17 for County taxes; and

18 (C) Applicable laws relating to the collection of County taxes shall
19 relate to the collection of the connection charges.

20 (6) Property redeemed from a County tax sale and property sold by the
21 **[County] Commissioners OF ST. MARY'S COUNTY** after a final tax sale may not be
22 redeemed or sold until the connection charges due on it are paid.

23 (7) To give notice to the general public of existing liens and charges against
24 any property within any sanitary district abutting on any water or sewer main, the
25 **METROPOLITAN** Commission shall keep a public record of all names of owners of property,
26 locations of the property, lot numbers when of record, and the amount of the connection
27 charges or other charges that may become liens.

28 (8) The records shall be kept in the land records of St. Mary's County, and
29 the Clerk of the Circuit Court for **[the] ST. MARY'S** County shall furnish space necessary
30 to keep and preserve the records, that, when recorded in the public record, are legal notice
31 of all existing liens within any sanitary district.

32 (9) If any liens, connection charges, or other charges remain unpaid for
33 thirty (30) days after becoming overdue, they may be collected by an action to enforce the
34 liens, and any judgment or decree obtained shall have the force and effect of a judgment in
35 personam.

1 (10) The **METROPOLITAN** Commission may file an action to enforce the
2 liens against the owner of record at the time the levy was made, or the owner of record at
3 the time the suit is filed, or any owner of record between these dates.

4 [(11) Notwithstanding any other law, the Commission shall establish a
5 procedure by which the owner of a residential property, that is also the primary residence
6 of the owner subject to the connection charges, may apply for a waiver or an extension of
7 time to pay the charges because of the financial hardship of the owner, including a method
8 by which the owner may appeal the decision of the Commission to the Board of County
9 Commissioners, or an entity designated by the Board of County Commissioners.]

10 113–13. Discontinuance of service.

11 In addition to any other powers and penalties contained in this chapter, the
12 **METROPOLITAN** Commission may discontinue water and sewer service for nonpayment
13 of any service, connection, inspection, benefit or any other charge if not paid within thirty
14 (30) days of the due date. In addition to payment of the bill, the **METROPOLITAN**
15 Commission shall collect a turn-off and turn-on charge before resuming service.

16 113–14. Service rates.

17 A. For the purpose of providing funds for maintaining, repairing and operating
18 its water supply and sewerage systems, for line extensions of them, for its administrative
19 and other expenses, including proper depreciation allowances, if any, and for interest on
20 and the retirement of bonds as specified in this chapter, the **METROPOLITAN** Commission
21 may make service rates, as it deems necessary, on water lines and sewers chargeable
22 against all properties having a connection with any water pipe or sewer pipe under its
23 supervision or ownership. The service rates may include any State or Federally mandated
24 fees or charges. The rate for both water and sewer service shall be uniform throughout a
25 sanitary district, subject to changes that the **METROPOLITAN** Commission considers
26 necessary. Beginning on July 1, 1993, the rate for both water and sewer service shall be
27 uniform throughout all sanitary districts, subject to changes that the **METROPOLITAN**
28 Commission considers necessary. [However, where the Commission provides service to
29 property in an area in which it is economically not feasible to provide service at the uniform
30 rate because of the distance of the area from the principal facilities of the Commission, the
31 Commission may classify the property as a remote area and may impose an additional
32 service charge to meet the additional cost of providing service to the property.] The
33 **METROPOLITAN** Commission may collect a reasonable deposit in advance of furnishing
34 water or sewerage service. The **METROPOLITAN** Commission shall begin the assessment
35 of water and sewer service rates either at the time of the connection of all spigots or
36 hydrants, toilets, and waste drains to a water main or sewer or on the expiration of the
37 deadline for connection as required by the **METROPOLITAN** Commission in accordance
38 with section 113–10 of this article, whichever occurs first.

39 **B. WHERE THE METROPOLITAN COMMISSION PROVIDES SERVICE TO**
40 **PROPERTY IN AN AREA IN WHICH IT IS ECONOMICALLY NOT FEASIBLE TO PROVIDE**

1 SERVICE AT THE UNIFORM RATE BECAUSE OF THE DISTANCE OF THE AREA FROM
2 THE PRINCIPAL FACILITIES OF THE METROPOLITAN COMMISSION, THE
3 METROPOLITAN COMMISSION MAY CLASSIFY THE PROPERTY AS A REMOTE AREA
4 AND MAY IMPOSE AN ADDITIONAL SERVICE CHARGE TO MEET THE ADDITIONAL COST
5 OF PROVIDING SERVICE TO THE PROPERTY.

6 [B.] C. The sewer service rates shall be reasonable and shall be charged to all
7 properties being served in a given sanitary district.

8 [C.] D. WATER SERVICE CHARGES. The water service charge shall consist
9 of:

10 (1) a [minimum or ready-to-serve] ~~READY-TO-SERVE~~ charge, which
11 shall be ~~THE MINIMUM CHARGE ASSESSED FOR WATER SERVICE AND CALCULATED~~
12 based upon the size of the meter on the water connection leading to the property[.]; and
13 [of]

14 (2) a charge for water used, which shall be ~~CALCULATED~~ based upon the
15 amount of water passing through the meter in excess of any water included in the
16 [minimum or ready-to-serve] ~~READY-TO-SERVE~~ charge during the period between the
17 last two (2) readings. The meter shall be placed on water connections as determined by the
18 METROPOLITAN Commission. If the METROPOLITAN Commission at any time
19 determines not to have meters installed in all the properties in a given sanitary district
20 that are connected to the system, then a reasonable flat rate, as determined by the
21 METROPOLITAN Commission, shall be charged to all properties in which meters have not
22 been installed. This rate shall be uniform within a sanitary district.

23 [D. Notwithstanding subsections B and C of this Section, any property owned by
24 either a regularly organized volunteer Fire Department or a volunteer Rescue Squad is
25 exempt from the imposition of a water or sewer service charge while used for public
26 purposes.]

27 E. BILLING. Bills for the amount of the charges shall be sent monthly, quarterly
28 or semiannually, as the METROPOLITAN Commission determines, to the owner of each
29 property served and are then payable at the Office of the METROPOLITAN Commission. If
30 any bill remains unpaid after thirty (30) days from the due date or dates specified in it, the
31 bill is overdue and the METROPOLITAN Commission may begin collection proceedings. At
32 the request of the owner, bills for services may be sent, at the discretion of the
33 METROPOLITAN Commission, to persons or entities other than the owner, provided that
34 the owner states in his request that any bill so mailed will be considered as notice to him
35 as if it were mailed to the owner in accordance with above.

36 F. PAST DUE BILLS. When a bill is overdue and after written notice is left upon
37 the premises or mailed to the last known address of the owner, the METROPOLITAN
38 Commission shall turn off the water or sewer, if possible, from the property in question.

1 The water or sewer service may not be resumed until the bill or bills, and a charge as
2 determined by the **METROPOLITAN** Commission to cover costs incurred to turn off and to
3 turn on the water or sewer service, have been paid.

4 G. If any charges remain unpaid for a period of thirty (30) days after the due date
5 for payment, a late charge at a rate not to exceed one and five-tenths (1 5/10) percent per
6 month may be made by the **METROPOLITAN** Commission until all delinquent charges are
7 paid, the late charge to be in addition to all other charges.

8 H. [(1)] If any bill shall remain unpaid for thirty (30) days after the due date, it
9 shall be collectible from the owner of the property served in the same manner as other debts
10 are collectible in the County. The service charges and all penalties and late charges shall
11 be a first lien against the property, and the same procedures as set forth in section
12 [113-12.D.] **113-12.C.** of this chapter shall be followed by the **METROPOLITAN**
13 Commission in collecting those debts.

14 [(2)] Notwithstanding any other law, the Commission shall establish a
15 procedure by which the owner of a residential property, that is also the primary residence
16 of the owner subject to the connection charges, may apply for a waiver or an extension of
17 time to pay the charges because of the financial hardship of the owner, including a method
18 by which the owner may appeal the decision of the Commission to the Board of County
19 Commissioners, or an entity designated by the Board of County Commissioners.]

20 113-15. Connections with other systems.

21 The **METROPOLITAN** Commission shall have full power and, authority to enter into
22 any contract for the connection of its water supply or sewerage system or any part thereof
23 with any publicly or privately owned system for the purchase or sale of water and for the
24 collection, treatment and disposal of sewerage, and to enter into any other agreement
25 concerning any other matter and on such terms deemed by the **METROPOLITAN**
26 Commission to be necessary, advisable or expedient for the proper construction,
27 maintenance and operation of the water supply or sewerage systems under its control or
28 those under the control of any public or private body.

29 113-16. Other systems; acquisition, general.

30 A. Purchase. Whenever the **METROPOLITAN** Commission considers it advisable
31 and proper for the adequate provision of water or sewer service in any sanitary district to
32 assume ownership of privately owned water or sewerage systems, it may purchase them
33 upon such terms and conditions as may be agreed upon but shall have no right of
34 condemnation with respect thereto, but before any part of the purchase price is paid, other
35 than a nominal sum of money to bind the agreement, it shall be the duty of the vendor or
36 agent to furnish a statement to the **METROPOLITAN** Commission setting forth all names
37 and addresses of persons having any interest or claims against the property whatsoever,
38 which shall be verified by an oath in writing. Thereupon it shall be the duty of the
39 **METROPOLITAN** Commission to notify personally or by registered or certified mail, return

1 receipt requested, all persons having any interest whatsoever in the property, and in
2 addition thereto the **METROPOLITAN** Commission shall give three (3) weeks' notice of its
3 intention to purchase the property in a newspaper or newspapers published within the
4 county in which the property is located, and each person having any claim whatsoever
5 against the property shall file his, her or its claim with the **METROPOLITAN** Commission
6 on or before the expiration date mentioned in the notice, at which time any and all persons
7 will be heard and their rights determined by the **METROPOLITAN** Commission, which
8 hearing shall be final.

9 B. Effect of sale. From and after payment to the proper parties of the agreed
10 purchase price, or other amounts found to be due by the **METROPOLITAN** Commission, the
11 **METROPOLITAN** Commission may take possession of, maintain and operate the system,
12 whether private or municipal, as part of its general system. From the date of the payment,
13 all properties along the line of any water main or sewer of the system as acquired shall
14 stand in the same relation, bear the same System Improvement Charge and be subject to
15 the same regulations and penalties as though the system so acquired had been constructed
16 and put into operation by the **METROPOLITAN** Commission under the provisions of this
17 chapter. However, a building or premises actually connected in an adequate manner with
18 the acquired system at the time of its purchase may not be required to pay any connection
19 charge.

20 C. Unfit systems.

21 (1) Whenever there is in existence a privately owned shared or community
22 water supply or sewerage system which, in the judgment of the appropriate federal, State
23 or local regulatory authority, is unfit, as a whole or in part, the system shall be rehabilitated
24 and brought into compliance with all applicable federal, State and local regulations by the
25 system owner(s) or, if rehabilitation is determined to be unfeasible, a new system may be
26 constructed by the system owner(s) to serve the area previously served by the unfit system,
27 or the system may be abandoned in accordance with all applicable federal, State and local
28 regulations.

29 (2) Should the system owner(s) request that the **METROPOLITAN**
30 Commission take ownership of or controlling authority in the system in accordance with
31 Section 9-1110 of the Environment Article of the Annotated Code of Maryland, the system
32 owner(s) shall present the **METROPOLITAN** Commission with a comprehensive plan of
33 action which provides any items as may be required by the **METROPOLITAN** Commission,
34 the procedures, policies and processes necessary to bring the system into compliance with
35 the St. Mary's County Comprehensive Water and Sewerage Plan, all appropriate federal,
36 State and local laws, rules and regulations, as well as with all **METROPOLITAN**
37 Commission standards, prior to any consideration of the request by the **METROPOLITAN**
38 Commission. The **METROPOLITAN** Commission shall take into consideration whether the
39 action requested is necessary to ensure the health, safety and welfare of the general public,
40 is economically feasible, as well as other criteria as the **METROPOLITAN** Commission may
41 deem necessary.

1 D. Municipal systems. Any municipal corporation whose system is acquired by
2 the **METROPOLITAN** Commission may use the amount paid to it for the system for the
3 purchase or redemption of any bonds or debt which may be outstanding against it, or the
4 **METROPOLITAN** Commission may, as part of the purchase price of the system, assume
5 the payment of any such outstanding bonds.

6 113–17. [Private systems] **PRIVATELY CONSTRUCTED SYSTEMS**; new.

7 A. [After June 1, 1957, whenever] **WHENEVER** the property owners or residents
8 of any locality [in a district] desire a **SHARED OR COMMUNITY** water supply or sewerage
9 system[, or part of them,] to be constructed in that locality and the **METROPOLITAN**
10 Commission decides that it is inexpedient or impracticable at that time, owing to the
11 remoteness of the locality from one of its systems or other causes, to build such system, the
12 owners or residents may build the system at their own expense.

13 B. However, it shall be constructed under plans and specifications approved by
14 the **METROPOLITAN** Commission and under its supervision, and its maintenance and
15 operation shall be under the general control of the **METROPOLITAN** Commission. All cost
16 incurred by the **METROPOLITAN** Commission for the services, i.e., to supervise, maintain
17 or control the construction project, shall be paid for in advance by the property owners or
18 individuals concerned.

19 C. The system, or part of it, the water main, sewer, water purification or
20 sewerage treatment plant and a connection with any of them may not be constructed or
21 installed except as provided in this section.

22 D. Any violation of this provision is a misdemeanor punishable under Section
23 176.

24 E. All construction records, including cost records, shall be filed with the
25 **METROPOLITAN** Commission.

26 113–18. Entry upon roadways.

27 The **METROPOLITAN** Commission may enter upon and excavate any State, County
28 or municipal street, road or alley or any other public highway for the purpose of installing,
29 maintaining and operating the water supply or sewerage systems provided for under this
30 chapter, and it may construct in any such street, road, alley or public highway a water main
31 or sewer, or any appurtenance thereof, without the payment of a charge. However,
32 whenever any State, County or municipal highway is to be disturbed, the public authority
33 having control of it shall be duly notified. The highway shall be repaired and left by the
34 **METROPOLITAN** Commission in the same condition as, or in a condition not inferior to,
35 that existing before the highway was [torn up] **EXCAVATED**. All costs incident thereto shall
36 be borne by the **METROPOLITAN** Commission.

1 113–19. Entry into buildings.

2 A. Any employee or agent of the **METROPOLITAN** Commission shall have the
3 right of entry, at all reasonable hours, upon any private premises and into any building in
4 any sanitary district while in pursuit of his official duties, upon first presenting proper
5 credentials from the **METROPOLITAN** Commission.

6 B. While in pursuit of official duties, any employee or agent of the
7 **METROPOLITAN** Commission shall have a right of entry including reasonable vehicular
8 ingress to and egress from any **METROPOLITAN** Commission pumping station, elevated
9 water storage tank, well, or other related or appurtenant equipment.

10 C. Any restraint or hindrance offered to the entry, access, ingress or egress by
11 any owner or tenant of any affected property, or agent of the owner or tenant, or any other
12 person is a misdemeanor punishable under Section 176.

13 113–20. Obstructions.

14 A. All individuals, firms or corporations having buildings, conduits, pipes, tracks,
15 poles or other structures or obstructions in, on, over, under or through any public road,
16 street or alley of any sanitary district which blocks or impedes the construction and
17 establishment of the **METROPOLITAN** Commission's water supply or sewerage systems or
18 other works shall, upon reasonable notice from the **METROPOLITAN** Commission,
19 promptly so shift, adjust, accommodate or remove the structures or obstructions as to fully
20 meet the exigencies occasioning the action.

21 B. The costs of such changes shall be borne and paid for by the **METROPOLITAN**
22 Commission.

23 C. Every public service corporation, company or individual, before it or they shall
24 begin any excavation or construction in any street, road, alley or public highway within any
25 sanitary district, shall file with the **METROPOLITAN** Commission plans of such work and
26 construction showing the location and depth in such street, road, alley or public highway of
27 the proposed main, conduit, pole, pipe or other structure, and the construction or work may
28 not be begun until the plans have been approved by the **METROPOLITAN** Commission, nor
29 shall any change be made in the approved plans or in the work or construction as shown
30 upon the plans except on further approval of the **METROPOLITAN** Commission.

31 D. Whenever any main, conduit, pole, pipe or other structure is put in without
32 the filing of plans with the **METROPOLITAN** Commission and the approval thereof by it,
33 or when any change is made in the location of such main, conduit, pipe, pole or other
34 structure as shown upon the plans approved by the **METROPOLITAN** Commission, or any
35 approved change therein, the **METROPOLITAN** Commission, if and when such conduit,
36 main, pipe or pole, or other structure interferes with the construction of or operation of its
37 water or sewerage system or other works, may remove such conduit, main, pipe, pole or
38 other structures or change the location thereof at the cost and expense of the party so

1 putting them in, or their heirs, assigns or successors, and without any liability upon the
 2 part of the **METROPOLITAN** Commission for damage that might be done to same by reason
 3 of the **METROPOLITAN** Commission's operations in constructing or maintaining its
 4 systems or works.

5 **E.** Any violation of the provisions of this section is a misdemeanor punishable
 6 under Section 176.

7 113–21. Penalties.

8 **A.** Unless otherwise provided, any act or omission designated as a misdemeanor
 9 in the chapter is punishable by a fine of not more than one hundred dollars (\$100.00) or
 10 [to] confinement for not more than thirty (30) days in the county jail, or both. Where this
 11 act or omission is of a continuing nature and persists in violation of the provisions of this
 12 chapter or of any rule or regulation promulgated under this chapter, a conviction for one
 13 (1) offense is not a bar to a conviction for a continuation of the offense subsequent to the
 14 first or any succeeding conviction.

15 **B.** Civil infractions.

16 (1) The [St. Mary's County] Metropolitan Commission may designate any
 17 violation of this chapter as a civil infraction, which shall be enforced as provided in this
 18 subsection.

19 (2) A Metropolitan Commission employee with the duty of enforcing this
 20 chapter may deliver a citation to a person believed to be committing a violation. A copy of
 21 the citation shall be retained by the Metropolitan Commission employee and shall bear a
 22 certification attesting to the truth of the matters set forth. The citation shall contain:

23 [(a)] **(A)** The name and address of the person charged;

24 [(b)] **(B)** The nature of the violation;

25 [(c)] **(C)** The place and time of the violation;

26 [(d)] **(D)** The amount of the fine assessed;

27 [(e)] **(E)** The manner, location, and time in which the fine may be
 28 paid; and

29 [(f)] **(F)** The person's right to elect to stand trial for the violation.

30 (3) Except as provided in paragraph (4) of this subsection, a preset fine, not
 31 to exceed one hundred dollars (\$100.00), may be imposed for each violation. The
 32 Metropolitan Commission may establish a schedule of fines for each violation and may
 33 adopt procedures for collection of these fines.

1 (4) **[(a)] (A)** A person may not remove water from a public system
2 under the jurisdiction of the Metropolitan Commission without the prior authorization of
3 the Metropolitan Commission.

4 **[(b)] (B)** The Metropolitan Commission may impose a fine not
5 exceeding one thousand dollars (\$1,000.00) for each violation of this paragraph.

6 **[(c)] (C)** The Metropolitan Commission may establish a schedule of
7 fines for each violation of this paragraph based on the amount of water removed and the
8 number of prior violations by a person.

9 (5) A person who receives a citation may elect to stand trial for the offense
10 by filing with the Metropolitan Commission a notice of intention to stand trial. The notice
11 shall be given at least five (5) days before the date of payment as set forth in the citation.
12 On receipt of the notice of intention to stand trial, the **METROPOLITAN** Commission shall

14 to stand trial. On receipt of the citation, the district court shall schedule the case for trial
15 and notify the defendant of the trial date. All fines, penalties, or forfeitures collected by the
16 district court for violation shall be remitted to **[St. Mary's County] THE** Metropolitan
17 Commission.

18 C. Administrative enforcement remedies; judicial enforcement remedies.

19 (1) The **[St. Mary's County]** Metropolitan Commission may utilize
20 administrative enforcement remedies or seek judicial enforcement remedies for a violation
21 of any rules and regulations the **METROPOLITAN** Commission may adopt under this
22 chapter concerning public sewer use, including public sewer drains, the installation of
23 building sewer connections, and the discharge of waters and wastes into the public sewer
24 systems. The **METROPOLITAN** Commission shall establish procedures for implementing
25 the enforcement remedies authorized under this subsection.

26 (2) The **METROPOLITAN** Commission may utilize administrative
27 enforcement remedies that may include:

28 **[(a)] (A)** A notification of a violation;

29 **[(b)] (B)** A consent order;

30 **[(c)] (C)** A show cause hearing;

31 **[(d)] (D)** A compliance order;

32 **[(e)] (E)** A cease and desist order;

1 ~~[(f)]~~ **(F)** An administrative fine not to exceed one thousand dollars
2 (\$1,000.00) per violation, per day; ~~[or]~~

3 **(G)** AN ASSESSMENT FOR THE REIMBURSEMENT OF ACTUAL
4 COSTS INCURRED BY THE METROPOLITAN COMMISSION, INCLUDING BUT NOT
5 LIMITED TO TIME AND MATERIALS, IF SUCH COSTS ARE LESS THAN ONE THOUSAND
6 DOLLARS (\$1,000.00); OR

7 ~~[(g)]~~ **(H)** An emergency suspension.

8 (3) The METROPOLITAN Commission may seek the following judicial
9 enforcement remedies:

10 ~~[(a)]~~ **(A)** Petitioning the District Court of St. Mary's County for
11 injunctive relief;

12 ~~[(b)]~~ **(B)** For a conviction of a violation, requesting civil penalties
13 up to one thousand dollars (\$1,000.00) per violation, per day; or

14 ~~[(c)]~~ **(C)** For a conviction of a violation, requesting criminal
15 penalties of not more than one thousand dollars (\$1,000.00) per violation, or imprisonment
16 for not more than one (1) year per violation, or both.

17 113–22. ~~[Church property]~~ **EXEMPTIONS AND WAIVERS.**

18 **A.** NOTWITHSTANDING ANY OTHER LAW, THE METROPOLITAN
19 COMMISSION SHALL ESTABLISH A PROCEDURE BY WHICH THE OWNER OF A
20 RESIDENTIAL PROPERTY THAT IS ALSO THE PRINCIPAL RESIDENCE OF THE OWNER,
21 SUBJECT TO THE CONNECTION CHARGES, MAY APPLY FOR A WAIVER OR AN
22 EXTENSION OF TIME TO PAY THE CHARGES BECAUSE OF THE FINANCIAL HARDSHIP
23 OF THE OWNER, INCLUDING A METHOD BY WHICH THE OWNER MAY APPEAL THE
24 DECISION OF THE METROPOLITAN COMMISSION TO THE COMMISSIONERS OF ST.

3 D. PUBLIC PARKS OR PLAYGROUNDS OWNED BY A MUNICIPAL

5 ORGANIZED VOLUNTEER FIRE DEPARTMENT OR A VOLUNTEER RESCUE SQUAD ARE
6 EXEMPT FROM THE IMPOSITION OF A SYSTEM IMPROVEMENT CHARGE WHILE USED
7 FOR PUBLIC PURPOSES.

8 113-23. Rules and regulations.

9 The **METROPOLITAN** Commission may prescribe all needful rules, regulations and
10 specifications for the administration and enforcement of this chapter.

11 113-24. Inconsistent laws.

12 All Acts and parts of Acts inconsistent with the provisions of this chapter are hereby
13 repealed to the extent of their inconsistency, provided that nothing herein contained shall
14 be taken as restricting any control which the [State] **MARYLAND** Department of Health
15 [and Mental Hygiene] and the [State Water Resources Administration] **MARYLAND**
16 **DEPARTMENT OF THE ENVIRONMENT** are empowered to exercise within any sanitary
17 districts.

18 113-25. Condemnation of municipal facilities.

19 This chapter may not be construed or interpreted to authorize the **METROPOLITAN**
20 Commission to acquire by condemnation any municipally owned or operated water or
21 sewage treatment facilities.

22 113-26. Reimbursable work.

23 For any services rendered or work to be provided by the **METROPOLITAN**
24 Commission or the **METROPOLITAN** Commission's consultants or contractors at the
25 request of the Commissioners of St. Mary's County which would not be provided by the
26 **METROPOLITAN** Commission in the **METROPOLITAN** Commission's ordinary course of
27 business, the **METROPOLITAN** Commission and the Commissioners of St. Mary's County
28 shall, in advance of the services or work being provided, enter into a written agreement for
29 the scope of services or work to be provided and the cost for such work or services. Upon
30 completion of the work or services, or intermittently during the work or services, as
31 mutually agreed, the **METROPOLITAN** Commission shall request reimbursement from the
32 Commissioners of St. Mary's County for the cost of the work or services provided and the
33 Commissioners of St. Mary's County shall pay such costs as agreed.

34 113-27. Construction.

1 A. Liberal construction. This chapter constitutes full and complete authority,
2 without regard to the provisions of any law, for the doing of the acts and things authorized
3 in this chapter, and it shall be liberally construed to effect the purposes of it. However,
4 nothing contained in this chapter shall be taken as restricting any control which the [State]
5 **MARYLAND** Department of Health [and Mental Hygiene] or the [State Water Resources
6 Administration] **MARYLAND DEPARTMENT OF THE ENVIRONMENT** is empowered to
7 exercise over or within St. Mary's County or any sanitary district.

8 B. Validation of prior proceedings. Nothing contained in any amendment to this
9 chapter effective June 1, 1976, shall be construed as impairing the validity of any
10 proceedings or action taken under the provisions of this chapter prior to that date. All such
11 proceedings taken under this chapter, including, without limitation, the creation and
12 enlargement of any sanitary districts and the establishment and imposition of System
13 Improvement Charges and charges (whether pursuant to this chapter alone or pursuant to
14 Article 43 of the Annotated Code of Maryland as authorized by § 427A of Article 43) are
15 ratified, validated and confirmed. The authorization, sale and issuance of all bonds and
16 bond anticipation notes issued prior to that date by the [St. Mary's County] Metropolitan
17 Commission are ratified and confirmed, and all such bonds and bond anticipation notes are
18 validated as being validly authorized, sold and issued.

19 C. Validation of assessments and other charges. The determination and
20 imposition of System Improvement Charges and other charges by the [St. Mary's County]
21 Metropolitan Commission since its creation are expressly ratified, validated and confirmed,
22 including, without limitation, those schedules of System Improvement Charges and
23 charges determined, imposed and placed in effect on the following dates:

24 (1) Mattapany Sanitary District: January 9, 1969; October 1, 1970; July 1,
25 1971.

26 (2) Pine Hill Run Sanitary District No. 8: October 1, 1973; July 1, 1975.

27 (3) Leonardtwn Sanitary District No. 3: July 1, 1975.

28 (4) Indian Creek Sanitary District No. 10: July 1, 1975.

29 (5) Luckland Run Sanitary District No. 1: January 1, 1976.

30 D. Transition. In the event that the [St. Mary's County] Metropolitan
31 Commission has decided to exercise powers granted by § 9-727 of the
32 [Health-Environmental] **ENVIRONMENT** Article of the Annotated Code of Maryland, the
33 **METROPOLITAN** Commission may, nevertheless, exercise any and all powers granted by
34 this chapter on and after June 1, 1976, without any further action on the part of the
35 **METROPOLITAN** Commission, except those actions required by this chapter. In the event
36 that the **METROPOLITAN** Commission decides that any modification of an existing rate,
37 charge or assessment previously established by it is necessary or desirable or that the
38 creation of a new rate, charge or assessment is necessary or desirable, the

1 **METROPOLITAN** Commission shall promptly give notice of the proposed rates, charges
2 and assessments in at least one (1) newspaper of general circulation in St. Mary's County.
3 The **METROPOLITAN** Commission shall thereafter conduct a public hearing on the
4 necessity or advisability of the proposed rates, charges or assessments. If the
5 **METROPOLITAN** Commission acquires an existing water or sewer system, either public or
6 private, the rates, charges or assessments to be imposed by the **METROPOLITAN**
7 Commission on the persons served by the acquired system shall be treated as the
8 establishment of a rate, charge or assessment within the meaning of this section.

9 113-28. Severability.

10 The provisions of this chapter are severable, and it is the intention to confer the
11 whole or any part of the powers herein provided for, and if any of the provisions of this
12 chapter shall be held unconstitutional by any court of competent jurisdiction, the decision
13 of such court shall not affect or impair any of the remaining provisions of this chapter. It is
14 hereby declared to be the legislative intent that this chapter would have been adopted had
15 such unconstitutional provision not been included therein.

16 113-29. **[] System Improvement Charges. []**

17 A. **[(1)** In this section, the following words have the meanings indicated:

18 (2) EDU means an equivalent dwelling unit.

19 (3) PUBLICATION means notice to all persons having any interest in the
20 property.

21 **B.]** (1) For every property, whether improved or unimproved, to which an EDU
22 has been allocated for public water or sewer service by the St. Mary's County Office of Land
23 Use and Growth Management, the **METROPOLITAN** Commission shall impose and collect
24 on a per EDU basis, a System Improvement Charge.

25 (2) System Improvement Charges shall:

26 (A) Be assessed and payable on a monthly basis; and

27 (B) Be uniform and apply to every EDU equally.

28 (3) System Improvement Charges shall be used by the **METROPOLITAN**
29 Commission to pay the costs associated with:

30 (A) The capital costs of central treatment facility performance
31 upgrades, if the projects are identified in the **METROPOLITAN** Commission's [six-year
32 capital improvement plan] **5-YEAR CAPITAL IMPROVEMENT PLAN AND ANNUAL**
33 **CAPITAL IMPROVEMENT BUDGET**;

1 (B) The capital costs of the repair and replacement of existing water
2 supply and/or sewer collection systems, if the projects are identified in the
3 **METROPOLITAN** Commission's [six-year capital improvement plan] **5-YEAR CAPITAL**
4 **IMPROVEMENT PLAN AND ANNUAL CAPITAL IMPROVEMENT BUDGET**; and

5 (C) That portion of existing bonds, as of October 1, 2007, that was
6 issued to fund the costs of repair, replacement and, where appropriate, construction of
7 existing water supply or sewer collection systems and bonds issued to fund the costs of
8 capital treatment facility capacity allocated to existing system users as of October 1, 2007.

9 (4) In determining the System Improvement Charge, the capital costs
10 referred to in subsection [B.(3)] **A.(3)** of this section shall include the principal of, interest
11 on, and any redemption premium or other costs with respect to any bonds of the
12 **METROPOLITAN** Commission issued after October 1, 2007.

13 (5) (A) When bonds have not been issued at the time the System
14 Improvement Charge is calculated, in calculating the System Improvement Charge, the
15 **METROPOLITAN** Commission may establish a schedule for the principal of, interest on,
16 and other costs of bonds the **METROPOLITAN** Commission plans to issue in accordance
17 with paragraph (3) of subsection [H.] **G.** of this section.

18 (B) The **METROPOLITAN** Commission may adjust the schedule and
19 related System Improvement Charge provided in subparagraph (A) of this paragraph when
20 planned future bonds are issued.

21 **[C.] B.** (1) When collected, the System Improvement Charges shall be
22 placed, by the **METROPOLITAN** Commission, into an interest-bearing account containing
23 all of the System Improvement Charges collected, notwithstanding the sanitary district
24 from which the Charge was collected.

25 (2) The System Improvement Charges, together with any interest accrued
26 on the charges, shall remain in the general account, to be assessed and used by the
27 **METROPOLITAN** Commission on an as-needed basis to fund the costs of any extensive

29 **A.** of this section, in any sanitary district within which a system repair or replacement may
30 be needed.

31 **[D.] C.** (1) When the **METROPOLITAN** Commission determines the

10 (4) The **METROPOLITAN** Commission shall notify, in writing, all owners
11 of the properties as to:

12 (A) Under which class their respective properties fall;

13 (B) The amount of the System Improvement Charge imposed on the
14 property; and

15 (C) A time and place for a public hearing on the classification.

16 (5) The notice shall:

17 (A) Be mailed to the last known address of the owner;

18 (B) Be served in person on any adult occupying the premises; or

19 (C) In the case of vacant or unimproved property be posted on the
20 premises.

21 (6) The classification of any property made by the **METROPOLITAN**
22 Commission is final, and may only be changed:

23 (A) At the public hearing held in accordance with this subsection; or

24 (B) If the use of the property changes.

25 (7) The System Improvement Charge shall be imposed for both water
26 supply and sewerage facilities, whether constructed, purchased, established or otherwise
27 acquired, and shall be assessed as a uniform per EDU charge for each class of property.

1 **[E.] D.** (1) Whenever, through error, inadvertence or oversight or by reason
 2 of any judgment or decree, any property subject to a System Improvement Charge under
 3 this chapter has not had the System Improvement Charge imposed against it, or where it
 4 has been imposed by an erroneous description or in the wrong name, or where service on
 5 the owner has not been had, or where it has been set aside by judgment or decree, the
 6 **METROPOLITAN** Commission, on the discovery of the error, inadvertence or oversight, or
 7 within a reasonable time after the rendition of the judgment or decree, the
 8 **METROPOLITAN** Commission[,] may impose and collect the System Improvement Charge
 9 at the uniform rate and in the applicable property classification.

10 (2) The subsection applies to all errors, omissions, or mistakes made
 11 previously by the **METROPOLITAN** Commission or to any judgment or decree rendered
 12 previously.

13 (3) Appropriate adjustments for any payments shall be made in respect to
 14 that property.

15 **[F.] E.** (1) When there is more than one (1) contiguous lot in the same block
 16 under one (1) ownership appurtenant to a single residence, the **METROPOLITAN**
 17 Commission shall impose the System Improvement Charge based on the number of EDUs
 18 assigned to each property in accordance with all applicable zoning and land use regulations.

19 (2) (A) Land classified as agricultural by the **METROPOLITAN**
 20 Commission, when in actual use for farming or trucking purposes, may not be subject to
 21 the System Improvement Charge when the agricultural land has constructed through it or
 22 in front of it a sewer or water main, if a water or sewer connection is not made.

23 (B) When a water or sewer connection is made and is for every EDU
 24 connected the land shall become subjected to the System Improvement Charge.

25 ~~(3) Public parks or playgrounds owned by a municipal corporation and any~~

 33 of Health [and Mental Hygiene], or if following construction of the **METROPOLITAN**

6 water supply and sewer construction and acquisition shall be uniform for each EDU within
7 each class of property throughout the County for any one (1) year.

8 (2) The **METROPOLITAN** Commission shall determine the amount of the
9 System Improvement Charge per EDU within each class of property for both water and
10 sewer service as costs and conditions require, but a System Improvement Charge for any
11 class of property for any given year once levied by the **METROPOLITAN** Commission may
12 not be increased.

13 **[H.] G.** (1) The rate of the System Improvement Charge shall be based on
14 the **METROPOLITAN** Commission's [six-year capital improvement plan, as revised
15 annually] **5-YEAR CAPITAL IMPROVEMENT PLAN AND ANNUAL CAPITAL**
16 **IMPROVEMENT BUDGET.**

17 (2) The [capital improvement plan] **CAPITAL IMPROVEMENT PLAN** shall
18 identify those capital projects which will be undertaken by the **METROPOLITAN**
19 Commission during the most immediate [six-year] **FIVE-YEAR** period, including any
20 comprehensive improvement or replacement of existing water or wastewater systems and
21 central treatment and processing facility expansions and upgrades.

22 (3) To calculate the System Improvement Charge, the total of all debt
23 service on bonds and the total of amortized costs of all projects in the [capital improvement
24 budget] **CAPITAL IMPROVEMENT BUDGET** for the given year, both totals excluding any
25 costs included in the [capital improvement charge] **CAPITAL IMPROVEMENT CHARGE**

7 (II) Has an ownership interest in the dwelling, including a life

11 (I) For more than six (6) months of a consecutive 12-month
12 period that includes the date of application for a deferral of a System Improvement Charge;

16 due to illness or the need of special care, if the homeowner is otherwise qualified under the
17 provisions of this subsection.]

18 [(2)] (1) The METROPOLITAN Commission may establish financial
19 criteria to determine the eligibility of a [homeowner] HOMEOWNER whose [dwelling]
20 DWELLING is subject to a System Improvement Charge under this section for a deferral of
21 the monthly payment of that charge.

22 [(3)] (2) The METROPOLITAN Commission may defer the monthly
23 payment of a System Improvement Charge on the [dwelling] DWELLING of a [homeowner]
24 HOMEOWNER who:

25 (A) Files an application with the METROPOLITAN Commission; and

26 (B) Meets the financial eligibility criteria that the METROPOLITAN
27 Commission establishes.

28 [(4)] (3) A [homeowner] HOMEOWNER who applies for a deferral of
29 payment of a monthly System Improvement Charge levied on a [dwelling] DWELLING
30 shall submit to the METROPOLITAN Commission an application of the form that the
31 METROPOLITAN Commission provides.

32 [(5)] (4) A [homeowner] HOMEOWNER may apply for deferral on only
33 one (1) [dwelling] DWELLING.

1 [(6) (5)] A [homeowner] **HOMEOWNER** who applies for deferral of
2 payment of a System Improvement Charge shall apply at the time of payment of monthly

4 [(7) (6)] Subject to paragraph [(3) (2)] of this subsection, the
5 **METROPOLITAN** Commission shall terminate the deferral of payment of a monthly
6 System Improvement Charge if a [homeowner] **HOMEOWNER** dies, sells, or alienates the

8 [(8) (7)] The **METROPOLITAN** Commission may defer the monthly

11 [homeowner] **HOMEOWNER** if the succeeding spouse qualifies under the provisions of

13 [(9) (8)] When the **METROPOLITAN** Commission terminates the deferral
14 of payment of a monthly System Improvement Charge under the provisions of paragraph
15 [(7) (6)] of this subsection:

16 (A) All deferred charges, with interest calculated on the cumulative
17 annual payments for the deferral period, shall become due and payable immediately; and

18 (B) The annual levy of System Improvement Charges shall resume.

19 [(10) (9)] (A) A deferred System Improvement Charge that is due and
20 payable on termination of a deferral by the **METROPOLITAN** Commission is a lien against

22 (B) After the **METROPOLITAN** Commission terminates the deferral
23 of payment of a System Improvement Charge under paragraph [(7) (6)] of this subsection,

26 and in default from a [homeowner] **HOMEOWNER** in accordance with subsection [L.] **K.** of

28 [(11) (10)] The **METROPOLITAN** Commission may require a [homeowner]
29 **HOMEOWNER** who qualifies for deferral under this section to requalify at times and under
30 circumstances that the **METROPOLITAN** Commission determines are reasonable and
31 necessary.

32 [(12) (11)] (A) The **METROPOLITAN** Commission may only implement
33 the provisions of this subsection by adoption of a resolution of the **METROPOLITAN**
34 Commission.

1 (B) The **METROPOLITAN** Commission shall hold a public hearing at
2 least ten (10) days prior to any action on the proposed resolution under this paragraph.

3 (C) The **METROPOLITAN** Commission shall publish notice of the
4 public hearing, together with a synopsis of the proposed resolution, in at least one (1)
5 newspaper of general circulation in St. Mary's County once each week for two (2) successive
6 weeks prior to the public hearing.

7 [J.] I. (1) On the allocation of an EDU, the **METROPOLITAN** Commission may
8 permit a connection with a water main or sewer by a property owner whose property does
9 not abut on the water main or sewer and who has not previously paid a System
10 Improvement Charge for the construction of the water main or sewer.

11 (2) If the **METROPOLITAN** Commission permits a connection with a water
12 main or sewer under this subsection, the **METROPOLITAN** Commission shall classify the
13 property and determine the System Improvement Charge to be paid by the property owner.

14 (3) If a connection is made under this subsection, the property owner and
15 property, for all charges, rates and benefits, shall stand in every respect in the same
16 position as if the property abutted on a water main or sewer.

17 [K.] J. (1) When an applicant applies for water or sewer lines in an area in
18 which the **METROPOLITAN** Commission determines that it is economically not feasible to
19 serve unless the applicant makes a substantial contribution to the cost of construction of
20 the water and sewer lines, including the cost of connecting them with the **METROPOLITAN**
21 Commission's system, the **METROPOLITAN** Commission may classify the applicant's
22 property, together with other adjacent or adjoining properties that could be readily served
23 from the construction required by the applicant, as a "remote area."

24 (2) If the **METROPOLITAN** Commission approves an application for water
25 and sewer lines and the applicant makes a contribution to the cost of construction in
26 accordance with this subsection, the **METROPOLITAN** Commission may construct the
27 water or sewer lines required by the applicant.

28 (3) If the **METROPOLITAN** Commission constructs the water or sewer
29 lines, it shall impose a System Improvement Charge in accordance with this section.

30 [L.] K. When the **METROPOLITAN** Commission improves a water system or
31 sanitary sewerage system by replacing, augmenting, upgrading, or expanding it in order to
32 provide increased or improved water or sewer service and the necessity for the
33 improvement arises from changes, whether individually or cumulatively, in use of the
34 property, those properties shall derive a benefit from the improved facility and the
35 **METROPOLITAN** Commission may impose an additional System Improvement Charge on
36 each benefited property for the construction as part of the water or sewer system services.

1 [M.] L. (1) The System Improvement Charge shall be payable at the Office
2 of the **METROPOLITAN** Commission at a time that the **METROPOLITAN** Commission
3 determines.

4 (2) If any charges remain unpaid for a period of thirty (30) days after the
5 payment is due, in addition to any other charges, the **METROPOLITAN** Commission may
6 impose a late charge not to exceed one and one-half (11) percent per month until all
7 delinquent charges are paid.

8 (3) The entire unpaid System Improvement Charge shall be overdue and
9 in default after thirty (30) days after the payment is due for all or any part of the System
10 Improvement Charge required by the **METROPOLITAN** Commission, at which time the
11 **METROPOLITAN** Commission may proceed to enforce payment.

12 (4) Any statute of limitations to the contrary notwithstanding and subject
13 only to prior State and County taxes, the System Improvement Charge shall be a first lien
14 on the property against which it is assessed until paid.

15 (5) For purposes of collection:

16 (A) The System Improvement Charge shall be treated as County
17 taxes and be advertised in the same manner as and with County taxes;

18 (B) All property subject to the System Improvement Charges shall
19 be sold for System Improvement Charges at the same time and in the same manner as the
20 properties are sold for County taxes; and

21 (C) Applicable laws relating to the collection of County taxes shall
22 relate to the collection of the System Improvement Charges.

23 (6) Property redeemed from a County tax sale and property sold by the
24 **[County] Commissioners OF ST. MARY'S COUNTY** after a final tax sale may not be
25 redeemed or sold until the System Improvement Charges are paid.

26 (7) To give notice to the general public of existing liens and charges against
27 any property within any sanitary district abutting on any water or sewer main, the
28 **METROPOLITAN** Commission shall keep a public record of all names of owners or property,
29 locations of the property, lot numbers when of record, and the amount of the System
30 Improvement Charges, water service charges, or **[[charges]] OTHER CHARGES** that may
31 become liens.

32 (8) If any liens, System Improvement Charges or other charges remain
33 unpaid for thirty (30) days after becoming overdue, they may be collected by an action to
34 enforce the liens, and any judgment or decree obtained shall have the force and effect of a
35 judgment in personam.

1 (9) The **METROPOLITAN** Commission may file an action to enforce the
2 liens against the owner of record at the time the levy was made, or the owner of record at
3 the time the suit is filed, or any owner of record between these dates.

4 (10) Notwithstanding any other law, the **METROPOLITAN** Commission
5 shall establish a procedure by which the owner of a residential property, that is also the
6 [primary] **PRINCIPAL** residence of the owner subject to the connection charges, may apply
7 for a waiver or an extension of time to pay the charges because of the financial hardship of
8 the owner, including a method by which the owner may appeal the decision of the
9 **METROPOLITAN** Commission to the [Board of County] Commissioners **OF ST. MARY'S**
10 **COUNTY[,]** or an entity designated by the [Board of County] Commissioners **OF ST.**
11 **MARY'S COUNTY.**

12 [N.] **M.** (1) All System Improvement Charges collected by the
13 **METROPOLITAN** Commission shall be set aside in a separate fund [to be known and
14 designated as the "Metropolitan District Account."] **OR FUNDS.**

15 (2) In order to determine the amount which it considers necessary to be
16 imposed under section 113-7 of this chapter, the **METROPOLITAN** Commission shall
17 deduct the amount it estimates that it will be able to collect from the System Improvement
18 Charges and other charges previously imposed by it, but not yet paid and to be set aside for
19 the interest and principal payments and the amount of funds then available for the purpose
20 of paying the principal of and interest on outstanding bonds, from the whole amount
21 necessary to be raised in any one (1) year for interest and principal payments on
22 outstanding bonds.

23 (3) The balance then remaining to be raised shall be the amount to be
24 certified to the [County] Commissioners of St. Mary's County for collection by taxation as
25 provided by section 113-7 of this chapter.

26 [O.] **N.** (1) If the State, County, or any municipal corporation, commission,
27 board, or agency of the State or County acquires for public use property that is subject to a
28 System Improvement Charge levied by the [St. Mary's] Metropolitan Commission, the
29 System Improvement Charge shall continue to be paid in perpetuity.

30 (2) If any property subject to a System Improvement Charge is acquired as
31 provided in this section without eminent domain proceedings, the System Improvement
32 Charge shall continue to be paid in perpetuity.

33 (3) If any property subject to a System Improvement Charge is acquired
34 through eminent domain proceedings, the **METROPOLITAN** Commission shall be named a
35 party to the proceeding, if necessary, and the final order shall require that the System
36 Improvement Charge be paid concurrent through the date of conveyance and shall require
37 the continued payment of the System Improvement Charge in perpetuity.

(4) If, by oversight or mistake, the **METROPOLITAN** Commission is not named a party to the eminent domain proceedings, the condemning authority shall pay to the **METROPOLITAN** Commission the amount required to pay the System Improvement Charge through the date of conveyance at the same time the condemning authority pays the amount awarded to the property owner in the proceedings.

113-30. **[[]Additional requirements of METROPOLITAN Commission.[]]**

Notwithstanding any provision of this chapter:

A. The **METROPOLITAN** Commission shall adopt or approve, with the prior approval of the **[County]** Commissioners **OF ST. MARY'S COUNTY**, facilities plans, a 5-year Capital Improvement Plan, and an annual Capital **IMPROVEMENT** Budget; and

B. Upon adoption by the **METROPOLITAN** Commission, **REVIEW BY THE ST. MARY'S COUNTY PLANNING COMMISSION AND WITH PRIOR APPROVAL OF THE COMMISSIONERS OF ST. MARY'S COUNTY**, the 5-year Capital Improvement Plan **AND ANNUAL CAPITAL IMPROVEMENT BUDGET** shall be **[deemed approved by the Commissioners of St. Mary's County and]** incorporated into the St. Mary's County Comprehensive Water and Sewerage Plan. The incorporation shall constitute an amendment of the St. Mary's County Comprehensive Water and Sewerage Plan by operation of law and shall be submitted to the Department of the Environment. Section 9-503 of the Environment Article of the Annotated Code of Maryland shall not apply to the amendment by incorporation.
