A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City – Alcoholic Beverages – Class B–D–7 License**

3 FOR the purpose of clarifying certain provisions on the hours of sale, in Baltimore City, for
4 Class B–D–7 beer, wine, and liquor license holders within a certain geographic area;
5 making conforming changes; and generally relating to alcoholic beverages in
6 Baltimore City.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages**

20 12–102.

21 This title applies only in Baltimore City.

22 12–905.

23 (a) There is a Class B–D–7 beer, wine, and liquor license.

1 (d) [(1) Except as provided in paragraph (2) of this subsection, the] **A** license
 2 holder may sell beer, wine, and liquor during the hours and days set out under § 12–2004(c)
 3 of this title.

4 [(2) The hours of sale for a license holder in an area bounded by Liberty
 5 Heights Avenue, Northern Parkway, Druid Park Drive, and Wabash Avenue are from 9
 6 a.m. to 9 p.m.]

8 (c) [Except as provided in § 12–2005 of this subtitle, a] **A** holder of a Class
 9 B–D–7 beer, wine, and liquor license may sell beer, wine, and liquor:

10 (1) **FROM 9 A.M. TO 9 P.M. IN THE AREA BOUNDED BY LIBERTY**
 11 **HEIGHTS AVENUE, NORTHERN PARKWAY, DRUID PARK DRIVE, AND WABASH**
 12 **AVENUE;**

13 **(2)** from 9 a.m. to 10 p.m. in the area specified in the Park Heights Master
 14 Plan adopted by the City in 2006; and

15 **[(2)] (3)** from 6 a.m. to 2 a.m. the following day in all other locations in
 16 the City.

18 (c) (1) This subsection does not apply to:

19 (i) a Class B beer and light wine license;

20 (ii) a Class B beer, wine, and liquor license;

21 **(III) A CLASS B–D–7 BEER, WINE, AND LIQUOR LICENSE;**

22 **[(iii)] (IV)** a Class C beer and light wine license; and

23 **[(iv)] (V)** a Class C beer, wine, and liquor license.

24 (2) For a license holder in an area bounded by Liberty Heights Avenue,
 25 Northern Parkway, Druid Park Drive, and Wabash Avenue, the hours of sale:

26 (i) may not begin before 9 a.m. or end after 10 p.m.; and

27 (ii) may not be extended if they begin later than 9 a.m. or end before
 28 10 p.m.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
2 1, 2020.
