A BILL ENTITLED

1 AN ACT concerning

2 **Department of General Services – Energy-Conserving Standards**
3 **(Maryland Sustainable Buildings Act of 2020)**

4 FOR the purpose of requiring the Department of General Services to establish and
5 periodically update certain standards for State buildings to conserve energy and
6 minimize adverse impacts on birds; requiring each State building constructed,
7 acquired, or substantially altered by the State to meet the standards to the extent
8 practicable and within budgetary constraints; requiring the Department to reduce
9 the lighting of existing State buildings in a certain manner; requiring the Secretary
10 of General Services to adopt certain regulations; establishing that certain
11 requirements do not apply to certain contracts or projects; defining “State building”;
12 and generally relating to the construction, alteration, or acquisition of State
13 buildings.

24 Preamble

25 WHEREAS, The amount of glass used in new building construction is increasing

1 dramatically in Maryland and worldwide; and

2 WHEREAS, The increase in the use of glass in buildings threatens to undo energy
3 conservation efforts, cost the State money, and contribute to climate change and
4 biodiversity loss; and

5 WHEREAS, Adopting building standards to protect birds will reduce energy
6 consumption by approximately 40% or more, making State buildings more sustainable and
7 saving taxpayers money; now, therefore,

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
9 That the Laws of Maryland read as follows:

10 **Article – State Finance and Procurement**

11 4–101.

12 (a) In this title the following words have the meanings indicated.

13 (b) “Department” means the Department of General Services.

14 (c) “Secretary” means the Secretary of General Services.

15 **4–410.1.**

16 **(A) IN THIS SECTION, “STATE BUILDING” MEANS:**

17 **(1) A BUILDING ACQUIRED THROUGH ANY MEANS BY THE STATE FOR**
18 **USE BY A STATE AGENCY OR DEPARTMENT;**

19 **(2) A BUILDING CONSTRUCTED OR RENOVATED BY OR FOR THE STATE**
20 **FOR OCCUPANCY BY A STATE AGENCY OR DEPARTMENT; OR**

21 **(3) A BUILDING ACQUIRED, CONSTRUCTED, OR RENOVATED FOR**
22 **WHICH MORE THAN 50% OF THE MONEY FOR THE ACQUISITION, CONSTRUCTION, OR**
23 **RENOVATION CAME FROM STATE FUNDS.**

24 **(B) THIS SECTION DOES NOT APPLY TO:**

25 **(1) A PUBLIC WORK CONTRACT OF LESS THAN \$500,000;**

26 **(2) A PUBLIC WORK CONTRACT FOR WHICH 50% OR LESS OF THE**
27 **FUNDS USED FOR THE PROJECT ARE STATE FUNDS; OR**

28 **(3) A PROJECT FOR WHICH FUNDING IS PROVIDED IN THE CAPITAL**
29 **BUDGET AS A GRANT TO A NONPROFIT ORGANIZATION.**

1 **(C) (1) THE DEPARTMENT SHALL ESTABLISH STANDARDS FOR STATE**
2 **BUILDINGS TO CONSERVE ENERGY AND MINIMIZE ADVERSE IMPACTS ON BIRDS**
3 **THAT ARE CONSISTENT WITH GREEN BUILDING COUNCIL LEED PILOT CREDIT 55**
4 **FOR REDUCING BIRD COLLISIONS AND THE AMERICAN BIRD CONSERVANCY**
5 **BIRD-FRIENDLY DESIGN RECOMMENDATIONS.**

6 **(2) THE DEPARTMENT SHALL UPDATE THE STANDARDS DEVELOPED**
7 **UNDER PARAGRAPH (1) OF THIS SUBSECTION EVERY 5 YEARS.**

8 **(3) THE STANDARDS DEVELOPED UNDER THIS SUBSECTION SHALL**
9 **SPECIFY THAT, EXCEPT WHERE FULL OPERATION OF BUILDING LIGHTING IS**
10 **DOCUMENTED AS NECESSARY, INCLUDING FOR PUBLIC SAFETY OR OTHER**
11 **PURPOSES, INTERIOR AND EXTERIOR LIGHTING SHALL BE APPROPRIATELY**
12 **SHIELDED AND MINIMIZED FROM MIDNIGHT TO DAWN EACH DAY:**

13 **(I) FROM MARCH 1 THROUGH MAY 31, BOTH INCLUSIVE; AND**

14 **(II) FROM AUGUST 1 THROUGH OCTOBER 31, BOTH INCLUSIVE.**

15 **(D) EACH STATE BUILDING CONSTRUCTED, SUBSTANTIALLY ALTERED, OR**
16 **ACQUIRED BY THE STATE SHALL MEET, TO THE EXTENT PRACTICABLE AND WITHIN**
17 **BUDGETARY CONSTRAINTS AS DETERMINED BY THE DEPARTMENT, THE STANDARDS**
18 **ESTABLISHED UNDER SUBSECTION (C) OF THIS SECTION.**

19 **(E) THE DEPARTMENT SHALL REDUCE THE LIGHTING OF EXISTING STATE**
20 **BUILDINGS, TO THE EXTENT PRACTICABLE AND WITHIN BUDGETARY CONSTRAINTS**
21 **AS DETERMINED BY THE DEPARTMENT:**

22 **(1) IN ACCORDANCE WITH SUBSECTION (C)(3) OF THIS SECTION; AND**

23 **(2) BY USING AUTOMATIC CONTROL TECHNOLOGIES, INCLUDING**
24 **TIMERS, PHOTOSENSORS, INFRARED DETECTORS, AND MOTION DETECTORS.**

25 **(F) THE SECRETARY SHALL ADOPT REGULATIONS TO CARRY OUT THE**
26 **PROVISIONS OF THIS SECTION.**

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
28 October 1, 2020.
