CHAPTER _____

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Cinema/Theater License**

3 FOR the purpose of repealing certain time and area restrictions on the consumption of beer,
4 wine, and liquor in a cinema or theater for which a certain license has been issued
5 in Frederick County; authorizing the on–premises consumption of beer, wine, and
6 liquor in the lobby or a screening room or performance hall in the licensed premises
7 of the cinema or theater; and generally relating to alcoholic beverages in Frederick
8 County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Alcoholic Beverages**

2 This title applies only in Frederick County.

3 20-1003.1.

4 (a) There is a Class CT (cinema/theater) (on-sale) beer, wine, and liquor license.

5 (b) The Board may issue the license for use in a for-profit cinema or theater that
6 has one or more screening rooms or performance halls.

7 (c) (1) The license authorizes the license holder to sell beer, wine, and liquor
8 for on-premises consumption by the can, bottle, or drink:

9 (i) [in a designated area of the lobby, for 45 minutes before a movie
10 starts or a theater performance starts] **IN THE LOBBY OR A SCREENING ROOM OR**
11 **PERFORMANCE HALL;** and

12 (ii) to an individual who has a ticket to a movie or a theater
13 performance and proper identification.

14 (2) A license holder shall offer for sale food other than candy and popcorn.

15 (d) A customer may consume beer, wine, or liquor anywhere on the licensed
16 premises.

17 (e) A license holder may exercise the privileges of the license Monday through
18 Sunday.

19 (f) An individual serving beer, wine, or liquor:

20 (1) may not mix the contents of one bottle with the contents of another
21 bottle; and

22 (2) shall remove or destroy all empty bottles and cans.

23 (g) (1) A license holder shall:

24 (i) obtain a crowd control training certificate from a program that is
25 certified by the State; and

26 (ii) while selling beer, wine, and liquor, have one certified crowd
27 control manager on the licensed premises for every 250 individuals present.

28 (2) Notwithstanding § 20-1903(a) of this title, a license holder shall require
29 one individual who has completed a certified alcohol awareness program to be on the

1 licensed premises at all times when alcohol is being served.

2 (h) The annual license fee is \$1,500.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
4 1, 2020.
