1 AN ACT concerning

2 **Maryland Small Business Innovation Research and Technology Transfer**
3 **Incentive Program**

4 FOR the purpose of establishing the Maryland Small Business Innovation Research and
5 Technology Transfer Incentive Program; requiring the Maryland Technology
6 Development Corporation to administer the Program; establishing the purposes of
7 the Program; establishing qualifications for participation in the Program;
8 authorizing the Program to provide certain awards and investments to certain
9 businesses on a competitive basis, subject to certain limitations; providing for the
10 coordination of certain activities of the Program with comparable county programs;
11 providing that a certain award or investment recipient may be required to return
12 certain funds under certain circumstances; establishing the Maryland Small
13 Business Innovation Research and Technology Transfer Incentive Matching Fund as
14 a special, nonlapsing fund; specifying the purpose of the Fund; requiring the
15 Corporation to administer the Fund; requiring the State Treasurer to hold the Fund,
16 and the Comptroller to account for the Fund; specifying the contents of the Fund;
17 specifying the purpose for which the Fund may be used; providing for the investment
18 of money in and expenditures from the Fund; requiring interest earnings of the Fund
19 to be credited to the Fund; requiring the Corporation to adopt certain regulations;
20 exempting the Fund from a certain provision of law requiring interest earnings on

12 **(2) HAVE RECEIVED A PHASE I OR PHASE II SMALL BUSINESS**

17 **(C) AN AWARD OR INVESTMENT RECIPIENT THAT FAILS TO FULFILL THE**
18 **ELIGIBILITY AND MAINTENANCE REQUIREMENTS OF THE PROGRAM MAY BE**
19 **REQUIRED TO RETURN ALL OR PART OF THE AWARD OR INVESTMENT, AS WELL AS**
20 **ANY ACCRUED INTEREST OR FEES, TO THE PROGRAM.**

21 **(D) THE PROGRAM SHALL REQUIRE AN AWARD OR INVESTMENT RECIPIENT**
22 **TO RETURN TO THE FUND ANY MONEY FROM AN AWARD OR INVESTMENT UNDER**
23 **THIS PART, AS WELL AS ANY ACCRUED INTEREST OR FEES, IF THE RECIPIENT DOES**
24 **NOT REMAIN IN THE STATE FOR AT LEAST 2 YEARS AFTER RECEIVING THE AWARD**
25 **OR INVESTMENT PAYMENT.**

30 **MATERIALS TO EVALUATE WHETHER THE APPLICANT QUALIFIES FOR AN AWARD OR**

1 (C) SUBJECT TO THE AVAILABILITY OF MONEY IN THE FUND, THE
2 PROGRAM MAY PROVIDE TO AN ELIGIBLE SMALL BUSINESS AN AWARD OR

4 OR SMALL BUSINESS TECHNOLOGY TRANSFER GRANT.

5 (D) EXCEPT AS PROVIDED IN SUBSECTION (F) OF THIS SECTION, A SMALL
6 BUSINESS THAT RECEIVES AN AWARD OR INVESTMENT FOR A PHASE I SMALL
7 BUSINESS INNOVATION RESEARCH GRANT OR SMALL BUSINESS TECHNOLOGY
8 TRANSFER GRANT, OR A SIMILAR GRANT UNDER A SIMILAR PROGRAM
9 ADMINISTERED BY AN AGENCY OF THE FEDERAL GOVERNMENT, SHALL RECEIVE AN
10 AWARD OR INVESTMENT IN AN AMOUNT THAT IS THE LESSER OF:

11 (1) 25% OF THE PHASE I SMALL BUSINESS INNOVATION RESEARCH
12 GRANT OR SMALL BUSINESS TECHNOLOGY TRANSFER GRANT, OR A SIMILAR GRANT
13 UNDER A SIMILAR PROGRAM ADMINISTERED BY AN AGENCY OF THE FEDERAL
14 GOVERNMENT; OR

15 (2) \$25,000.

16 (E) EXCEPT AS PROVIDED IN SUBSECTION (F) OF THIS SECTION, A SMALL
17 BUSINESS THAT RECEIVES AN AWARD OR INVESTMENT FOR A PHASE II SMALL
18 BUSINESS INNOVATION RESEARCH GRANT OR SMALL BUSINESS TECHNOLOGY
19 TRANSFER GRANT, OR A SIMILAR GRANT UNDER A SIMILAR PROGRAM
20 ADMINISTERED BY AN AGENCY OF THE FEDERAL GOVERNMENT, SHALL RECEIVE AN
21 AWARD OR INVESTMENT IN AN AMOUNT THAT IS THE LESSER OF:

22 (1) 25% OF THE PHASE II SMALL BUSINESS INNOVATION RESEARCH
23 GRANT OR SMALL BUSINESS TECHNOLOGY TRANSFER GRANT, OR A SIMILAR GRANT
24 UNDER A SIMILAR PROGRAM ADMINISTERED BY AN AGENCY OF THE FEDERAL
25 GOVERNMENT; OR

26 (2) \$75,000.

27 (F) ON THE RECOMMENDATION OF THE EXECUTIVE DIRECTOR, THE
28 BOARD MAY APPROVE AN AWARD OR INVESTMENT IN A SMALL BUSINESS IN EXCESS
29 OF THE LIMITATIONS SPECIFIED UNDER SUBSECTIONS (D) AND (E) OF THIS SECTION
30 IF THE BOARD DETERMINES THAT THE AWARD IS NECESSARY TO BETTER SERVE THE
31 COMMUNITY AND THE PURPOSES OF THE PROGRAM.

32 (G) DURING EACH FISCAL YEAR:

33 (1) THE CORPORATION MAY NOT PROVIDE MORE THAN 20 AWARDS
34 OR INVESTMENTS IN ACCORDANCE WITH SUBSECTION (D) OF THIS SECTION OR

1 MORE THAN 10 AWARDS OR INVESTMENTS IN ACCORDANCE WITH SUBSECTION (E)
2 OF THIS SECTION; AND

3 (2) A SMALL BUSINESS MAY NOT RECEIVE MORE THAN ONE AWARD OR
4 INVESTMENT.

5 (H) A SMALL BUSINESS MAY NOT RECEIVE MORE THAN THREE AWARDS OR
6 INVESTMENTS UNDER THIS PART.

7 (I) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, EACH
8 QUARTER, THE CORPORATION SHALL PROVIDE AWARDS AND INVESTMENTS ON A
9 COMPETITIVE BASIS TO ELIGIBLE SMALL BUSINESSES.

10 (2) IN PROVIDING AN AWARD OR INVESTMENT UNDER THIS SECTION,
11 THE CORPORATION:

12 (I) SHALL CONSIDER:

13 1. THE IMPACT OF THE AWARD OR INVESTMENT ON THE
14 SMALL BUSINESS; AND

15 2. HOW THE SMALL BUSINESS WILL UTILIZE THE AWARD
16 OR INVESTMENT TOWARD COMMERCIALIZATION OF THE RESEARCH CONDUCTED BY
17 THE SMALL BUSINESS; AND

18 (II) MAY CONSIDER ANY ADDITIONAL CRITERIA SPECIFIED BY
19 THE CORPORATION IN REGULATION.

20 (J) THE PROGRAM SHALL COORDINATE WITH COMPARABLE STATE AND
21 COUNTY PROGRAMS TO:

22 (1) CONDUCT MARKETING AND OUTREACH, INCLUDING CONDUCTING
23 JOINT WORKSHOPS, ONLINE TRAINING OPPORTUNITIES, AND OUTREACH TO
24 ECONOMICALLY DISADVANTAGED SMALL BUSINESSES AND FIRST-TIME SMALL
25 BUSINESS INNOVATION RESEARCH GRANT OR SMALL BUSINESS TECHNOLOGY
26 TRANSFER GRANT APPLICANTS; AND

27 (2) PROVIDE ASSISTANCE TO ELIGIBLE BUSINESSES UNDER THIS
28 PART.

30 (A) THERE IS A MARYLAND SMALL BUSINESS INNOVATION RESEARCH AND
31 TECHNOLOGY TRANSFER INCENTIVE MATCHING FUND.

1 **(B) THE PURPOSE OF THE FUND IS TO PROVIDE AWARDS OR INVESTMENTS**
2 **TO FURTHER STIMULATE INNOVATION AND ENTREPRENEURSHIP AND ATTRACT**
3 **EARLY-STAGE SMALL BUSINESSES ENGAGED IN RESEARCH AND DEVELOPMENT.**

4 **(C) THE CORPORATION SHALL ADMINISTER THE FUND.**

5 **(D) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT**
6 **SUBJECT TO REVERSION UNDER § 7-302 OF THE STATE FINANCE AND**
7 **PROCUREMENT ARTICLE.**

8 **(2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,**
9 **AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.**

10 **(E) THE FUND CONSISTS OF:**

11 **(1) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;**

12 **(2) REPAYMENTS AND EARNINGS FROM INVESTMENTS MADE**
13 **THROUGH THE PROGRAM;**

14 **(3) MONEY RECAPTURED FROM BUSINESSES THAT FAIL TO FULFILL**
15 **THE TERMS AND CONDITIONS OF AN AWARD OR INVESTMENT MADE THROUGH THE**
16 **PROGRAM;**

17 **(4) INTEREST EARNINGS OF THE FUND; AND**

18 **(5) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR**
19 **THE BENEFIT OF THE FUND.**

20 **(F) THE FUND MAY BE USED ONLY FOR:**

21 **(1) PROVIDING AWARDS OR INVESTMENTS TO ELIGIBLE SMALL**
22 **BUSINESSES THAT HAVE RECEIVED FINANCIAL ASSISTANCE FROM THE FEDERAL**
23 **GOVERNMENT UNDER COMPARABLE SMALL BUSINESS INNOVATION RESEARCH OR**
24 **SMALL BUSINESS TECHNOLOGY TRANSFER GRANT PROGRAMS; AND**

25 **(2) ADMINISTRATIVE EXPENSES OF THE PROGRAM, INCLUDING**
26 **MARKETING, OUTREACH, AND TECHNICAL ASSISTANCE.**

27 **(G) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND**
28 **IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.**

1 **(2) INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO THE**
2 **FUND.**

3 **(H) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE**
4 **WITH THE STATE BUDGET.**

13 receive interest earnings, as accounted for by the Comptroller, shall accrue to the General
14 Fund of the State.
