A BILL ENTITLED

1 AN ACT concerning

2 **Real Property – Regulation of Common Ownership Community Managers**

3 FOR the purpose of creating the State Board of Common Ownership Community Managers
4 in the Maryland Department of Labor; providing for the composition of the Board
5 and the appointment, terms, and expenses of the Board members; providing for the
6 powers, duties, and functions of the Board; providing that certain provisions of this
7 Act do not prohibit certain persons from providing certain services under certain
8 circumstances; requiring an individual to be issued a license by the Board before
9 providing management services for a common ownership community under certain
10 circumstances; specifying the qualifications for a license; providing for the issuance,
11 fees, renewal, and reinstatement of a license; authorizing the Board to deny a license
12 to any applicant, reprimand a licensed community manager, or suspend or revoke a
13 license under certain circumstances; requiring an individual to be issued a limited
14 license by the Board before providing management services for a common ownership
15 community under certain circumstances; specifying the qualifications for a limited
16 license; providing for the issuance, fees, renewal, and reinstatement of a limited
17 license; authorizing the Board to deny a limited license to any applicant, reprimand
18 any licensed associate community manager, or suspend or revoke a limited license
19 under certain circumstances; requiring a common ownership community to register
20 with the Board under certain circumstances; imposing certain duties on a
21 contracting party concerning a fidelity bond or theft insurance under certain
22 circumstances; imposing certain duties concerning financial institution accounts on
23 a licensed community manager; requiring a contract to provide management services
24 to include certain provisions under certain circumstances; prohibiting certain acts
25 and imposing certain penalties for a violation of this Act; making certain provisions
26 of this Act subject to the Maryland Program Evaluation Act; establishing the State
27 Board of Common Ownership Community Managers Fund; providing for the
28 purpose, administration, composition, use, and audit of the Fund; requiring that
29 certain interest earnings be credited to the Fund; requiring the Secretary of Labor,
30 in consultation with the Board, to calculate certain costs annually; authorizing the
31 Board to set certain fees, based on certain calculations; prohibiting a fee established

1 by the Board from being increased by more than a certain percentage annually;
2 specifying the terms of the initial members of the Board; providing that the Board
3 may take into consideration certain training and testing standards when adopting
4 certain regulations; providing that a certain examination shall satisfy certain
5 examination requirements for a license under certain circumstances; requiring the
6 Board to grant a waiver of certain training and examination requirements for a
7 license under certain circumstances; requiring the Maryland Department of Labor
8 to report to the General Assembly on or before a certain date; authorizing the
9 Department of Budget and Management to advance certain funds to the Board and
10 requiring the Board to reimburse certain funds under certain circumstances;
11 defining certain terms; and generally relating to the regulation of common ownership
12 community managers.

29 **(A) IN THIS TITLE THE FOLLOWING WORDS HAVE THE MEANINGS**
30 **INDICATED.**

31 **(B) “BOARD” MEANS THE STATE BOARD OF COMMON OWNERSHIP**
32 **COMMUNITY MANAGERS.**

33 **(C) (1) “COMMON OWNERSHIP COMMUNITY” MEANS:**

1 (I) A CONDOMINIUM AS DEFINED IN § 11-101 OF THE REAL
2 PROPERTY ARTICLE THAT IS USED FOR RESIDENTIAL PURPOSES;

3 (II) A COOPERATIVE HOUSING CORPORATION AS DEFINED IN §
4 5-6B-01 OF THE CORPORATIONS AND ASSOCIATIONS ARTICLE; AND

5 (III) A HOMEOWNERS ASSOCIATION AS DEFINED IN § 11B-101 OF
6 THE REAL PROPERTY ARTICLE.

7 (2) "COMMON OWNERSHIP COMMUNITY" DOES NOT INCLUDE A
8 TIME-SHARE PROJECT AS DEFINED IN § 11A-101 OF THE REAL PROPERTY
9 ARTICLE.

10 (D) "LICENSE" MEANS, UNLESS THE CONTEXT REQUIRES OTHERWISE, A
11 LICENSE ISSUED BY THE BOARD UNDER SUBTITLE 3 OF THIS TITLE THAT ALLOWS
12 AN INDIVIDUAL TO PROVIDE MANAGEMENT SERVICES FOR A COMMON OWNERSHIP
13 COMMUNITY.

14 (E) "LICENSED ASSOCIATE COMMUNITY MANAGER" MEANS, UNLESS THE
15 CONTEXT REQUIRES OTHERWISE, AN INDIVIDUAL WHO IS ISSUED A LIMITED
16 LICENSE BY THE BOARD UNDER SUBTITLE 4 OF THIS TITLE TO PROVIDE
17 MANAGEMENT SERVICES FOR A COMMON OWNERSHIP COMMUNITY UNDER THE
18 SUPERVISION OF A LICENSED COMMUNITY MANAGER.

19 (F) "LICENSED COMMUNITY MANAGER" MEANS, UNLESS THE CONTEXT
20 REQUIRES OTHERWISE, AN INDIVIDUAL WHO IS ISSUED A LICENSE BY THE BOARD
21 UNDER SUBTITLE 3 OF THIS TITLE TO PROVIDE MANAGEMENT SERVICES FOR A
22 COMMON OWNERSHIP COMMUNITY.

23 (G) "LIMITED LICENSE" MEANS, UNLESS THE CONTEXT REQUIRES
24 OTHERWISE, A LIMITED LICENSE ISSUED BY THE BOARD UNDER SUBTITLE 4 OF THIS
25 TITLE THAT ALLOWS THE INDIVIDUAL TO PROVIDE MANAGEMENT SERVICES FOR A
26 COMMON OWNERSHIP COMMUNITY UNDER THE SUPERVISION OF A LICENSED
27 COMMUNITY MANAGER.

28 (H) "PROVIDE MANAGEMENT SERVICES" MEANS:

29 (1) TO ACT WITH THE AUTHORITY OF THE COMMON OWNERSHIP
30 COMMUNITY IN ITS BUSINESS, LEGAL, FINANCIAL, OR OTHER TRANSACTIONS WITH
31 MEMBERS AND NONMEMBERS OF THE COMMON OWNERSHIP COMMUNITY;

32 (2) TO EXECUTE THE RESOLUTIONS AND DECISIONS OF A COMMON
33 OWNERSHIP COMMUNITY OR, WITH THE AUTHORITY OF THE COMMON OWNERSHIP
34 COMMUNITY, TO ENFORCE THE RIGHTS OF THE COMMON OWNERSHIP COMMUNITY

1 SECURED BY STATUTE, CONTRACT, COVENANT, RULE, OR BYLAW;

2 (3) TO NEGOTIATE CONTRACTS OR OTHERWISE COORDINATE OR
3 ARRANGE FOR SERVICES OR THE PURCHASE OF PROPERTY AND GOODS FOR OR ON
4 BEHALF OF A COMMON OWNERSHIP COMMUNITY;

5 (4) TO COLLECT, DISBURSE, OR OTHERWISE EXERCISE DOMINION OR
6 CONTROL OVER MONEY OR OTHER PROPERTY BELONGING TO A COMMON
7 OWNERSHIP COMMUNITY;

8 (5) TO PREPARE BUDGETS, FINANCIAL STATEMENTS, OR OTHER
9 FINANCIAL REPORTS FOR A COMMON OWNERSHIP COMMUNITY;

10 (6) TO ARRANGE, CONDUCT, OR COORDINATE MEETINGS OF A
11 COMMON OWNERSHIP COMMUNITY OR THE GOVERNING BODY OF A COMMON
12 OWNERSHIP COMMUNITY; OR

13 (7) TO OFFER OR SOLICIT TO PERFORM ANY OF THE ACTS OR
14 SERVICES LISTED IN ITEMS (1) THROUGH (6) OF THIS SUBSECTION ON BEHALF OF A
15 COMMON OWNERSHIP COMMUNITY.

16 (I) "RESPONSIBLE MANAGER" MEANS A LICENSED COMMUNITY MANAGER
17 WHO HAS PRIMARY RESPONSIBILITY FOR PROVIDING MANAGEMENT SERVICES TO A
18 COMMON OWNERSHIP COMMUNITY UNDER THE TERMS OF A CONTRACT ENTERED
19 INTO BY THE COMMON OWNERSHIP COMMUNITY.

21 THE PROVISIONS OF THIS TITLE THAT REQUIRE AN INDIVIDUAL TO BE ISSUED
22 A LICENSE OR A LIMITED LICENSE DO NOT PROHIBIT:

23 (1) AN INDIVIDUAL WHO IS A REGULAR, SALARIED EMPLOYEE OF A
24 LICENSED COMMUNITY MANAGER OR A SINGLE COMMON OWNERSHIP COMMUNITY
25 FROM PERFORMING ADMINISTRATIVE, INTERNAL, BOOKKEEPING, OR MINISTERIAL
26 FUNCTIONS IN SUPPORT OF THE LICENSED COMMUNITY MANAGER OR THE SINGLE
27 COMMON OWNERSHIP COMMUNITY;

28 (2) AN INDIVIDUAL WHO IS ADMINISTRATIVE SUPPORT STAFF OR AN
29 ASSISTANT OF A LICENSED COMMUNITY MANAGER FROM INCIDENTALLY PROVIDING
30 MANAGEMENT SERVICES IF THE INDIVIDUAL IS SUPERVISED BY A LICENSED
31 COMMUNITY MANAGER;

32 (3) A RESIDENT OF A COMMON OWNERSHIP COMMUNITY WHO ACTS
33 WITHOUT COMPENSATION FROM PROVIDING MANAGEMENT SERVICES FOR THAT

1 COMMON OWNERSHIP COMMUNITY;

2 (4) A MEMBER OF THE GOVERNING BODY OF A COMMON OWNERSHIP
3 COMMUNITY WHO ACTS WITHOUT COMPENSATION FROM PROVIDING MANAGEMENT
4 SERVICES FOR THAT COMMON OWNERSHIP COMMUNITY;

5 (5) AN ATTORNEY AT LAW FROM REPRESENTING A COMMON
6 OWNERSHIP COMMUNITY, A LICENSED COMMUNITY MANAGER, OR A LICENSED
7 ASSOCIATE COMMUNITY MANAGER IN ANY BUSINESS THAT CONSTITUTES THE
8 PRACTICE OF LAW;

9 (6) AN INDIVIDUAL LICENSED UNDER THIS ARTICLE AS A LICENSED
10 CERTIFIED PUBLIC ACCOUNTANT, A LICENSED REAL ESTATE BROKER, OR A
11 LICENSED ASSOCIATE REAL ESTATE BROKER FROM PROVIDING TO A COMMON
12 OWNERSHIP COMMUNITY THE SERVICES FOR WHICH THE INDIVIDUAL IS LICENSED;
13 OR

14 (7) AN INDIVIDUAL WHO ACTS AS A RECEIVER OR TRUSTEE IN
15 BANKRUPTCY IN THE PERFORMANCE OF DUTIES OR AN INDIVIDUAL WHO ACTS
16 UNDER A COURT ORDER FROM PROVIDING MANAGEMENT SERVICES FOR A COMMON
17 OWNERSHIP COMMUNITY.

18 SUBTITLE 2. STATE BOARD OF COMMON OWNERSHIP COMMUNITY MANAGERS.

20 THERE IS A STATE BOARD OF COMMON OWNERSHIP COMMUNITY MANAGERS
21 IN THE DEPARTMENT.

22 22-202.

23 (A) (1) THE BOARD CONSISTS OF NINE MEMBERS.

24 (2) OF THE NINE MEMBERS OF THE BOARD:

25 (I) FIVE SHALL BE LICENSED COMMON OWNERSHIP
26 COMMUNITY MANAGERS;

27 (II) ONE SHALL BE A LAWYER, AS DEFINED IN § 10-101 OF THIS
28 ARTICLE, WHOSE PRIMARY PRACTICE INCLUDES THE REPRESENTATION OF
29 COMMON OWNERSHIP COMMUNITIES; AND

30 (III) THREE SHALL BE RESIDENT OWNERS IN A COMMON
31 OWNERSHIP COMMUNITY.

1 **(3) THE GOVERNOR SHALL APPOINT THE MEMBERS WITH THE**
2 **ADVICE OF THE SECRETARY AND THE ADVICE AND CONSENT OF THE SENATE.**

3 **(B) EACH MEMBER OF THE BOARD MUST BE A RESIDENT OF THE STATE.**

4 **(C) BEFORE TAKING OFFICE, EACH APPOINTEE TO THE BOARD SHALL TAKE**
5 **THE OATH REQUIRED BY ARTICLE I, § 9 OF THE MARYLAND CONSTITUTION.**

6 **(D) (1) THE TERM OF A MEMBER IS 4 YEARS AND BEGINS ON JULY 1.**

7 **(2) THE TERMS OF THE MEMBERS ARE STAGGERED AS REQUIRED BY**
8 **THE TERMS PROVIDED FOR MEMBERS OF THE BOARD ON OCTOBER 1, 2020.**

9 **(3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL**
10 **A SUCCESSOR IS APPOINTED AND QUALIFIES.**

11 **(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**
12 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND**
13 **QUALIFIES.**

14 **(5) A MEMBER MAY NOT SERVE MORE THAN TWO CONSECUTIVE**
15 **TERMS.**

5 (1) ADOPT BYLAWS AS NECESSARY TO DO THE BUSINESS OF THE

7 (2) ADOPT ANY REGULATIONS TO CARRY OUT THIS TITLE.

8 (B) IN ADDITION TO ANY DUTIES SET FORTH ELSEWHERE, THE BOARD

16 INDIVIDUALS WHO HAVE BEEN ISSUED A LICENSE OR A LIMITED LICENSE UNDER
17 THIS TITLE; AND

18 (4) KEEP A RECORD OF ITS PROCEEDINGS.

19 (C) THE BOARD MAY ESTABLISH BY REGULATION:

20 (1) THE PROCESS OF RESOLVING DISCIPLINARY MATTERS PENDING
21 BEFORE THE BOARD THROUGH NONJUDICIAL DISPUTE RESOLUTION PROCESSES;

22 (2) EDUCATION AND TRAINING OPPORTUNITIES FOR GOVERNING
23 BODIES OF COMMON OWNERSHIP COMMUNITIES; AND

24 (3) ANY OTHER PROCEDURES OR STANDARDS CONSISTENT WITH THE
25 MISSION OF THE BOARD.

10 (A) AN INDIVIDUAL MUST BE ISSUED A LICENSE BY THE BOARD BEFORE
11 THE INDIVIDUAL MAY PROVIDE MANAGEMENT SERVICES AS A LICENSED
12 COMMUNITY MANAGER FOR A COMMON OWNERSHIP COMMUNITY IN THE STATE.

13 (B) A LICENSED COMMUNITY MANAGER MAY PROVIDE MANAGEMENT
14 SERVICES FOR A COMMON OWNERSHIP COMMUNITY ONLY UNDER THE TERMS OF A
15 CONTRACT ENTERED INTO BY THE COMMON OWNERSHIP COMMUNITY.

17 (A) TO QUALIFY FOR A LICENSE, AN APPLICANT MUST BE AN INDIVIDUAL
18 WHO MEETS:

19 (1) THE REQUIREMENTS OF THIS SECTION; AND

20 (2) ANY OTHER QUALIFICATION AS REQUIRED BY REGULATION OF
21 THE BOARD.

22 (B) AN APPLICANT MUST BE A LICENSED ASSOCIATE COMMUNITY
23 MANAGER.

24 (C) AN APPLICANT SHALL:

25 (1) COMPLETE A TRAINING PROGRAM APPROVED BY THE BOARD; AND

26 (2) PASS AN EXAMINATION APPROVED BY THE BOARD THAT
27 INCLUDES TESTING OF KNOWLEDGE OF STATE LAWS AND REGULATIONS
28 CONCERNING COMMON OWNERSHIP COMMUNITIES.

1 (D) AN APPLICANT MUST:

2 (1) BE ACTIVELY ENGAGED IN PROVIDING MANAGEMENT SERVICES
3 FOR AT LEAST 5 YEARS AS A LICENSED ASSOCIATE COMMUNITY MANAGER BEFORE
4 APPLYING FOR A LICENSE; OR

5 (2) HOLD AN ACTIVE PROFESSIONAL DESIGNATION AS APPROVED BY
6 THE BOARD.

7 22-303.

8 AN APPLICANT FOR A LICENSE SHALL:

9 (1) SUBMIT TO THE BOARD AN APPLICATION ON THE FORM THAT THE
10 BOARD PROVIDES; AND

11 (2) PAY TO THE BOARD AN APPLICATION FEE SET BY THE BOARD.

5 the requirements listed in subsection (b) of this section shall be deemed adequate for
6 satisfying the requirements of § 22–302(c) or § 22–402(c) of the Business Occupations and
7 Professions Article, as enacted by Section 2 of this Act.

8 (b) The examination specified under subsection (a) of this section shall be:

9 (1) a nationally prepared and administered standardized examination for
10 the community association management profession; and

11 (2) developed according to the basic principles of professional testing
12 standards that utilize psychometric measurement.

13 SECTION 6. AND BE IT FURTHER ENACTED, That the State Board of Common
14 Ownership Community Managers shall grant a waiver of the training and examination
15 requirements for a license issued under § 22–304 or a limited license issued under §
16 22–404 of the Business Occupations and Professions Article, as enacted by Section 2 of this
17 Act, to any applicant who presents to the Board not later than October 1, 2022, satisfactory
18 evidence that the applicant provided management services in the State for the 2 years
19 immediately before the date of application.

20 SECTION 7. AND BE IT FURTHER ENACTED, That, on or before December 1,
21 2020, the Maryland Department of Labor shall report to the General Assembly, in
22 accordance with § 2–1257 of the State Government Article, on the imposition of a
23 registration fee on common ownership communities, including the necessity for and amount
24 of a registration fee on common ownership communities in relation to the license fees and
25 limited license fees required under this Act and the size of a common ownership community
26 to which a registration fee would apply.

27 SECTION 8. AND BE IT FURTHER ENACTED, That the Department of Budget
28 and Management, by budget amendment, may advance sufficient funds to the State Board
29 of Common Ownership Community Managers to allow the Board to commence operations
30 on October 1, 2020, so that the functions of issuing licenses and limited licenses and
31 registering common ownership communities can be in place prior to October 1, 2021. The
32 Board shall reimburse any funds that have been advanced after the license fees and limited
33 license fees have been received and deposited into the State Board of Common Ownership
34 Community Managers Fund.

35 SECTION 9. AND BE IT FURTHER ENACTED, That this Act shall take effect
36 October 1, 2020.
