CHAPTER _____

1 AN ACT concerning

2 **Real Property – Regulation of Common Ownership Community Managers**

3 FOR the purpose of creating the State Board of Common Ownership Community Managers
4 in the Maryland Department of Labor; providing for the composition of the Board
5 and the appointment, terms, and expenses of the Board members; providing for the
6 powers, duties, and functions of the Board; requiring the Maryland Department of
7 Labor to allocate a certain amount of money for the establishment of the Board in a
8 certain fiscal year; providing that certain provisions of this Act do not prohibit
9 certain persons from providing certain services under certain circumstances;
10 requiring an individual to be issued a license by the Board before providing
11 management services for a common ownership community under certain
12 circumstances; specifying the qualifications for a license; providing for the issuance,
13 fees, renewal, and reinstatement of a license; authorizing the Board to deny a license
14 to any applicant, reprimand a licensed community manager, or suspend or revoke a
15 license under certain circumstances; requiring an individual to be issued a limited
16 license by the Board before providing management services for a common ownership
17 community under certain circumstances; specifying the qualifications for a limited
18 license; providing for the issuance, fees, renewal, and reinstatement of a limited
19 license; authorizing the Board to deny a limited license to any applicant, reprimand
20 any licensed associate community manager, or suspend or revoke a limited license
21 under certain circumstances; requiring a common ownership community to register
22 with the Board under certain circumstances; imposing certain duties on a
23 contracting party concerning a fidelity bond or theft insurance under certain
24 circumstances; imposing certain duties concerning financial institution accounts on
25 a licensed community manager; requiring a contract to provide management services

18 requiring the Board to reimburse certain funds under certain circumstances;

17 AN INDIVIDUAL TO PROVIDE MANAGEMENT SERVICES FOR A COMMON OWNERSHIP
18 COMMUNITY.

19 (E) "LICENSED ASSOCIATE COMMUNITY MANAGER" MEANS, UNLESS THE
20 CONTEXT REQUIRES OTHERWISE, AN INDIVIDUAL WHO IS ISSUED A LIMITED
21 LICENSE BY THE BOARD UNDER SUBTITLE 4 OF THIS TITLE TO PROVIDE
22 MANAGEMENT SERVICES FOR A COMMON OWNERSHIP COMMUNITY UNDER THE
23 SUPERVISION OF A LICENSED COMMUNITY MANAGER.

24 (F) "LICENSED COMMUNITY MANAGER" MEANS, UNLESS THE CONTEXT
25 REQUIRES OTHERWISE, AN INDIVIDUAL WHO IS ISSUED A LICENSE BY THE BOARD
26 UNDER SUBTITLE 3 OF THIS TITLE TO PROVIDE MANAGEMENT SERVICES FOR A
27 COMMON OWNERSHIP COMMUNITY.

28 (G) "LIMITED LICENSE" MEANS, UNLESS THE CONTEXT REQUIRES
29 OTHERWISE, A LIMITED LICENSE ISSUED BY THE BOARD UNDER SUBTITLE 4 OF THIS
30 TITLE THAT ALLOWS THE INDIVIDUAL TO PROVIDE MANAGEMENT SERVICES FOR A
31 COMMON OWNERSHIP COMMUNITY UNDER THE SUPERVISION OF A LICENSED
32 COMMUNITY MANAGER.

33 (H) "PROVIDE MANAGEMENT SERVICES" MEANS:

1 (1) TO ACT WITH THE AUTHORITY OF THE COMMON OWNERSHIP
2 COMMUNITY IN ITS BUSINESS, LEGAL, FINANCIAL, OR OTHER TRANSACTIONS WITH
3 MEMBERS AND NONMEMBERS OF THE COMMON OWNERSHIP COMMUNITY;

4 (2) TO EXECUTE THE RESOLUTIONS AND DECISIONS OF A COMMON
5 OWNERSHIP COMMUNITY ~~OR, WITH THE AUTHORITY OF THE COMMON OWNERSHIP~~

7 (3) TO ENFORCE THE RIGHTS OF THE COMMON OWNERSHIP
8 COMMUNITY SECURED BY STATUTE, CONTRACT, COVENANT, RULE, OR BYLAW WITH

24 (I) "RESPONSIBLE MANAGER" MEANS A LICENSED COMMUNITY MANAGER
25 WHO HAS PRIMARY RESPONSIBILITY FOR PROVIDING MANAGEMENT SERVICES TO A
26 COMMON OWNERSHIP COMMUNITY UNDER THE TERMS OF A CONTRACT ENTERED
27 INTO BY THE COMMON OWNERSHIP COMMUNITY.

29 THE PROVISIONS OF THIS TITLE THAT REQUIRE AN INDIVIDUAL TO BE ISSUED
30 A LICENSE OR A LIMITED LICENSE DO NOT PROHIBIT:

5 ASSISTANT OF A LICENSED COMMUNITY MANAGER FROM INCIDENTALLY PROVIDING
6 MANAGEMENT SERVICES IF THE INDIVIDUAL IS SUPERVISED BY A LICENSED
7 COMMUNITY MANAGER;

8 (3) A RESIDENT OF A COMMON OWNERSHIP COMMUNITY WHO ACTS
9 WITHOUT COMPENSATION FROM PROVIDING MANAGEMENT SERVICES FOR THAT
10 COMMON OWNERSHIP COMMUNITY;

11 (4) A MEMBER OF THE GOVERNING BODY OF A COMMON OWNERSHIP
12 COMMUNITY WHO ACTS WITHOUT COMPENSATION FROM PROVIDING MANAGEMENT
13 SERVICES FOR THAT COMMON OWNERSHIP COMMUNITY;

14 (5) AN ATTORNEY AT LAW FROM REPRESENTING A COMMON
15 OWNERSHIP COMMUNITY, A LICENSED COMMUNITY MANAGER, OR A LICENSED
16 ASSOCIATE COMMUNITY MANAGER IN ANY BUSINESS THAT CONSTITUTES THE
17 PRACTICE OF LAW;

21 OWNERSHIP COMMUNITY THE SERVICES FOR WHICH THE INDIVIDUAL IS LICENSED;

2 (A) (1) THE BOARD CONSISTS OF NINE MEMBERS.

3 (2) OF THE NINE MEMBERS OF THE BOARD:

4 (I) FIVE SHALL BE LICENSED COMMON OWNERSHIP
5 COMMUNITY MANAGERS;

6 (II) ONE SHALL BE A LAWYER, AS DEFINED IN § 10-101 OF THIS
7 ARTICLE, WHOSE PRIMARY PRACTICE INCLUDES THE REPRESENTATION OF

4 (i) courses that include topics such as:

7 3. management of large-scale communities;

8 4. legal considerations in community management; and

9 5. contemporary issues in community management; and

10 (ii) examinations that include a case study of an existing common
11 ownership community.

12 SECTION 5. AND BE IT FURTHER ENACTED, That:

13 (a) Until the time that the State Board of Common Ownership Community
14 Managers adopts regulations concerning the training and examination requirements for an
15 applicant for a license or limited license under this Act, passing an examination that meets
16 the requirements listed in subsection (b) of this section shall be deemed adequate for
17 satisfying the requirements of § 22-302(c) or § 22-402(c) of the Business Occupations and
18 Professions Article, as enacted by Section 2 of this Act.

19 (b) The examination specified under subsection (a) of this section shall be:

20 (1) a nationally prepared and administered standardized examination for
21 the community association management profession; and

22 (2) developed according to the basic principles of professional testing
23 standards that utilize psychometric measurement.

24 SECTION 6. AND BE IT FURTHER ENACTED, That the State Board of Common
25 Ownership Community Managers shall grant a waiver of the training and examination
26 requirements for a license issued under § 22-304 or a limited license issued under §
27 22-404 of the Business Occupations and Professions Article, as enacted by Section 2 of this
28 Act, to any applicant who presents to the Board not later than October 1, 2022, satisfactory
29 evidence that the applicant provided management services in the State for the 2 years
30 immediately before the date of application.

1 SECTION 7. AND BE IT FURTHER ENACTED, That, on or before December 1,
2 2020, the Maryland Department of Labor shall report to the General Assembly, in
3 accordance with § 2-1257 of the State Government Article, on the imposition of a
4 registration fee on common ownership communities, including the necessity for and amount
5 of a registration fee on common ownership communities in relation to the license fees and
6 limited license fees required under this Act and the size of a common ownership community
7 to which a registration fee would apply.

8 SECTION 8. AND BE IT FURTHER ENACTED, That the Department of Budget
9 and Management, by budget amendment, may advance sufficient funds to the State Board
10 of Common Ownership Community Managers to allow the Board to commence operations
11 on October 1, 2020, so that the functions of issuing licenses and limited licenses and
12 registering common ownership communities can be in place prior to October 1, 2021. The
13 Board shall reimburse any funds that have been advanced after the license fees and limited
14 license fees have been received and deposited into the State Board of Common Ownership
15 Community Managers Fund.

16 SECTION 9. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2020.
