## A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Registration – Renewal**

3 FOR the purpose of requiring that the system of multiyear vehicle registration adopted by  
4 the Motor Vehicle Administration include for certain registration classes certain  
5 options for the duration of a registration to be phased in over a certain number of  
6 years; requiring the Administration to make available certain methods of obtaining  
7 or renewing a vehicle registration for certain motor vehicles; authorizing the  
8 Administration to charge a certain late fee for registration renewals that occur more  
9 than a certain period of time after a registration has expired; requiring that a certain  
10 amount of the late fee authorized by this Act be paid into a certain fund; and  
11 generally relating to vehicle registration renewal.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
23 That the Laws of Maryland read as follows:

2 (a) (1) Notwithstanding any other provision of this subtitle **AND SUBJECT TO**  
3 **PARAGRAPH (2) OF THIS SUBSECTION**, the Administration may adopt a system of  
4 multiyear registration.

5 (2) (I) **FOR A CLASS A (PASSENGER) VEHICLE OR CLASS D**  
6 **(MOTORCYCLE) VEHICLE, THE ADMINISTRATION SHALL PHASE IN A SYSTEM OF**  
7 **MULTIYEAR REGISTRATION THAT INCLUDES OPTIONS FOR REGISTRATION FOR**  
8 **1- OR 2-YEAR PERIODS.**

9 (II) **THE MULTIYEAR REGISTRATION SYSTEM UNDER**  
10 **SUBPARAGRAPH (I) OF THIS PARAGRAPH SHALL BE PHASED IN TO ALLOW**  
11 **REGISTRATION:**

12 1. **BEGINNING JANUARY 1, 2021, FOR A VEHICLE**  
13 **MANUFACTURED AT LEAST 20 YEARS BEFORE THE DATE OF REGISTRATION;**

14 2. **BEGINNING JANUARY 1, 2022, FOR A VEHICLE**  
15 **MANUFACTURED AT LEAST 19 YEARS BEFORE THE DATE OF REGISTRATION;**

16 3. **BEGINNING JANUARY 1, 2023, FOR A VEHICLE**  
17 **MANUFACTURED AT LEAST 18 YEARS BEFORE THE DATE OF REGISTRATION;**

18 4. **BEGINNING JANUARY 1, 2024, FOR A VEHICLE**  
19 **MANUFACTURED AT LEAST 17 YEARS BEFORE THE DATE OF REGISTRATION;**

20 5. **BEGINNING JANUARY 1, 2025, FOR A VEHICLE**  
21 **MANUFACTURED AT LEAST 16 YEARS BEFORE THE DATE OF REGISTRATION;**

22 6. **BEGINNING JANUARY 1, 2026, FOR A VEHICLE**  
23 **MANUFACTURED AT LEAST 15 YEARS BEFORE THE DATE OF REGISTRATION;**

24 7. **BEGINNING JANUARY 1, 2027, FOR A VEHICLE**  
25 **MANUFACTURED AT LEAST 14 YEARS BEFORE THE DATE OF REGISTRATION;**

26 8. **BEGINNING JANUARY 1, 2028, FOR A VEHICLE**  
27 **MANUFACTURED AT LEAST 13 YEARS BEFORE THE DATE OF REGISTRATION;**

28 9. **BEGINNING JANUARY 1, 2029, FOR A VEHICLE**  
29 **MANUFACTURED AT LEAST 12 YEARS BEFORE THE DATE OF REGISTRATION;**

30 10. **BEGINNING JANUARY 1, 2030, FOR A VEHICLE**  
31 **MANUFACTURED AT LEAST 11 YEARS BEFORE THE DATE OF REGISTRATION;**

1           **11. BEGINNING JANUARY 1, 2031, FOR A VEHICLE**  
2 **MANUFACTURED AT LEAST 10 YEARS BEFORE THE DATE OF REGISTRATION;**

3           **12. BEGINNING JANUARY 1, 2032, FOR A VEHICLE**  
4 **MANUFACTURED AT LEAST 9 YEARS BEFORE THE DATE OF REGISTRATION;**

5           **13. BEGINNING JANUARY 1, 2033, FOR A VEHICLE**  
6 **MANUFACTURED AT LEAST 8 YEARS BEFORE THE DATE OF REGISTRATION;**

7           **14. BEGINNING JANUARY 1, 2034, FOR A VEHICLE**  
8 **MANUFACTURED AT LEAST 7 YEARS BEFORE THE DATE OF REGISTRATION;**

9           **15. BEGINNING JANUARY 1, 2035, FOR A VEHICLE**  
10 **MANUFACTURED AT LEAST 6 YEARS BEFORE THE DATE OF REGISTRATION;**

11           **16. BEGINNING JANUARY 1, 2036, FOR A VEHICLE**  
12 **MANUFACTURED AT LEAST 5 YEARS BEFORE THE DATE OF REGISTRATION;**

13           **17. BEGINNING JANUARY 1, 2037, FOR A VEHICLE**  
14 **MANUFACTURED AT LEAST 4 YEARS BEFORE THE DATE OF REGISTRATION;**

15           **18. BEGINNING JANUARY 1, 2038, FOR A VEHICLE**  
16 **MANUFACTURED AT LEAST 3 YEARS BEFORE THE DATE OF REGISTRATION;**

17           **19. BEGINNING JANUARY 1, 2039, FOR A VEHICLE**  
18 **MANUFACTURED AT LEAST 2 YEARS BEFORE THE DATE OF REGISTRATION;**

19           **20. BEGINNING JANUARY 1, 2040, FOR A VEHICLE**  
20 **MANUFACTURED AT LEAST 1 YEAR BEFORE THE DATE OF REGISTRATION; AND**

21           **21. BEGINNING JANUARY 1, 2041, FOR ANY CLASS A**  
22 **(PASSENGER) VEHICLE OR CLASS D (MOTORCYCLE) VEHICLE.**

23           **(3) ANY METHOD AUTHORIZED BY THE ADMINISTRATION FOR**  
24 **OBTAINING OR RENEWING A VEHICLE REGISTRATION SHALL BE MADE AVAILABLE**  
25 **FOR CLASS A (PASSENGER) VEHICLE OR CLASS D (MOTORCYCLE) VEHICLE**  
26 **REGISTRATIONS FOR 1- AND 2-YEAR PERIODS UNDER PARAGRAPH (2) OF THIS**  
27 **SUBSECTION.**

28           (b) Vehicle registration plates or validation tabs shall be issued and displayed in  
29 accordance with a schedule established by the Administrator.

30           (c) The fee for a multiyear registration is the same as the annual registration fee

1 established under this title multiplied by the number of years for which the registration is  
2 issued.

3 (d) The Administration shall refund the registration fees upon surrender of the  
4 registration card and registration plates if the return is made before the beginning of any  
5 12-month registration year for which the application for refund is made.

6 (e) The Administration may adopt regulations to carry out the provisions of this  
7 section.

9 (A) **THE ADMINISTRATION MAY CHARGE A LATE FEE NOT EXCEEDING \$25**  
10 **FOR THE RENEWAL OF A REGISTRATION THAT OCCURS MORE THAN 1 WEEK AFTER**  
11 **THE REGISTRATION HAS EXPIRED.**

12 (B) **FROM THE LATE FEE COLLECTED UNDER SUBSECTION (A) OF THIS**  
13 **SECTION, \$6.25 SHALL BE PAID INTO THE MARYLAND TRAUMA PHYSICIAN**  
14 **SERVICES FUND ESTABLISHED UNDER § 19-130 OF THE HEALTH - GENERAL**  
15 **ARTICLE.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
17 1, 2020.
