A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Board of Education – Compensation**

3 FOR the purpose of altering the amount of annual compensation of the president and other
4 voting members of the Frederick County Board of Education beginning with the
5 commencement of a certain term of office; and generally relating to the Frederick
6 County Board of Education.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Education**

15 3–5B–03.

16 (a) (1) [The] **UNTIL THE ELECTION OF MEMBERS OF THE FREDERICK**
17 **COUNTY BOARD AT THE GENERAL ELECTION OF 2022 AND THE COMMENCEMENT OF**
18 **THEIR TERMS ON DECEMBER 6, 2022, FOLLOWING THAT ELECTION, THE** president of
19 the [Frederick County Board] **COUNTY BOARD** is entitled to receive \$11,000 annually as
20 compensation, and each other voting member of the [Frederick County Board] **COUNTY**
21 **BOARD** is entitled to receive \$10,000 annually as compensation.

22 (2) **AFTER THE ELECTION OF MEMBERS OF THE COUNTY BOARD AT**
23 **THE GENERAL ELECTION OF 2022 AND ON THE COMMENCEMENT OF THEIR TERMS**
24 **ON DECEMBER 6, 2022, FOLLOWING THE ELECTION, THE PRESIDENT OF THE**

1 COUNTY BOARD IS ENTITLED TO RECEIVE **\$15,000** ANNUALLY AS COMPENSATION,
2 AND EACH OTHER VOTING MEMBER OF THE COUNTY BOARD IS ENTITLED TO
3 RECEIVE **\$14,000** ANNUALLY AS COMPENSATION.

4 (b) The president and all other members of the Frederick County Board are
5 entitled to health insurance benefits regularly provided to employees of the Frederick
6 County public school system.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
8 1, 2020.
