1 AN ACT concerning

2 **Montgomery County – Board of Education – Compensation**

3 **MC 13–20**

4 FOR the purpose of altering the compensation of the members of the Montgomery County
5 Board of Education; authorizing a student member to elect to receive certain
6 compensation at a certain time; providing for the application of this Act; and
7 generally relating to the compensation of the members of the Montgomery County
8 Board of Education.

9 BY repealing and reenacting, with amendments,

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Education**

17 3–902.

18 (a) An elected member of the county board is entitled to reimbursement for travel
19 and other expenses as provided by the Montgomery County Council.

1 (b) (1) An elected member of the county board is entitled to receive[:

2 (i) \$25,000 annually as compensation; or]

3 **ANNUALLY AS COMPENSATION:**

4 (I) 1. **\$25,000, ENDING ON NOVEMBER 30, 2020;**

5 2. **\$30,000, BEGINNING ON DECEMBER 1, 2020; AND**

6 3. **\$35,000, BEGINNING ON DECEMBER 1, 2022; OR**

7 (ii) An annual salary set through legislation based on the
8 recommendations of the Montgomery County Board of Education Compensation
9 Commission in accordance with Title 28, Subtitle 1A of the Local Government Article.

10 (2) The president of the county board is entitled to receive[:

11 (i) 29,000 annually as compensation; or] **ANNUALLY AS**
12 **COMPENSATION:**

13 (I) 1. **\$29,000, ENDING ON NOVEMBER 30, 2020;**

14 2. **\$34,000, BEGINNING ON DECEMBER 1, 2020; AND**

15 3. **\$39,000, BEGINNING ON DECEMBER 1, 2022; OR**

16 (ii) An annual salary set through legislation based on the
17 recommendations of the Montgomery County Board of Education Compensation
18 Commission in accordance with Title 28, Subtitle 1A of the Local Government Article.

19 (3) An elected member is entitled to health insurance and to other fringe
20 benefits regularly provided to employees of the board of education under the same terms
21 and conditions extended to other employees of the board of education.

22 (4) **A SALARY INCREASE FOR AN ELECTED MEMBER UNDER THIS**
23 **SUBSECTION SHALL TAKE EFFECT AT THE BEGINNING OF THE TERM OF OFFICE AND**
24 **MAY NOT INCREASE DURING THE TERM OF OFFICE.**

25 (c) (1) The student member [may not receive compensation but, after
26 submitting expense vouchers,] may be reimbursed for out-of-pocket expenses incurred in
27 connection with official duties.

28 (2) **[A] EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS**

1 **SUBSECTION**, A student member who completes a full term on the county board shall [be
2 granted a scholarship of:

3 (i) \$5,000 to be applied toward the student's higher education costs;
4 or] **RECEIVE AS FOLLOWS:**

5 [(ii)] **(I)** A scholarship set through legislation based on the
6 recommendations of the Montgomery County Board of Education Compensation
7 Commission in accordance with Title 28, Subtitle 1A of the Local Government Article; **OR**

8 **(II) 1. THROUGH THE TERM THAT ENDS IN 2021, A**
9 **SCHOLARSHIP OF \$5,000 TO BE APPLIED TOWARD THE STUDENT'S HIGHER**
10 **EDUCATION COSTS;**

11 **2. BEGINNING WITH THE TERM THAT STARTS IN 2021, A**
12 **SCHOLARSHIP OF \$15,000 TO BE APPLIED TOWARD THE STUDENT'S HIGHER**
13 **EDUCATION COSTS AND A ONE-TIME STIPEND OF \$5,000 FOR A TOTAL AMOUNT OF**
14 **\$20,000; AND**

15 **3. BEGINNING WITH THE TERM THAT STARTS IN 2023, A**
16 **SCHOLARSHIP OF \$25,000 TO BE APPLIED TOWARD THE STUDENT'S HIGHER**
17 **EDUCATION COSTS AND A ONE-TIME STIPEND OF \$10,000 FOR A TOTAL AMOUNT OF**
18 **\$35,000.**

19 **(3) BEFORE BEING SWORN IN, THE STUDENT MEMBER MAY ELECT TO**
20 **RECEIVE A CERTAIN PERCENTAGE OF THE TOTAL AMOUNT UNDER PARAGRAPH (2)**
21 **OF THIS SUBSECTION AS A SCHOLARSHIP AND THE REMAINING PERCENTAGE AS A**
22 **STIPEND, PROVIDED THAT THE TOTAL AMOUNT IS NOT RECEIVED SOLELY AS A**
23 **SCHOLARSHIP OR SOLELY AS A STIPEND.**

24 **SECTION 2. AND BE IT FURTHER ENACTED**, That, pursuant to Article III, § 35
25 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary
26 or compensation of the president and members of the Montgomery County Board of
27 Education while serving in a term of office beginning before the effective date of this Act,
28 but the provisions of this Act concerning the salary or compensation of the president and
29 members of the Montgomery County Board of Education shall take effect at the beginning
30 of the next following term of office. This limitation does not apply to an individual appointed
31 or elected after the effective date of this Act to fill out an unexpired term.

32 **SECTION 3. AND BE IT FURTHER ENACTED**, That this Act shall take effect July
33 1, 2020.
