CHAPTER _____

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Municipal Golf Course License**

3 FOR the purpose of establishing a Class M–G beer, wine, and liquor license for use at a
4 municipal golf course in Frederick County; authorizing the Board of License
5 Commissioners for Frederick County to issue the license to a manager of a municipal
6 golf course; specifying that the license authorizes the license holder to sell beer, wine,
7 and liquor for on–premises consumption on certain land and facilities used for golfing
8 purposes; authorizing the license holder to designate an agent for certain purposes;
9 providing that the agent shall be considered to be the vendor for certain purposes;
10 authorizing the Board to transfer a license to a different golf course manager under
11 certain circumstances; specifying the hours and days of sale; specifying a certain
12 annual license fee; requiring the Board to adopt certain regulations; and generally
13 relating to alcoholic beverages licenses in Frederick County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Alcoholic Beverages**

4 20–102.

5 This title applies only in Frederick County.

6 **20–1009.2.**

7 (A) THIS SECTION APPLIES ONLY TO A MUNICIPAL GOLF COURSE THAT IS
8 OPERATED BY A MUNICIPAL GOLF COURSE MANAGER OR A GOLF COURSE MANAGER
9 UNDER A MANAGEMENT AGREEMENT WITH THE CITY OF FREDERICK.

10 (B) THERE IS A CLASS M–G BEER, WINE, AND LIQUOR LICENSE FOR USE AT
11 A MUNICIPAL GOLF COURSE.

12 (C) THE BOARD MAY ISSUE THE LICENSE TO A MANAGER OF A MUNICIPAL
13 GOLF COURSE.

14 (D) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,
15 AND LIQUOR FOR ON–PREMISES CONSUMPTION ON THE LAND AND IN THE
16 FACILITIES USED FOR GOLFING PURPOSES.

17 (E) (1) THE LICENSE HOLDER MAY DESIGNATE AN AGENT TO SELL BEER,
18 WINE, AND LIQUOR AT THE MUNICIPAL GOLF COURSE.

19 (2) THE AGENT SHALL BE CONSIDERED THE VENDOR FOR PURPOSES
20 OF COLLECTING AND REMITTING THE SALES AND USE TAX.

21 (F) ON REQUEST OF THE CITY OF FREDERICK, THE BOARD MAY TRANSFER
22 THE LICENSE TO A DIFFERENT GOLF COURSE MANAGER.

23 (G) THE HOURS OF SALE ARE:

24 (1) ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO ~~2 A.M. THE~~
25 ~~FOLLOWING DAY~~ 10 P.M.; AND

26 (2) ON SUNDAY, FROM 10 A.M. TO ~~2 A.M. THE FOLLOWING DAY~~ 10 P.M.

27 (H) THE ANNUAL LICENSE FEE IS \$600.

28 (I) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
2 1, 2020.
