A BILL ENTITLED

1 AN ACT concerning

2 **Labor and Employment – Use of Facial Recognition Services – Prohibition**

3 FOR the purpose of prohibiting an employer from using certain facial recognition services
4 during an applicant’s interview for employment unless the applicant consents under
5 a certain provision of this Act; authorizing an applicant to consent to the use of
6 certain facial recognition service technologies during an interview by signing a
7 waiver; providing for the contents of a certain waiver; defining certain terms; and
8 generally relating to employer use of facial recognition service technologies during
9 job interviews.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Labor and Employment**

18 **3–717.**

19 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
20 **INDICATED.**

21 **(2) “FACIAL RECOGNITION SERVICE” MEANS TECHNOLOGY THAT**
22 **ANALYZES FACIAL FEATURES AND IS USED FOR RECOGNITION OR PERSISTENT**
23 **TRACKING OF INDIVIDUALS IN STILL OR VIDEO IMAGES.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(3) “FACIAL TEMPLATE” MEANS THE MACHINE-INTERPRETABLE**
2 **PATTERN OF FACIAL FEATURES THAT IS EXTRACTED FROM ONE OR MORE IMAGES**
3 **OF AN INDIVIDUAL BY A FACIAL RECOGNITION SERVICE.**

4 **(B) AN EMPLOYER MAY NOT USE A FACIAL RECOGNITION SERVICE FOR THE**
5 **PURPOSE OF CREATING A FACIAL TEMPLATE DURING AN APPLICANT’S INTERVIEW**
6 **FOR EMPLOYMENT UNLESS AN APPLICANT CONSENTS UNDER SUBSECTION (C) OF**
7 **THIS SECTION.**

8 **(C) (1) AN APPLICANT MAY CONSENT TO THE USE OF FACIAL**
9 **RECOGNITION SERVICE TECHNOLOGY DURING AN INTERVIEW BY SIGNING A WAIVER.**

10 **(2) THE WAIVER SIGNED UNDER PARAGRAPH (1) OF THIS**
11 **SUBSECTION SHALL STATE IN PLAIN LANGUAGE:**

12 **(I) THE APPLICANT’S NAME;**

13 **(II) THE DATE OF THE INTERVIEW;**

14 **(III) THAT THE APPLICANT CONSENTS TO THE USE OF FACIAL**
15 **RECOGNITION DURING THE INTERVIEW; AND**

16 **(IV) WHETHER THE APPLICANT READ THE CONSENT WAIVER.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2020.
