A BILL ENTITLED

1 AN ACT concerning

2 **Clean Cars Act of 2020**

3 FOR the purpose of extending and altering, for certain fiscal years, the Electric Vehicle
4 Recharging Equipment Rebate Program and vehicle excise tax credit for the
5 purchase of certain electric vehicles; increasing, for certain fiscal years, the total
6 amount of electric vehicle recharging equipment rebates that the Maryland Energy
7 Administration may issue; altering the type of vehicle that is eligible for the electric
8 vehicle excise tax credit; repealing a certain limitation on the maximum amount of
9 the electric vehicle excise tax credit; extending and altering, for certain fiscal years,
10 the maximum amount required to be transferred from the Maryland Strategic
11 Energy Investment Fund to the Transportation Trust Fund to offset certain revenue
12 reductions; increasing the total amount of electric vehicle excise tax credits that may
13 be allowed during certain fiscal years; making a stylistic change; and generally
14 relating to electric vehicles.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – State Government**

17 9–2009.

18 (a) (1) In this section the following words have the meanings indicated.

19 (2) “Electric vehicle recharging equipment rebate” means a rebate issued
20 by the Administration under this section for the cost of qualified electric vehicle recharging
21 equipment.

22 (3) “Qualified electric vehicle recharging equipment” means property in the
23 State that is used for recharging motor vehicles propelled by electricity.

24 (4) “Retail service station dealer” has the meaning stated in § 10–101 of
25 the Business Regulation Article.

26 (b) (1) There is an Electric Vehicle Recharging Equipment Rebate Program.

27 (2) The Administration shall administer the Program.

28 (c) (1) For fiscal years [2018 through 2020] **2021 THROUGH 2023**, subject to
29 the provisions of this section, an individual, a business entity, or a unit of State or local
30 government may apply to the Administration for an electric vehicle recharging equipment
31 rebate for the costs of acquiring and installing qualified electric vehicle recharging
32 equipment.

33 (2) For each fiscal year, the total amount of rebates issued by the
34 Administration may not exceed [\$1,200,000] **\$1,800,000**.

1 (3) The Administration may allow an applicant to include reasonable
2 installation costs in the cost of qualified electric vehicle recharging equipment for the
3 purpose of calculating the amount of an electric vehicle recharging equipment rebate.

6 (a) In this section, “excise tax” means the tax imposed under § 13–809 of this
7 subtitle.

8 (b) This section applies only to:

9 (1) A [plug–in electric drive] **ZERO–EMISSION ELECTRIC** vehicle that:

10 (i) Has not been modified from original manufacturer specifications;

11 (ii) Is acquired for use or lease by the taxpayer and not for resale;

12 (iii) Has a total purchase price not exceeding \$63,000;

13 (iv) Has a battery capacity of at least [5.0] **30** kilowatt–hours; and

14 (v) Is purchased new and titled for the first time on or after July 1,
15 2017, but before July 1, [2020] **2023**; and

16 (2) A fuel cell electric vehicle that:

17 (i) Has not been modified from original manufacturer specifications;

18 (ii) Is acquired for use or lease by the taxpayer and not for resale;

19 (iii) Has a total purchase price not exceeding \$63,000; and

20 (iv) Is purchased new and titled for the first time on or after July 1,
21 2017, but before July 1, [2020] **2023**.

22 (c) Subject to available funding, a credit is allowed against the excise tax imposed
23 for a [plug–in electric drive] **ZERO–EMISSION ELECTRIC** vehicle or fuel cell electric
24 vehicle.

25 (d) The credit allowed under this section [may not exceed the lesser of:

26 (1) The amount of excise tax paid for the purchase of the vehicle; or

1 (2)] IS EQUAL TO \$3,000 FOR EACH ELIGIBLE VEHICLE PURCHASED.

2 (e) The credit allowed under this section is limited to the acquisition of:

3 (1) One vehicle per individual; and

4 (2) 10 vehicles per business entity.

5 (f) A credit may not be claimed under this section:

6 (1) For a vehicle unless the vehicle is registered in the State; or

7 (2) Unless the manufacturer has already conformed to any applicable State
8 or federal laws or regulations governing clean-fuel vehicle or electric vehicle purchases
9 applicable during the calendar year in which the vehicle is titled.

10 (g) The [Motor Vehicle] Administration shall administer the credit under this
11 section.

14 SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding any other
15 provision of law, for fiscal [year 2020] **YEARS 2021 THROUGH 2023** the lesser of
16 **[\$6,000,000] \$24,000,000 FOR EACH FISCAL YEAR** or the actual total amount of credits
17 allowed against the excise tax shall be transferred from the Strategic Energy Investment
18 Fund established under § 9–20B–05 of the State Government Article to the Transportation
19 Trust Fund to offset a reduction in revenues from the vehicle excise tax credit for [qualified
20 plug-in electric drive] **ZERO-EMISSION ELECTRIC** vehicles and fuel cell electric vehicles
21 under § 13–815 of the Transportation Article, as enacted by this Act. For fiscal [year 2020]
22 **YEARS 2021 THROUGH 2023**, the total amount of credits allowed against the excise tax
23 may not exceed **[\$6,000,000] \$24,000,000 FOR EACH FISCAL YEAR.**

26 SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding any other
27 provision of law, for fiscal [year 2020] **YEARS 2021 THROUGH 2023** the lesser of
28 **[\$6,000,000] \$24,000,000 FOR EACH FISCAL YEAR** or the actual total amount of credits
29 allowed against the excise tax shall be transferred from the Strategic Energy Investment
30 Fund established under § 9–20B–05 of the State Government Article to the Transportation
31 Trust Fund to offset a reduction in revenues from the vehicle excise tax credit for [qualified
32 plug-in electric drive] **ZERO-EMISSION ELECTRIC** vehicles and fuel cell electric vehicles
33 under § 13–815 of the Transportation Article, as enacted by this Act. For fiscal [year 2020]
34 **YEARS 2021 THROUGH 2023**, the total amount of credits allowed against the excise tax
35 may not exceed **[\$6,000,000] \$24,000,000 FOR EACH FISCAL YEAR.**

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
2 1, 2020.
