A BILL ENTITLED

1 AN ACT concerning

2 **Correctional Officers' Retirement System – Membership**

3 FOR the purpose of altering the membership of the Correctional Officers' Retirement
4 System to include certain individuals serving in certain positions in the Department
5 of Juvenile Services; providing for the calculation of a certain benefit from the
6 Correctional Officers' Retirement System for individuals serving in certain positions
7 on or before a certain date; requiring the State Retirement Agency, on or before a
8 certain date, to notify certain individuals affected by this Act of their right to transfer
9 service credit to the Correctional Officers' Retirement System; providing for the
10 application of this Act; requiring a certain transfer and combination of certain
11 service credit for certain individuals; requiring the Board of Trustees for the State
12 Retirement and Pension System to calculate a certain disability benefit for certain
13 individuals and to grant a certain benefit under certain circumstances; and generally
14 relating to membership in the Correctional Officers' Retirement System.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
26 That the Laws of Maryland read as follows:

27 **Article – State Personnel and Pensions**

2 (a) Except as provided in subsection (b) of this section, this subtitle applies only
3 to:

4 (10) an individual serving as a Department of Juvenile Services employee
5 in one of the following positions on or after July 1, 2018:

6 (i) a community detention officer or community detention
7 supervisor;

8 (ii) a youth transportation officer, youth transportation officer lead,
9 youth transportation officer supervisor, or youth transportation officer trainee;

10 (iii) a resident advisor, resident advisor lead, resident advisor
11 supervisor, or resident advisor trainee; or

12 (iv) a youth recreation specialist; [and]

13 (11) an individual serving as a Department of Public Safety and
14 Correctional Services employee in one of the following positions on or after July 1, 2018:

15 (i) a parole and probation assistant regional administrator;

16 (ii) a psychology services chief;

17 (iii) a correctional maintenance officer supervisor;

18 (iv) a correctional maintenance officer manager;

19 (v) a correctional maintenance services officer;

20 (vi) a correctional maintenance services supervisor; or

21 (vii) a correctional maintenance services manager; AND

22 **(12) AN INDIVIDUAL SERVING AS A DEPARTMENT OF JUVENILE**
23 **SERVICES EMPLOYEE IN ONE OF THE FOLLOWING POSITIONS ON OR AFTER JULY 1,**
24 **2020:**

25 **(I) CASE MANAGEMENT SPECIALIST I;**

26 **(II) CASE MANAGEMENT SPECIALIST II;**

27 **(III) CASE MANAGEMENT SPECIALIST III; OR**

1 (IV) CASE MANAGEMENT SPECIALIST SUPERVISOR.

2 25-401.

3 (a) A member may retire with a normal service retirement allowance if:

4 (1) on or before the date of retirement, the member:

5 (i) has at least 20 years of eligibility service;

6 (ii) 1. is a correctional case management specialist, supervisor,
7 or manager on or before June 30, 2016;

8 2. is vested in the Correctional Officers' Retirement System;
9 and

10 3. has a combined total of at least 20 years of eligibility
11 service from:

12 A. the Correctional Officers' Retirement System and the
13 Employees' Retirement System; or

14 B. the Correctional Officers' Retirement System and the
15 Employees' Pension System;

16 (iii) 1. is serving in a position specified in:

17 A. § 25-201(a)(8) or (9) of this title on or before June 30, 2017;

18 [or]

19 B. § 25-201(a)(10) or (11) of this title on or before June 30,
20 2018; OR

21 C. **§ 25-201(A)(12) OF THIS TITLE ON OR BEFORE JUNE**
22 **30, 2020;**

23 2. is vested in the Correctional Officers' Retirement System;
24 and

25 3. has a combined total of at least 20 years of eligibility
26 service from:

27 A. the Correctional Officers' Retirement System and the
28 Employees' Retirement System; or

1 B. the Correctional Officers' Retirement System and the
2 Employees' Pension System; or

3 (iv) is at least 55 years old and has:

4 1. at least 5 years of eligibility service credit, if the member
5 is a member on or before June 30, 2011; or

6 2. at least 10 years of eligibility service credit, if the member
7 becomes a member on or after July 1, 2011; and

8 (2) the member completes and submits a written application to the Board
9 of Trustees stating the date when the member desires to retire.

10 (b) On retirement under this section, a member is entitled to receive a normal
11 service retirement allowance that equals one fifty-fifth of the member's average final
12 compensation multiplied by the number of years of creditable service.

13 (c) (1) This subsection applies only to:

14 (i) a correctional case management specialist, supervisor, or
15 manager who has a combined total of 20 years of eligibility service as provided in subsection
16 (a)(1)(ii) of this section; or

17 (ii) a member serving in a position specified in § 25-201(a)(8), (9),
18 (10), [or] (11), **OR (12)** of this title who has a combined total of 20 years of eligibility service
19 as provided in subsection (a)(1)(iii) of this section.

20 (2) A member is entitled to receive a normal service retirement allowance
21 that equals an allowance based on the creditable service the member has in the
22 Correctional Officers' Retirement System.

23 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before January 1, 2021,
24 the State Retirement Agency shall notify the individuals who are affected by this Act of
25 their right to transfer service credit from the Employees' Retirement System or the
26 Employees' Pension System to the Correctional Officers' Retirement System.

27 SECTION 3. AND BE IT FURTHER ENACTED, That § 37-203(f)(3) of the State
28 Personnel and Pensions Article does not apply to an individual who transfers service credit
29 to the Correctional Officers' Retirement System under Title 37 of the State Personnel and
30 Pensions Article in accordance with this Act.

31 SECTION 4. AND BE IT FURTHER ENACTED, That:

32 (a) This section applies to an individual who:

33 (1) is employed in a position affected by this Act on July 1, 2020; and

1 (2) has no creditable service in the Employees' Pension System before July
2 1, 2008.

3 (b) An individual described under subsection (a) of this section shall have the
4 individual's service credit from the Employees' Pension System transferred and combined
5 with the individual's service in the Correctional Officers' Retirement System.

6 (c) If an individual described under subsection (a) of this section is granted an
7 ordinary disability benefit under Title 29, Subtitle 1 of the State Personnel and Pensions
8 Article, the Board of Trustees for the State Retirement and Pension System shall calculate
9 the ordinary disability benefit under §§ 29–106 and 29–108 of the State Personnel and
10 Pensions Article and grant the individual the greater benefit.

11 SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect July
12 1, 2020.
