2 **Correctional Institutions – Correctional Education Council – Mandatory**
3 **Education Program Requirements**

4 FOR the purpose of altering the minimum number of calendar days that the Correctional
5 Education Council must require certain inmates in correctional institutions to
6 participate in a certain mandatory education program; and generally relating to the
7 mandatory education program for inmates in correctional institutions.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Labor and Employment**

2 (a) (1) The Correctional Education Council shall develop and recommend an
3 educational and workforce training program for each correctional institution in the Division
4 of Correction.

5 (b) (1) The Council shall adopt regulations for all correctional institutions in
6 the Division of Correction for the implementation of a mandatory education program for all
7 inmates who fail to attain a minimum educational standard as set forth in this subsection.

8 (2) The regulations adopted by the Council shall:

9 (i) require that the educational standard shall be the attainment of
10 a General Educational Development (GED) diploma or a verified high school diploma;

11 (ii) apply only to any inmate who:

12 1. was received by the Division of Correction after July 1,
13 1987;

14 2. has 18 months or more remaining to be served before a
15 mandatory supervision release date;

16 3. is not exempted due to a medical, developmental, or
17 learning disability; and

18 4. does not possess a General Educational Development
19 (GED) diploma or a verified high school diploma; and

20 (iii) require any inmate who is not exempted under item (ii)3 of this
21 paragraph to participate in:

22 1. the mandatory education program for at least **[120] 240**
23 calendar days; or

24 2. a workforce skills training program.

25 (3) The Division of Correction shall report to the Parole Commission the
26 academic progress of an inmate in the mandatory education program.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
28 October 1, 2020.
