A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Barbershop and Beauty Salon**
3 **License**

4 FOR the purpose of establishing a barbershop and beauty salon beer and wine license in
5 Anne Arundel County; specifying the individuals who are qualified to hold the
6 license; authorizing a license holder to serve a certain amount of beer or wine by the
7 glass to a customer for on–premises consumption under certain circumstances;
8 specifying the hours during which a license holder is authorized to serve beer and
9 wine; stating that a license holder need not obtain a certain Sunday license;
10 establishing an annual license fee; and generally relating to alcoholic beverages in
11 Anne Arundel County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That Section(s) 11–1002 of Article – Alcoholic Beverages of the Annotated Code of Maryland
3 be renumbered to be Section(s) 11–1002.1.

4 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
5 as follows:

6 **Article – Alcoholic Beverages**

7 11–102.

8 This title applies only in Anne Arundel County.

9 **11–1002.**

10 (A) **THERE IS A BARBERSHOP AND BEAUTY SALON BEER AND WINE LICENSE.**

11 (B) **THE BOARD MAY ISSUE THE LICENSE TO A HOLDER OF:**

12 (1) **A BARBERSHOP PERMIT ISSUED UNDER § 4–501 OF THE BUSINESS**
13 **OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

14 (2) **A BEAUTY SALON PERMIT ISSUED UNDER § 5–501 OF THE**
15 **BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE.**

16 (C) **THE LICENSE AUTHORIZES THE LICENSE HOLDER TO PROVIDE NOT**
17 **MORE THAN 5 OUNCES OF BEER OR WINE BY THE GLASS FOR ON–PREMISES**
18 **CONSUMPTION BY A BARBERSHOP OR BEAUTY SALON CUSTOMER:**

19 (1) **WHEN THE CUSTOMER IS BEING PROVIDED:**

20 (I) **A BARBERING SERVICE UNDER TITLE 4 OF THE BUSINESS**
21 **OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

22 (II) **A COSMETOLOGY SERVICE UNDER TITLE 5 OF THE**
23 **BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

24 (2) **WHILE THE CUSTOMER IS ATTENDING A FUND–RAISING EVENT AT**
25 **THE BARBERSHOP OR BEAUTY SALON.**

26 (D) **A LICENSE HOLDER MAY SERVE BEER AND WINE FOR ON–PREMISES**
27 **CONSUMPTION DURING NORMAL BUSINESS HOURS BUT NOT LATER THAN 9 P.M.**

28 (E) **A LICENSE HOLDER NEED NOT OBTAIN A SUNDAY LICENSE UNDER**

1 § 11-2004 OF THIS TITLE TO PROVIDE BEER AND WINE ON SUNDAY.

2 (F) THE ANNUAL LICENSE FEE IS \$100.

3 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
4 1, 2020.
