1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Barbershop and Beauty Salon**
3 **License**

4 FOR the purpose of establishing a barbershop and beauty salon beer and wine license in
5 Anne Arundel County; specifying the individuals who are qualified to hold the
6 license; authorizing a license holder to serve a certain amount of beer or wine by the
7 glass to a customer for on–premises consumption under certain circumstances;
8 specifying the hours during which a license holder is authorized to serve beer and
9 wine; stating that a license holder need not obtain a certain Sunday license;
10 establishing an annual license fee; and generally relating to alcoholic beverages in
11 Anne Arundel County.

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 7 That Section(s) 11–1002 of Article – Alcoholic Beverages of the Annotated Code of Maryland
 8 be renumbered to be Section(s) 11–1002.1.

9 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
 10 as follows:

11 **Article – Alcoholic Beverages**

12 11–102.

13 This title applies only in Anne Arundel County.

14 **11–1002.**

15 **(A) THERE IS A BARBERSHOP AND BEAUTY SALON BEER AND WINE LICENSE.**

16 **(B) THE BOARD MAY ISSUE THE LICENSE TO A HOLDER OF:**

17 **(1) A BARBERSHOP PERMIT ISSUED UNDER § 4–501 OF THE BUSINESS**
 18 **OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

19 **(2) A BEAUTY SALON PERMIT ISSUED UNDER § 5–501 OF THE**
 20 **BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE.**

21 **(C) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO PROVIDE NOT**
 22 **MORE THAN 12 OUNCES OF BEER OR 5 OUNCES OF BEER OR WINE BY THE GLASS FOR**
 23 **ON–PREMISES CONSUMPTION BY A BARBERSHOP OR BEAUTY SALON CUSTOMER:**

24 **(1) WHEN THE CUSTOMER IS BEING PROVIDED:**

25 **(I) A BARBERING SERVICE UNDER TITLE 4 OF THE BUSINESS**
 26 **OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

27 **(II) A COSMETOLOGY SERVICE UNDER TITLE 5 OF THE**
 28 **BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

29 **(2) WHILE THE CUSTOMER IS ATTENDING A FUND–RAISING EVENT AT**
 30 **THE BARBERSHOP OR BEAUTY SALON.**

1 **(D) A LICENSE HOLDER MAY SERVE BEER AND WINE FOR ON-PREMISES**
2 **CONSUMPTION DURING NORMAL BUSINESS HOURS BUT NOT LATER THAN 9 P.M.**

3 **(E) A LICENSE HOLDER NEED NOT OBTAIN A SUNDAY LICENSE UNDER**
4 **§ 11-2004 OF THIS TITLE TO PROVIDE BEER AND WINE ON SUNDAY.**

5 **(F) THE ANNUAL LICENSE FEE IS \$100.**

6 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
7 1, 2020.
