## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Assisted Living Program License**

3 FOR the purpose of establishing an assisted living program beer, wine, and liquor license  
4 in Harford County; authorizing the Board of License Commissioners for Harford  
5 County to issue the license to a manager of a certain assisted living program; limiting  
6 the number of licenses the Board may issue to a person; authorizing the license  
7 holder to provide beer and wine for on–premises consumption by a resident or guest  
8 of a resident; authorizing the license holder to store liquor, prepare mixed drinks,  
9 and serve liquor or mixed drinks under certain circumstances; specifying the hours  
10 the license holder may provide or serve alcoholic beverages; requiring the license  
11 holder to require certain individuals to have completed certain alcohol awareness  
12 training; authorizing an employee of the assisted living program who is at least a  
13 certain age to serve alcoholic beverages or assist in preparing mixed drinks;  
14 specifying the license fee; requiring the license to be applied for by and issued to the  
15 manager of an assisted living program; exempting an applicant for the license from  
16 certain pecuniary interest requirements; providing that certain distance  
17 requirements do not apply to the issuance of the license; providing for the  
18 termination of this Act; defining a certain term; and generally relating to alcoholic  
19 beverages licenses in Harford County.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
23 That Section(s) 22–1001 of Article – Alcoholic Beverages of the Annotated Code of Maryland  
24 be renumbered to be Section(s) 22–1001.1.

25 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
26 as follows:

27 **Article – Alcoholic Beverages**

28 22–102.

29 This title applies only in Harford County.

30 **22–1001.**

31 **(A) IN THIS SECTION, “ASSISTED LIVING PROGRAM” HAS THE MEANING**  
32 **STATED IN § 19–1801 OF THE HEALTH – GENERAL ARTICLE.**

33 **(B) THERE IS A CLASS ALP (ASSISTED LIVING PROGRAM) BEER, WINE, AND**  
34 **LIQUOR LICENSE.**

1 (C) (1) THE BOARD MAY ISSUE THE LICENSE TO A MANAGER OF AN  
2 ASSISTED LIVING PROGRAM THAT:

3 (I) IS LICENSED BY THE DEPARTMENT OF HUMAN SERVICES  
4 UNDER § 19-1804.1 OF THE HEALTH – GENERAL ARTICLE; AND

5 (II) MAY BE OPERATED UNDER A MANAGEMENT AGREEMENT.

6 (2) THE BOARD MAY ISSUE A MAXIMUM OF FIVE CLASS ALP  
7 LICENSES TO A PERSON.

8 (D) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO:

9 (1) PROVIDE BEER AND WINE FOR ON-PREMISES CONSUMPTION BY A  
10 RESIDENT OR A GUEST OF A RESIDENT OF THE ASSISTED LIVING PROGRAM; AND

11 (2) (I) STORE LIQUOR THAT HAS BEEN PURCHASED BY A RESIDENT  
12 IN A SECURE LOCKER THAT IS ACCESSIBLE ONLY TO INDIVIDUALS AT LEAST 21  
13 YEARS OLD;

14 (II) PREPARE MIXED DRINKS USING LIQUOR THAT HAS BEEN  
15 PURCHASED BY A RESIDENT AND MIXERS PROVIDED BY THE RESIDENT OR LICENSE  
16 HOLDER; AND

17 (III) SERVE LIQUOR THAT HAS BEEN PURCHASED BY A  
18 RESIDENT, OR A MIXED DRINK THAT IS PREPARED USING A RESIDENT'S LIQUOR, TO  
19 A RESIDENT OR GUEST OF A RESIDENT FOR ON-PREMISES CONSUMPTION.

20 (E) THE LICENSE HOLDER MAY PROVIDE OR SERVE BEER, WINE, AND  
21 LIQUOR FOR ON-PREMISES CONSUMPTION ON MONDAY THROUGH SUNDAY, FROM ~~8~~  
22 ~~A.M. TO 2 A.M. THE FOLLOWING DAY~~ 4 P.M. TO 9 P.M.

23 (F) (1) THE LICENSE HOLDER SHALL REQUIRE EACH INDIVIDUAL WHO  
24 SERVES BEER, WINE, OR LIQUOR ON THE PREMISES TO HOLD A CERTIFICATE OF  
25 COMPLETION FROM AN APPROVED ALCOHOL AWARENESS PROGRAM AS DESCRIBED  
26 IN § 4-505 OF THIS ARTICLE.

27 (2) AN EMPLOYEE OF THE ASSISTED LIVING PROGRAM WHO IS AT  
28 LEAST 18 YEARS OLD MAY SERVE ALCOHOLIC BEVERAGES OR ASSIST IN PREPARING  
29 MIXED DRINKS.

30 (G) THE ANNUAL LICENSE FEE IS \$5,000.

31 22-1405.

1           (a)   (1)   **[A] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, A**  
2 license for the use of a corporation, an unincorporated entity, or a limited liability company  
3 shall be applied for by and issued to, as individuals:

4                   (i)   three officers holding a financial interest in the corporation; or

5                   (ii) three authorized persons holding a financial interest in the  
6 limited liability company.

7           (2)   One of the three individual applicants who apply for a license shall be  
8 a resident of the county.

9           (3)   The license shall be in effect so long as the resident applicant remains  
10 a resident of the county.

11          (4)   For a license issued after July 1, 1984, the resident applicant:

12                   (i)   1.   for a Class A beer and wine license or a Class A-1 or Class  
13 A-2 beer, wine, and liquor license, shall own at least 25% of the total corporation,  
14 unincorporated entity, or limited liability company;

15                           2.   for any type of license other than one specified in item 1 or  
16 3 of this item, shall own at least 10% of the total corporation, unincorporated entity, or  
17 limited liability company; or

18                           3.   for a Class C-1, Class C-2, or Class C-3 license, may own  
19 any amount or no amount of the total corporation, unincorporated entity, or limited liability  
20 company;

21                   (ii) shall serve as manager or supervisor; and

22                   (iii) shall be physically present on the premises for a substantial  
23 amount of time on a daily basis.

24          (5)   An application for a license shall:

25                   (i)   state the name and address of:

26                           1.   the corporation or unincorporated entity and each officer  
27 who holds a financial interest in the corporation or unincorporated entity; or

28                           2.   the limited liability company and each authorized person  
29 who holds a financial interest in the limited liability company; and

30                   (ii) be signed by:

1                   1.     the president or vice president of a corporation or an  
2     unincorporated entity and the three officers to whom the license is issued; or

3                   2.     the three authorized persons of a limited liability company  
4     to whom the license is issued.

5                   (6)    If there are fewer than three officers or directors of a corporation or an  
6     unincorporated entity or fewer than three authorized persons of a limited liability company,  
7     each officer, director, or authorized person holding a financial interest in the corporation,  
8     unincorporated entity, or limited liability company shall apply for the license.

9                   (7)    If a close corporation does not have officers or directors, one or more  
10    resident stockholders who own more than 50% of the stock together may apply for the  
11    license.

12                   **(C) (1) A CLASS ALP (ASSISTED LIVING PROGRAM) BEER, WINE, AND**  
13    **LIQUOR LICENSE SHALL BE APPLIED FOR BY AND ISSUED TO THE MANAGER OF THE**  
14    **ASSISTED LIVING PROGRAM.**

15                   **(2) THE PECUNIARY INTEREST REQUIREMENTS ESTABLISHED UNDER**  
16    **SUBSECTION (A) OF THIS SECTION, INCLUDING STOCK OWNERSHIP AND LIMITED**  
17    **LIABILITY COMPANY MEMBERSHIP INTERESTS, DO NOT APPLY TO AN APPLICANT**  
18    **FOR A CLASS ALP (ASSISTED LIVING PROGRAM) BEER, WINE, AND LIQUOR LICENSE.**

19    22-1602.

20                   (a)    This section does not apply to:

21                   (1)    a license in effect on July 1, 1975, or the issuance or transfer of a Class  
22    B (on-sale) beer, wine, and liquor license for use on any premises licensed on July 1, 1975;

23                   (2)    a license in effect on July 1, 1977;

24                   (3)    the renewal, transfer, or upgrading of a license, unless the license is  
25    transferred to a new location; and

26                   (4)    the issuance of:

27                   (i)    a 1-day license that is to be used on the premises of a place of  
28    worship or school;

29                   (ii)   a Class GC (golf course) license; [and]

30                   (iii)  a Class CCFA (continuing care facility) license; AND

31                   **(IV) A CLASS ALP (ASSISTED LIVING PROGRAM) LICENSE.**

1 (b) (1) (i) Except as provided in paragraph (2) of this subsection, the Board  
2 may not issue a license for an establishment that is within 300 feet of a place of worship.

3 (ii) The distance from the establishment to the place of worship is to  
4 be measured from the nearest point of the building of the establishment to the nearest point  
5 of the building of the place of worship.

6 (2) Paragraph (1) of this subsection does not apply to the issuance of:

7 (i) a 1-day license for use in a building;

8 (ii) a license issued to a hotel, motel, restaurant, club, or caterer in  
9 a municipality; and

10 (iii) a Class H beer, wine, and liquor license issued to a caterer for  
11 use in a banquet facility in an establishment if:

12 1. the construction of the establishment was completed after  
13 July 1, 1991; and

14 2. the establishment is used for emergency operations by a  
15 volunteer fire company.

16 (c) (1) (i) Except as provided in paragraph (2) of this subsection, the Board  
17 may not issue a license to a business establishment that is within 1,000 feet of a public or  
18 private school building.

19 (ii) The distance from the establishment to the public or private  
20 school is to be measured from the nearest point of the building of the establishment to the  
21 nearest point of the building of the school.

22 (2) The Board may issue a license to a business establishment in Harford  
23 County and in a municipality in Harford County if the business establishment is not located  
24 within 300 feet of a public or private school.

25 (3) A decision of the County Board of Education to locate a public school  
26 building within 1,000 feet of the premises of a license holder may not be the basis to revoke  
27 or deny the renewal, transfer, or upgrading of the license.

28 **Article – Health – General**

29 19–1801.

30 In this subtitle:

1 (1) “Assisted living program” means a residential or facility-based  
2 program that provides housing and supportive services, supervision, personalized  
3 assistance, health-related services, or a combination thereof that meets the needs of  
4 individuals who are unable to perform or who need assistance in performing the activities  
5 of daily living or instrumental activities of daily living in a way that promotes optimum  
6 dignity and independence for the individuals.

7 (2) “Assisted living program” does not include:

8 (i) A nursing home, as defined under § 19–1401 of this title;

9 (ii) A State facility, as defined under § 10–101 of this article;

10 (iii) A program licensed by the Department under Title 7 or Title 10  
11 of this article;

12 (iv) A hospice care program regulated by the Department under  
13 Subtitle 9 of this title;

14 (v) Services provided by family members;

15 (vi) Services provided in an individual’s own home; or

16 (vii) A program certified by the Department of Human Services under  
17 Title 6, Subtitle 5, Part II of the Human Services Article as a certified Adult Residential  
18 Environment Program.

19 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
20 1, 2020. It shall remain effective for a period of 3 years and, at the end of June 30, 2023,  
21 this Act, with no further action required by the General Assembly, shall be abrogated and  
22 of no further force and effect.
