1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Class MT (Movie Theater) License**

3 FOR the purpose of authorizing the Board of License Commissioners for Harford County to
4 grant up to a certain number of Class MT (movie theater) licenses to the same person;
5 increasing the fee for a certain license; and generally relating to alcoholic beverages
6 in Harford County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages**

20 22–102.

3 (a) There is a Class MT (movie theater) beer, wine, and liquor license.

4 (b) (1) The Board may issue the license for use by the owner of a movie theater.

5 (2) To be eligible for the license, the owner of a movie theater is required
6 to provide documentation to the Board that the owner has made an investment of at least
7 \$250,000 in the movie theater.

8 **(3) THE BOARD MAY ISSUE NOT MORE THAN FIVE CLASS MT**
9 **LICENSES TO THE SAME PERSON.**

10 (c) (1) The license holder may sell beer, wine, and liquor for on-premises
11 consumption from 4 p.m. to midnight on the days that the movie theater is open.

12 (2) Beer, wine, and liquor may be sold only:

13 (i) in single-serve containers; and

14 (ii) from a counter separate from a counter serving candy, popcorn,
15 and nonalcoholic beverages.

16 (3) A movie theater for which the license is issued:

17 (i) is subject to the alcohol awareness training requirements under
18 § 4-505 of this article; and

19 (ii) shall offer for sale food other than candy and popcorn.

20 (d) The annual license fee is [~~\$500~~] **\$1,000**.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
22 1, 2020.
