A BILL ENTITLED

1 AN ACT concerning

2 **Consumer Protection – Security Features for Connected Devices**

3 FOR the purpose of requiring the manufacturer of a connected device to equip the device
4 with a certain reasonable security feature; providing that a security feature for a
5 connected device is reasonable if the connected device is equipped with a certain
6 means for authentication; providing that a violation of this Act is an unfair, abusive,
7 or deceptive trade practice within the meaning of the Maryland Consumer Protection
8 Act and is subject to certain enforcement and penalty provisions; providing for the
9 construction of certain provisions of this Act; defining certain terms; providing for a
10 delayed effective date; and generally relating to security features for connected
11 devices.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That Section(s) 13–301(14)(xxiii) through (xxxiii), respectively, of Article – Commercial
3 Law of the Annotated Code of Maryland be renumbered to be Section(s) 13–301(14)(xxiv)
4 through (xxxiv), respectively.

5 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
6 as follows:

7 **Article – Commercial Law**

8 13–301.

9 Unfair, abusive, or deceptive trade practices include any:

10 (14) Violation of a provision of:

11 **(XXIII) TITLE 14, SUBTITLE 42 OF THIS ARTICLE, SECURITY**
12 **FEATURES FOR CONNECTED DEVICES;**

13 **SUBTITLE 42. SECURITY FEATURES FOR CONNECTED DEVICES.**

14 **14–4201.**

15 **(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS**
16 **INDICATED.**

17 **(B) “AUTHENTICATION” MEANS A METHOD OF VERIFYING THE AUTHORITY**
18 **OF A USER, PROCESS, OR CONNECTED DEVICE TO OBTAIN ACCESS TO RESOURCES**
19 **THROUGH AN INFORMATION SYSTEM.**

20 **(C) “CONNECTED DEVICE” MEANS A PHYSICAL OBJECT THAT IS:**

21 **(1) CAPABLE OF CONNECTING TO THE INTERNET, DIRECTLY OR**
22 **INDIRECTLY; AND**

23 **(2) ASSIGNED AN INTERNET PROTOCOL ADDRESS OR A BLUETOOTH**
24 **ADDRESS.**

25 **(D) (1) “MANUFACTURER” MEANS A PERSON WHO:**

26 **(I) MANUFACTURES OR ASSEMBLES A NEW CONNECTED**
27 **DEVICE FOR SALE OR DISTRIBUTION; OR**

28 **(II) CONTRACTS WITH ANOTHER PERSON TO MANUFACTURE OR**

1 ASSEMBLE A CONNECTED DEVICE ON THAT PERSON'S BEHALF.

2 (2) "MANUFACTURER" DOES NOT INCLUDE A PERSON WHO
3 CONTRACTS WITH ANOTHER PERSON TO PURCHASE AND BRAND A CONNECTED
4 DEVICE.

5 (E) "SECURITY FEATURE" MEANS AN ATTRIBUTE OF HARDWARE,
6 FIRMWARE, SOFTWARE, PROCESS, PROCEDURE, OR A COMBINATION OF THESE
7 FACTORS THAT COULD PREVENT OR LESSEN THE LIKELIHOOD OF FAILURE OR
8 COMPROMISE OF THE CONFIDENTIALITY, INTEGRITY, OR ACCESSIBILITY OF A
9 CONNECTED DEVICE OR INFORMATION STORED WITHIN A CONNECTED DEVICE.

10 (F) "UNAUTHORIZED ACCESS" MEANS ANY USE, MODIFICATION,
11 DISCLOSURE, OR DESTRUCTION OF ANY INFORMATION STORED WITHIN A
12 CONNECTED DEVICE THAT IS NOT AUTHORIZED BY THE OWNER OF THE CONNECTED
13 DEVICE.

14 14-4202.

15 THIS SUBTITLE MAY NOT BE CONSTRUED TO IMPOSE ANY DUTY ON:

16 (1) A MANUFACTURER OF A CONNECTED DEVICE FOR AN
17 UNAUTHORIZED ACCESS THAT ARISES FROM AN UNAFFILIATED THIRD-PARTY
18 APPLICATION OR SOFTWARE THAT A USER ADDS TO A CONNECTED DEVICE;

19 (2) A MANUFACTURER TO PREVENT A USER FROM HAVING FULL
20 CONTROL OVER A CONNECTED DEVICE, INCLUDING BY ALLOWING A USER TO
21 MODIFY THE SOFTWARE OR FIRMWARE RUNNING ON THE CONNECTED DEVICE; OR

22 (3) THE OPERATOR OF AN ELECTRONIC STORE, AN ELECTRONIC
23 MARKETPLACE, OR ANY OTHER MEANS OF PURCHASING OR DOWNLOADING
24 SOFTWARE OR APPLICATIONS TO ENFORCE COMPLIANCE WITH THIS SUBTITLE.

26 (A) A MANUFACTURER OF A CONNECTED DEVICE SHALL EQUIP THE DEVICE
27 WITH A REASONABLE SECURITY FEATURE THAT IS:

28 (1) APPROPRIATE TO THE NATURE AND FUNCTION OF THE
29 CONNECTED DEVICE;

30 (2) APPROPRIATE TO THE INFORMATION THE CONNECTED DEVICE
31 COLLECTS, CONTAINS, OR TRANSMITS; AND

1 **(3) DESIGNED TO PROTECT THE CONNECTED DEVICE FROM**
2 **UNAUTHORIZED ACCESS, DESTRUCTION, OR MODIFICATION.**

3 **(B) A CONNECTED DEVICE HAS A REASONABLE SECURITY FEATURE FOR**
4 **THE PURPOSE OF THIS SUBTITLE IF:**

5 **(1) THE SECURITY FEATURE MEETS THE REQUIREMENTS UNDER**
6 **SUBSECTION (A) OF THIS SECTION; AND**

7 **(2) THE CONNECTED DEVICE IS EQUIPPED WITH A MEANS FOR**
8 **AUTHENTICATION OUTSIDE OF A LOCAL AREA NETWORK THAT INCLUDES:**

9 **(I) A PREPROGRAMMED PASSWORD THAT IS UNIQUE TO EACH**
10 **MANUFACTURED CONNECTED DEVICE; OR**

11 **(II) A PROCESS THAT REQUIRES THE USER TO GENERATE A NEW**
12 **MEANS OF AUTHENTICATION BEFORE THE USER IS GRANTED ACCESS TO THE**
13 **CONNECTED DEVICE FOR THE FIRST TIME.**

15 **A VIOLATION OF THIS SUBTITLE IS:**

16 **(1) AN UNFAIR, ABUSIVE, OR DECEPTIVE TRADE PRACTICE WITHIN**
17 **THE MEANING OF TITLE 13 OF THIS ARTICLE; AND**

18 **(2) SUBJECT TO THE ENFORCEMENT AND PENALTY PROVISIONS**
19 **CONTAINED IN TITLE 13 OF THIS ARTICLE.**

20 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 January 1, 2021.
