## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Frederick County – Board of Education – Compensation**

3 FOR the purpose of altering the amount of annual compensation of the president and other  
4 voting members of the Frederick County Board of Education beginning with the  
5 commencement of a certain term of office; and generally relating to the Frederick  
6 County Board of Education.

7 BY repealing and reenacting, with amendments,  
8 Article – Education  
9 Section 3–5B–03  
10 Annotated Code of Maryland  
11 (2018 Replacement Volume and 2019 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Education**

15 3–5B–03.

16 (a) **(1)** [The] **UNTIL THE ELECTION OF MEMBERS OF THE FREDERICK**  
17 **COUNTY BOARD AT THE GENERAL ELECTION OF 2022 AND THE COMMENCEMENT OF**  
18 **THEIR TERMS ON DECEMBER 6, 2022, FOLLOWING THAT ELECTION, THE** president of  
19 the [Frederick County Board] **COUNTY BOARD** is entitled to receive \$11,000 annually as  
20 compensation, and each other voting member of the [Frederick County Board] **COUNTY**

1 BOARD is entitled to receive \$10,000 annually as compensation.

2 (2) AFTER THE ELECTION OF MEMBERS OF THE COUNTY BOARD AT  
3 THE GENERAL ELECTION OF 2022 AND THE COMMENCEMENT OF THEIR TERMS ON  
4 DECEMBER 6, 2022, FOLLOWING THE ELECTION, THE PRESIDENT OF THE COUNTY  
5 BOARD IS ENTITLED TO RECEIVE \$15,000 ANNUALLY AS COMPENSATION, AND EACH  
6 OTHER VOTING MEMBER OF THE COUNTY BOARD IS ENTITLED TO RECEIVE \$14,000  
7 ANNUALLY AS COMPENSATION.

8 (b) The president and all other members of the Frederick County Board are  
9 entitled to health insurance benefits regularly provided to employees of the Frederick  
10 County public school system.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
12 1, 2020.
