Public education school system; PreK-12th grade. one of our many requirements is to provide extracurricular activities for our students. Outdoor athletic tracks are an essential component of the physical education program. JV and Varsity track teams and extracurricular running clubs must have a safe running surface for which to use.		

11. Description and Purpose of Project (Limit length to visible area)

The outdoor athletic track at Colonel Richardson High School is at the end of its useful life and must be replaced. These funds will be used to remove the existing surface, mill the existing asphalt base, replace with new asphalt and install new structural track surfacing system to include lines and event markings. The County Government does not have the debt capacity to handle this project in conjunction with other capital budget requests. In addition, the County is at their maximum taxing level for income tax purposes. Replacement of this outdoor athletic track is essential in order to continue to offer track as a spring JV and Varsity sport as well as being able to continue to include track as a vital component of the daily physical education curriculum.
