5 FOR the purpose of establishing the Office of ~~Digital Inclusion~~ Statewide Broadband in the
6 Department of Housing and Community Development; establishing the purpose of
7 the Office; requiring the Governor to appoint the Director of the Office; providing
8 that the Director serves at the pleasure of the Governor and reports to certain
9 individuals; requiring the Director to work closely with certain officials for certain
10 purposes; establishing the duties of the Office; requiring the Office to offer funding
11 and technical assistance through certain partnerships to help local governments and
12 certain entities qualify for federal funding opportunities; requiring the Office to work
13 with a certain unit to initiate a broadband funding structure under a certain
14 provision of law; requiring the Office to prepare and submit a certain plan to the
15 Governor and the General Assembly, on or before a certain date; requiring the Office
16 to solicit input from certain stakeholders in preparing the plan; requiring the Office
17 to collaborate with certain units of State and local government in carrying out certain

30 WHEREAS, The General Assembly recognizes the importance of the Internet as the
 31 most transformative technology of modern life, a key stimulus for socioeconomic
 32 opportunity and development, and a prerequisite for social and economic inclusion; and

33 WHEREAS, High-quality broadband Internet service creates new jobs, attracts new
 34 industries, expands markets for new and existing businesses, enables Marylanders to
 35 better access educational opportunities and resources, facilitates delivery of health care
 36 services, and protects public safety; and

37 WHEREAS, Increased deployment of broadband Internet services and
 38 infrastructure will improve long-term quality of life for all Marylanders and will ensure
 39 that the State remains economically competitive both locally and globally; and

1 WHEREAS, Maryland is committed to enabling the development of a statewide
 2 digital communications infrastructure by encouraging continued private investment and
 3 where necessary, through public investment, public-private partnerships, and cooperatives
 4 to meet the growing demand for reliable, high-speed, universal, and affordable broadband
 5 access in the key sectors of public safety, education, health care, and transportation for all
 6 Marylanders; and

7 WHEREAS, By advancing digital literacy and universal access among Marylanders,
 8 the State will help eradicate the inequalities in adoption, knowledge, and skills needed to
 9 effectively use and communicate through various digital platforms and tools, ultimately
 10 enabling the acquisition of skills and knowledge necessary for digitally inclusive
 11 communities; and

12 WHEREAS, A ~~growing~~ digital divide between Marylanders who have the ability and
 13 means to use broadband Internet services and those who do not exacerbates preexisting
 14 inequality in the State; and

15 WHEREAS, The Governor established the Office of Rural Broadband in 2017
 16 through Executive Order, and the Office is doing important work to provide Internet access
 17 and connectivity to certain residents in more rural parts of the State; and

18 WHEREAS, There are Marylanders in every county of the State who are unable to
 19 adequately use broadband Internet today, or who are unaware of the utility and benefits of
 20 broadband Internet; and

21 WHEREAS, It is necessary to establish an office that will work not only with rural
 22 jurisdictions but with every county in the State; now, therefore,

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
