CHAPTER _____

1 AN ACT concerning

2 **Agriculture – Neonicotinoid Pesticides – Sale and Storage**

3 FOR the purpose of restricting a person that sells a neonicotinoid pesticide under certain
4 provisions of law to selling a neonicotinoid pesticide only to a certain certified
5 applicator or farmer; requiring a person selling a neonicotinoid pesticide to store a
6 neonicotinoid pesticide in a certain manner; making stylistic and conforming
7 changes; defining certain terms; and generally relating to neonicotinoid pesticides.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Agriculture**

2 (a) In this subtitle the following words have the meanings indicated.

3 (c) "Certified applicator" means a person who is certified by the Secretary under
4 this subtitle.

5 (r) "Restricted use pesticide" means a pesticide so classified by the provisions in
6 this title or by the federal government or the Secretary of Agriculture, State of Maryland.

8 (A) In this subtitle[, "neonicotinoid"] **THE FOLLOWING WORDS HAVE THE**
9 **MEANINGS INDICATED.**

10 (B) **"CERTIFIED APPLICATOR" HAS THE MEANING STATED IN § 5-201 OF**
11 **THIS TITLE.**

12 (C) **"NEONICOTINOID pesticide"** means any pesticide containing a chemical
13 belonging to the neonicotinoid class of chemicals, including:

14 (1) Imidacloprid;

15 (2) Nithiazine;

16 (3) Acetamiprid;

17 (4) Clothianidin;

18 (5) Dinotefuran;

19 (6) Thiacloprid;

20 (7) Thiamethoxam; and

21 (8) Any other chemical designated by the Department as belonging to the
22 neonicotinoid class of chemicals.

23 (D) **"RESTRICTED USE PESTICIDE" HAS THE MEANING STATED IN § 5-201 OF**
24 **THIS TITLE.**

26 (a) **[(1)]** This section does not apply to:

1 [(i)] (1) Pet care products used to mitigate fleas, mites, ticks,
2 heartworms, or other animals that are harmful to the health of a domesticated animal;

3 [(ii)] (2) Personal care products used to mitigate lice and bedbugs;
4 and

5 [(iii)] (3) Indoor pest control products used to mitigate insects
6 indoors, including ant bait.

7 [(2)] (B) (1) On or after January 1, 2018, a person may not sell at retail
8 in the State a neonicotinoid pesticide unless the person also sells a restricted use pesticide[,
9 as defined in § 5–201 of this title].

10 (2) A PERSON THAT SELLS A NEONICOTINOID PESTICIDE UNDER
11 PARAGRAPH (1) OF THIS SUBSECTION:

12 (I) MAY SELL A NEONICOTINOID PESTICIDE ONLY TO A
13 CERTIFIED APPLICATOR OR A FARMER; AND

14 (II) SHALL STORE EACH NEONICOTINOID PESTICIDE ~~BEHIND~~
15 ~~THE COUNTER AND~~ IN A MANNER THAT IS INACCESSIBLE TO A CUSTOMER WITHOUT
16 THE ASSISTANCE FROM THE PERSON OR AN EMPLOYEE OF THE PERSON.

17 [(b)] (C) On or after January 1, 2018, a person may not use a neonicotinoid
18 pesticide unless the person is:

19 (1) A certified applicator or a person working under the supervision of a
20 certified applicator[, as defined in § 5–201 of this title];

21 (2) A farmer, or a person under the supervision of a farmer, who uses the
22 pesticide for agricultural purposes, including crop production, livestock, poultry, equine,
23 and noncrop agricultural fields; or

24 (3) A veterinarian.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2021.
