1 AN ACT concerning

2 **Queen Anne's County – Alcoholic Beverages – Repeal of Place of Worship**
3 **Prohibition**

4 FOR the purpose of repealing a prohibition on the Board of License Commissioners for
5 Queen Anne's County from issuing a license to an establishment located within a
6 certain distance of a place of worship; and generally relating to alcoholic beverages
7 licenses in Queen Anne's County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

2 This title applies only in Queen Anne's County.

3 27-1601.

4 (a) (1) Except as provided in subsection (b) of this section, the Board may not
5 issue a license for an establishment unless the establishment is located at least 500 feet
6 away from:

7 (i) [a place of worship;

8 (ii)] an elementary or secondary school;

9 [(iii)] (II) a public library; or

10 [(iv)] (III) a youth center sponsored or conducted by a governmental
11 unit.

12 (2) The distance is to be measured from the nearest point of the building of
13 the establishment to the nearest point of the property line of the [place of worship,
14 elementary or secondary school, public library, or youth center.

15 (b) The prohibition against issuing a license in subsection (a) of this section does
16 not apply to:

17 (1) the renewal or transfer of a license issued before May 1, 1976; or

18 (2) the issuance of a Class B (on-sale) hotel and restaurant license of any
19 type.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
21 1, 2021.
