1 AN ACT concerning

2 **Montgomery County – Community Choice Energy – Pilot Program**

3 **MC 17–21**

4 FOR the purpose of applying certain laws regarding net energy metering and community  
5 solar generating systems to customers served by a community choice aggregator;  
6 altering the circumstances under which counties and municipal corporations may  
7 act as an aggregator; authorizing a community choice aggregator to act as an  
8 electricity supplier for certain purposes without obtaining a certain license;  
9 establishing a certain Community Choice Aggregator Pilot Program; providing for  
10 the application of certain provisions of this Act; establishing a process by which,  
11 beginning on a certain date, a county may form a community choice aggregator;  
12 requiring a county to develop and give certain notice of a certain aggregation plan  
13 under certain circumstances; providing for the contents of a certain aggregation plan;  
14 prohibiting a county from excluding certain customers from the ability to participate

2 under which certain customers shall be deemed to have given permission to a certain  
3 county to act as the customers' community choice aggregator; providing that certain  
4 customers may refuse to participate in certain aggregation activities under certain  
5 circumstances; requiring a certain electricity supplier to give certain notice to a  
6 community choice aggregator regarding the end of a certain contract term;  
7 prohibiting a community choice aggregator from assessing certain new fees, taxes,  
8 or charges in the aggregation charges or rates under certain circumstances;  
9 authorizing a community choice aggregator to provide and promote energy efficiency  
10 programs, in consultation with certain persons under certain circumstances;  
11 exempting a community choice aggregator from certain requirements relating to the  
12 licensing of electricity suppliers; authorizing a community choice aggregator to own  
13 a certain electric generating facility or electric storage facility for a certain purpose;  
14 requiring a community choice aggregator to submit a certain plan to the Public  
15 Service Commission for the use or disposition of a certain electric generating facility  
16 or electric storage facility under certain circumstances; authorizing a community  
17 choice aggregator to contract for service from an electric generating facility under

20 certain period; requiring any contract relating to the provision of electric service by  
21 a community choice aggregator to allow for or anticipate the adoption of a certain  
22 mechanism; requiring a county to give or provide for certain notices to certain  
23 persons and to the Commission under certain circumstances; providing for the  
24 contents of certain notices; requiring the Commission to notify a certain county as to  
25 its approval of the aggregation plan and certain proposed terms of service, rates, and  
26 categories of certain charges, fees, or other costs under certain circumstances;

25 That Section(s) 1–101(f) through (i) and (j) through (tt), respectively, of Article – Public  
26 Utilities of the Annotated Code of Maryland be renumbered to be Section(s) 1–101(g)

28 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
29 as follows:

32 (a) In this division the following words have the meanings indicated.

33 (b) (1) “Aggregator” means an entity or an individual that acts on behalf of a  
34 customer to purchase electricity or gas.

35 (2) “Aggregator” does not include:

1 (i) an entity or individual that purchases electricity or gas **ONLY** for  
2 its own use or for the use of its subsidiaries or affiliates;

3 (ii) a municipal electric utility or a municipal gas utility serving only  
4 in its distribution territory; or

5 (iii) a combination of governmental units that purchases electricity  
6 or gas for use by the governmental units.

7 **(F) “COMMUNITY CHOICE AGGREGATOR” MEANS A COUNTY THAT SERVES**  
8 **AS AN ELECTRIC AGGREGATOR FOR THE PURPOSE OF NEGOTIATING THE PURCHASE**  
9 **OF ELECTRIC GENERATION SERVICES FROM AN ELECTRICITY SUPPLIER LICENSED**  
10 **BY THE COMMISSION OR FROM AN ELECTRIC GENERATING OR STORAGE FACILITY,**  
11 **OR PROVIDING ELECTRICITY FROM AN ELECTRIC GENERATING FACILITY OWNED BY**  
12 **THE AGGREGATOR FOR RESIDENTIAL ELECTRIC CUSTOMERS, ~~INCLUDING~~**  
13 **~~MASTER-METERED MULTIPLE OCCUPANCY RESIDENCES~~ WHICH INCLUDE**  
14 **MASTER-METERED MULTIPLE OCCUPANCY RESIDENCES AND SMALL COMMERCIAL**  
15 **ELECTRIC CUSTOMERS, AS DEFINED IN § 7-510.3 OF THIS ARTICLE, THAT:**

16 **(1) ARE LOCATED WITHIN THE COUNTY, INCLUDING CUSTOMERS**  
17 **LOCATED WITHIN MUNICIPAL CORPORATIONS LOCATED IN THE COUNTY;**

18 **(2) HAVE NOT:**

19 **(I) SELECTED AN ELECTRICITY SUPPLIER OTHER THAN THE**  
20 **STANDARD OFFER SERVICE SUPPLIER; OR**

21 **(II) REFUSED TO PARTICIPATE IN THE AGGREGATION**  
22 **ACTIVITIES OF THE COUNTY; AND**

23 **(3) ARE NOT LOCATED IN THE SERVICE TERRITORY OF:**

24 **(I) A MUNICIPAL ELECTRIC UTILITY; OR**

25 **(II) AN ELECTRIC COOPERATIVE.**

26 **(K) “ELECTRIC STORAGE FACILITY” MEANS A FACILITY USED TO STORE:**

27 **(1) ELECTRICAL ENERGY; OR**

28 **(2) MECHANICAL, CHEMICAL, OR THERMAL ENERGY THAT WAS**  
29 **PREVIOUSLY ELECTRICAL ENERGY:**

30 **(I) FOR USE AS ELECTRICAL ENERGY AT A LATER TIME; OR**

1 (II) IN A PROCESS THAT OFFSETS ELECTRICITY USE DURING  
2 PEAK DEMAND.

4 (a) (1) In this section the following words have the meanings indicated.

5 (4) "Eligible customer-generator" means a customer that owns and  
6 operates, leases and operates, or contracts with a third party that owns and operates a  
7 biomass, micro combined heat and power, solar, fuel cell, wind, or closed conduit hydro  
8 electric generating facility that:

9 (i) is located on the customer's premises or contiguous property;

10 (ii) is interconnected and operated in parallel with an electric  
11 company's transmission and distribution facilities; and

12 (iii) is intended primarily to offset all or part of the customer's own  
13 electricity requirements.

14 (7) "Net energy metering" means measurement of the difference between  
15 the electricity that is supplied by an electric company and the electricity that is generated  
16 by an eligible customer-generator and fed back to the electric grid over the eligible  
17 customer-generator's billing period.

18 (f) (1) The electric company shall calculate net energy metering in accordance  
19 with this subsection.

20 (5) (i) An eligible customer-generator under paragraph (4) of this  
21 subsection may accrue net excess generation for a period:

22 1. not to exceed 12 months; and

23 2. that ends with the billing cycle that is complete  
24 immediately prior to the end of April of each year.

25 (ii) The electric company shall carry forward net excess generation  
26 until:

27 1. the eligible customer-generator's consumption of  
28 electricity from the grid eliminates the net excess generation; or

29 2. the accrual period under subparagraph (i) of this  
30 paragraph expires.

31 (iii) 1. The dollar value of net excess generation shall be equal to  
32 the generation or commodity portion of the rate that the eligible customer-generator would

1 have been charged by the electric company averaged over the previous 12-month period  
 2 ending with the billing cycle that is complete immediately prior to the end of April  
 3 multiplied by the number of kilowatt-hours of net excess generation.

4                   2. For customers served by **A COMMUNITY CHOICE**  
 5 **AGGREGATOR OR** an electricity supplier, the dollar value of the net excess generation shall  
 6 be equal to the generation or commodity rate that the customer would have been charged  
 7 by the **COMMUNITY CHOICE AGGREGATOR OR** electricity supplier multiplied by the  
 8 number of kilowatt-hours of net excess generation.

9           **(H) AN ELIGIBLE CUSTOMER-GENERATOR PARTICIPATING IN NET ENERGY**  
 10 **METERING MAY PARTICIPATE IN THE AGGREGATION ACTIVITIES OF A COMMUNITY**  
 11 **CHOICE AGGREGATOR UNDER § 7-510.3 OF THIS TITLE.**

12           **[(h)] (I)** On or before September 1 of each year, the Commission shall report to  
 13 the General Assembly, in accordance with § 2-1257 of the State Government Article, on the  
 14 status of the net metering program under this section, including:

15                   (1) the amount of capacity of electric generating facilities owned and  
 16 operated by eligible customer-generators in the State by type of energy resource;

17                   (2) based on the need to encourage a diversification of the State's energy  
 18 resource mix to ensure reliability, whether the rated generating capacity limit in subsection  
 19 (d) of this section should be altered; and

20                   (3) other pertinent information.

22           (d) (1) (i) The Commission shall establish a pilot program for a Community  
 23 Solar Energy Generating System Program.

24                   (ii) The structure of the pilot program is as provided in this  
 25 subsection.

26                   (2) All rate classes may participate in the pilot program.

27                   (3) Subscribers served by electric standard offer service, **COMMUNITY**  
 28 **CHOICE AGGREGATORS**, and electricity suppliers may hold subscriptions to the same  
 29 community solar energy generating system.

31           (a) A person, other than an electric company providing standard offer service  
 32 under § 7-510(c) of this subtitle **[or]**, a municipal electric utility serving customers solely  
 33 in its distribution territory, **OR A COMMUNITY CHOICE AGGREGATOR UNDER § 7-510.3**

2 unless the person holds a license issued by the Commission.

11 MORE THAN 25 KILOWATTS AND INCLUDES MASTER-METERED MULTIPLE  
12 OCCUPANCY RESIDENCES THAT HAVE A PEAK ELECTRIC LOAD OF NOT MORE THAN 25  
13 KILOWATTS.

14 (B) THIS SECTION APPLIES ONLY IN MONTGOMERY COUNTY.

15 (C) (1) THERE IS A COMMUNITY CHOICE AGGREGATION PILOT  
16 PROGRAM.

17 (2) BEGINNING ~~JANUARY~~ ~~APRIL 1~~ DECEMBER 31, 2023, A COUNTY  
18 MAY FORM A COMMUNITY CHOICE AGGREGATOR UNDER THIS SECTION.

19 (D) (1) AT LEAST 60 DAYS BEFORE INITIATING THE PROCESS TO FORM A  
20 COMMUNITY CHOICE AGGREGATOR, A COUNTY SHALL:

21 (I) DEVELOP AN AGGREGATION PLAN;

22 (II) GIVE WRITTEN NOTICE OF THE AGGREGATION PLAN TO  
23 EACH RESIDENTIAL AND SMALL COMMERCIAL ELECTRIC CUSTOMER IN THE  
24 COUNTY;

25 (III) PUBLISH A FAIR SUMMARY OF THE AGGREGATION PLAN IN  
26 AT LEAST ONE NEWSPAPER OF GENERAL CIRCULATION IN THE COUNTY;

27 (IV) IF THE COUNTY MAINTAINS A WEBSITE, PUBLISH THE FULL  
28 TEXT OF THE AGGREGATION PLAN ON THE WEBSITE; AND

29 (V) GIVE, FOR THE COMMISSION’S APPROVAL, WRITTEN NOTICE  
30 OF ITS INTENTION TO INITIATE A PROCESS TO FORM A COMMUNITY CHOICE  
31 AGGREGATOR.

**(2) THE AGGREGATION PLAN SHALL:**

**(I) DETAIL THE PROCESSES RELATED TO PARTICIPATING IN THE AGGREGATION ACTIVITIES OF A COMMUNITY CHOICE AGGREGATOR;**

**(II) CONTAIN INFORMATION ON THE OPERATIONS, FUNDING, AND ORGANIZATIONAL STRUCTURE OF THE COMMUNITY CHOICE AGGREGATOR;**

**(III) PROVIDE DETAILS ON:**

**1. THE RATE SETTING AND COSTS TO PARTICIPANTS, INCLUDING AN ANALYSIS OF HISTORICAL AND FORECASTED TRENDS IN ELECTRICITY PRICES AND A PURCHASING PLAN DESIGNED TO SAVE RATEPAYERS MONEY;**

**2. METHODS THAT THE COMMUNITY CHOICE AGGREGATOR MUST USE FOR ENTERING INTO AND TERMINATING AGREEMENTS WITH OTHER ENTITIES;**

**3. THE RIGHTS AND RESPONSIBILITIES OF PARTICIPATING ELECTRIC CUSTOMERS; AND**

**4. THE TERMINATION OF THE AGGREGATION PROGRAM, IF ANY; AND**

**(IV) PROVIDE FOR UNIVERSAL ELECTRICITY ACCESS, RELIABILITY, AND EQUITABLE TREATMENT OF ALL RESIDENTIAL AND SMALL COMMERCIAL ELECTRIC CUSTOMERS IN THE COUNTY.**

**(E) (1) AT LEAST 60 DAYS AFTER DEVELOPING AN AGGREGATION PLAN AND GIVING THE NOTICE REQUIRED UNDER SUBSECTION (D) OF THIS SECTION, A COUNTY MAY INITIATE THE PROCESS OF FORMING A COMMUNITY CHOICE AGGREGATOR BY FILING WITH THE COMMISSION:**

**(I) A NOTICE OF INTENT TO FORM A COMMUNITY CHOICE AGGREGATOR;**

**(II) A COPY OF THE AGGREGATION PLAN DEVELOPED IN ACCORDANCE WITH SUBSECTION (D) OF THIS SECTION;**

**(III) A DRAFT LOCAL LAW FORMING A COMMUNITY CHOICE AGGREGATOR; AND**



1 (IV) PROPOSED TERMS OF SERVICE, RATES, AND CATEGORIES  
2 OF CHARGES, FEES, OR ANY OTHER COSTS TO CUSTOMERS UNRELATED TO THE  
3 ACTUAL COST OF THE ELECTRICITY SUPPLY.

4 (2) THE NOTICE OF INTENT SHALL INCLUDE THE NAME OF THE  
5 COUNTY IN THE COMMUNITY CHOICE AGGREGATOR.

6 (3) A COUNTY IS A COMMUNITY CHOICE AGGREGATOR AFTER:

7 (I) SUBMITTING THE NOTICE OF INTENT AND AGGREGATION  
8 PLAN REQUIRED UNDER THIS SUBSECTION;

9 (II) THE COMMISSION HAS APPROVED ITS AGGREGATION PLAN  
10 AND PROPOSED TERMS FILED IN ACCORDANCE WITH PARAGRAPH (1)(IV) OF THIS  
11 SUBSECTION; AND

12 (III) ENACTING A LOCAL LAW THAT PROVIDES THAT THE COUNTY  
13 SHALL ACT AS A COMMUNITY CHOICE AGGREGATOR.

14 (F) (1) IN ACCORDANCE WITH A SCHEDULE ESTABLISHED BY THE  
15 COMMISSION UNDER SUBSECTION (L) OF THIS SECTION, IF A COUNTY ENACTS A  
16 LOCAL LAW TO ACT AS A COMMUNITY CHOICE AGGREGATOR, THE COUNTY SHALL  
17 PROVIDE OR CAUSE ITS SELECTED ELECTRICITY SUPPLIER, IF ANY, TO PROVIDE  
18 WRITTEN NOTICE OF THE FORMATION OF THE COMMUNITY CHOICE AGGREGATOR  
19 TO ALL RESIDENTIAL AND SMALL COMMERCIAL ELECTRIC CUSTOMERS IN THE  
20 COUNTY.

21 (2) THE NOTICE REQUIRED UNDER THIS SUBSECTION SHALL  
22 INCLUDE:

23 (I) THE IDENTITY AND COMMISSION-ISSUED LICENSE  
24 NUMBERS OF ANY SELECTED ELECTRICITY SUPPLIER;

25 (II) TERMS AND CONDITIONS OF SERVICE;

26 (III) NEW RATES, CHARGES, AND FEES FOR SERVICE UNDER THE  
27 COMMUNITY CHOICE AGGREGATOR;

28 (IV) A COMPARISON OF THE NEW RATES AND THE RATES UNDER  
29 THE CURRENT STANDARD OFFER SERVICE;

30 (V) INFORMATION ON HOW TO ACCESS THE STANDARD OFFER  
31 SERVICE AVAILABLE FROM AN ELECTRIC COMPANY; AND

1                   **(VI) THE TOTAL RENEWABLE COMPONENT OF THE ELECTRICITY**  
2 **TO BE SUPPLIED THROUGH A COMMUNITY CHOICE AGGREGATOR, INCLUDING THE**  
3 **SPECIFIC SOURCES OF ANY RENEWABLE ENERGY COMPARED TO THE**  
4 **REQUIREMENTS UNDER CURRENT LAW, IF ANY.**

5                   **(3) IN THE NOTICE REQUIRED UNDER THIS SUBSECTION, THE**  
6 **COUNTY SHALL PROVIDE TO THE RESIDENTIAL AND SMALL COMMERCIAL ELECTRIC**  
7 **CUSTOMERS IN THE COUNTY THE OPPORTUNITY TO REFUSE TO PARTICIPATE IN THE**  
8 **AGGREGATION ACTIVITIES OF THE COMMUNITY CHOICE AGGREGATOR:**

9                   **(I) BY RETURN SUBMISSION OF THE NOTICE TO THE**  
10 **COMMUNITY CHOICE AGGREGATOR OR THE ELECTRIC COMPANY INDICATING THE**  
11 **CUSTOMER'S DECISION TO REFUSE TO PARTICIPATE IN THE AGGREGATION**  
12 **ACTIVITIES OF THE COMMUNITY CHOICE AGGREGATOR; OR**

13                   **(II) BY CONTRACTING FOR SERVICE WITH A RETAIL**  
14 **ELECTRICITY SUPPLIER OR BY CHOOSING STANDARD OFFER SERVICE FROM AN**  
15 **ELECTRIC COMPANY.**

16                   **(4) A COUNTY THAT ENACTS A LOCAL LAW TO ACT AS A COMMUNITY**  
17 **CHOICE AGGREGATOR UNDER THIS SECTION MAY NOT EXCLUDE FROM THE ABILITY**  
18 **TO PARTICIPATE IN THE AGGREGATION ACTIVITIES OF THE COMMUNITY CHOICE**  
19 **AGGREGATOR:**

20                   **(I) ANY RESIDENTIAL OR SMALL COMMERCIAL ELECTRIC**  
21 **CUSTOMER IN THE COUNTY; OR**

22                   **(II) FOR THE PROVISION OF ELECTRIC SERVICE FOR FACILITIES**  
23 **LOCATED WITHIN THE JURISDICTION OF THE COMMUNITY CHOICE AGGREGATOR,**  
24 **ANY GOVERNMENTAL ENTITY.**

25                   **(G) A RESIDENTIAL OR SMALL COMMERCIAL ELECTRIC CUSTOMER IS**  
26 **DEEMED TO HAVE GIVEN PERMISSION TO THE COUNTY TO ACT ON THE CUSTOMER'S**  
27 **BEHALF AS A COMMUNITY CHOICE AGGREGATOR:**

28                   **(1) WHEN THE COUNTY RECEIVES FROM THE CUSTOMER:**

29                   **(I) A REPLY FROM THE NOTICE REQUIRED UNDER SUBSECTION**  
30 **(F) OF THIS SECTION BY WHICH THE CUSTOMER EXPLICITLY GRANTS PERMISSION**  
31 **FOR THE CUSTOMER TO RECEIVE SERVICE WITH THE COMMUNITY CHOICE**  
32 **AGGREGATOR; OR**

33                   **(II) AN APPLICATION TO RECEIVE SERVICE WITH THE**  
34 **COMMUNITY CHOICE AGGREGATOR;**

1           **(2) IN THE CASE OF A CUSTOMER RECEIVING STANDARD OFFER**  
2 **SERVICE, WITHIN 30 DAYS AFTER THE NOTICE REQUIRED BY SUBSECTION (F) OF**  
3 **THIS SECTION IS GIVEN IF:**

4                   **(I) THE COUNTY HAS NOT RECEIVED A RETURNED NOTICE BY**  
5 **THAT DATE; OR**

6                   **(II) AFTER THE CREATION OF THE COMMUNITY CHOICE**  
7 **AGGREGATOR AND RECEIPT OF THE NOTICE, THE CUSTOMER HAS NOT CONTRACTED**
