A BILL ENTITLED

1 AN ACT concerning

2 **Small Claims – Examination in Aid of Enforcement – Prohibition on Arrest or**
3 **Incarceration for Failure to Appear**

4 FOR the purpose of prohibiting an individual from being arrested or incarcerated for failure
5 to respond to certain orders to appear in court relating to an examination in aid of
6 enforcement of a money judgment entered in a small claim action in the District
7 Court; providing for the application of this Act; and generally relating to enforcement
8 of certain money judgments.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Courts and Judicial Proceedings**

17 **11–704.**

18 **AN INDIVIDUAL MAY NOT BE ARRESTED OR INCARCERATED FOR FAILURE TO**
19 **RESPOND TO AN ORDER TO APPEAR IN COURT:**

20 **(1) FOR AN EXAMINATION IN AID OF ENFORCEMENT OF A MONEY**
21 **JUDGMENT ENTERED IN A SMALL CLAIM ACTION IN THE DISTRICT COURT; OR**

22 **(2) TO SHOW CAUSE WHY THE INDIVIDUAL SHOULD NOT BE FOUND IN**
23 **CONTEMPT FOR FAILURE TO APPEAR IN COURT FOR AN EXAMINATION IN AID OF**

1 **ENFORCEMENT OF A MONEY JUDGMENT ENTERED IN A SMALL CLAIM ACTION IN THE**
2 **DISTRICT COURT.**

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to:

4 (1) any order to appear for an examination in aid of enforcement of a money
5 judgment entered in a small claim action in the District Court on or after the effective date
6 of this Act; and

7 (2) any show cause order for contempt for failure to appear in court for an
8 examination in aid of enforcement of a money judgment entered in a small claim action in
9 the District Court on or after the effective date of this Act.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2021.
