1 AN ACT concerning

2 **Utility Regulation – Consideration of Climate and Labor**

3 FOR the purpose of requiring the Secretary of the Environment to prepare a certain
4 recommendation in connection with certain issues considered by the Public Service
5 Commission; requiring the Secretary of Natural Resources to incorporate an
6 evaluation of the impact of certain electric power plants on climate change into the
7 Power Plant Research Program; expanding the required components of the research
8 program; requiring the Commission to consider the maintenance of fair and stable
9 labor standards for affected workers and the protection of the global climate in
10 supervising and regulating certain public service companies; ~~requiring each gas~~
11 ~~company and electric company to submit certain employment information to the~~
12 ~~Commission on or before a certain date each year; requiring the Commission to~~
13 ~~submit certain information to the General Assembly on or before a certain date each~~
14 ~~year;~~ requiring the Commission to consider, before taking final action on a certain
15 application, the effects of climate change on the operation of certain structures, the
16 impact of certain generation stations on statewide greenhouse gas emissions, and
17 the consistency of the application with the State's climate commitments; making
18 stylistic changes; and generally relating to the consideration of climate change and
19 labor in the regulation of utilities in the State.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 18 That the Laws of Maryland read as follows:

19 **Article – Environment**

20 2–405.

21 (a) (1) **(I)** Whenever the Public Service Commission notifies the Secretary
 22 of an application for a certificate of public convenience and necessity under § 7–207 of the
 23 Public Utilities Article, the Secretary shall prepare a recommendation in connection with
 24 the permit or registration required by this subtitle **AND THE ISSUES THE PUBLIC**
 25 **SERVICE COMMISSION MUST CONSIDER UNDER § 7–207 OF THE PUBLIC UTILITIES**
 26 **ARTICLE RELATING TO CLIMATE CHANGE.**

27 **(II)** The recommendation shall be presented at the hearing required
 28 by § 7–207 of the Public Utilities Article.

29 (2) The recommendation shall identify the requirements of all applicable
 30 federal and State environmental laws and standards and shall recommend and evaluate
 31 various methods and conditions for compliance.

32 (3) If a person files an application for an operating permit under this
 33 subtitle simultaneously with an application for a certificate, the Department shall
 34 consolidate its procedures for the issuance of the operating permit with the Public Service
 35 Commission's proceedings for issuance of the certificate and shall issue the operating
 36 permit simultaneously with the certificate unless consolidation would be inconsistent with
 37 the procedures set forth in the federal Clean Air Act.

1 (4) The Department shall incorporate into the initial operating permit the
2 conditions of the certificate which relate to air quality control.

5 (a) (1) The Secretary, in consultation with the Director of the Maryland
6 Energy Administration and in cooperation with the Secretaries of the Environment,
7 Agriculture, [and] Commerce, and [the Director of] Planning and electric company
8 representatives shall implement a continuing research program for electric power plant
9 site evaluation [and], related environmental and land use considerations, **AND THE**
10 **EVALUATION OF THE IMPACT OF ELECTRIC POWER PLANTS ON CLIMATE CHANGE.**

11 (2) (i) The Secretary shall seek from additional sources
12 recommendations for related research to be included in the program.

13 (ii) The additional sources shall include appropriate federal and
14 State agencies, electric companies and technical, scientific, or educational institutions or
15 organizations.

16 (3) (i) The Secretary, in consultation with the Director of the Maryland
17 Energy Administration, shall institute effective procedures for coordinating environmental
18 research assignments to prevent dissipation of money, time, and effort.

19 (ii) To this end, the State's electric companies shall be reimbursed
20 from the Fund for environmental research specifically required to satisfy application and
21 permit requirements for any federal, State, or local regulatory agencies, if the electric
22 company has requested reimbursement in advance and furnishes an outline of the program
23 and its estimated cost so that the Secretary can budget it in advance.

24 (b) The program shall include:

25 (1) General biological and ecological baseline studies, including, but not
26 limited to, appropriate environmental studies of the biology, physics, and chemistry of the
27 Chesapeake Bay and tributaries; sediment and biological surveys to determine and identify
28 essential marine organism nursery areas of the State's waters, including the Chesapeake
29 Bay and tributaries; epibenthos; bottom species; crab; finfish and human use studies;

30 (2) Research to assist prediction, including but not limited to experimental
31 research, field and laboratory, and the development and provision for physical,
32 mathematical, and biological modeling tools to assist in determining and evaluating the
33 effects of variation of natural waters resulting from electric generating plant operations
34 including changes in temperature, oxygen levels, salinity, biocides, radionuclides, and
35 "heavy" metals. This research also includes collection and organization of relevant

1 information and data necessary to operate physical, mathematical, and biological modeling
2 tools;

3 (3) Provisions for monitoring operations of electric power facilities located
4 in the State. These provisions include but are not limited to a determination of actual
5 distribution and effect of temperature, salinity, oxygen, radionuclides, “heavy” metals, and
6 biological effects; radiological; “heavy” metals and biocide effects; recreational and
7 commercial fishing gains and losses; and human health and welfare effects;

8 (4) Research and investigations relating to effects on air resources of
9 electric power plants and effects of air pollutants from power plants on public health and
10 welfare, vegetation, animals, materials, and esthetic values, including baseline studies,
11 predictive modeling, and monitoring of the air mass at sites of proposed or operating electric
12 generating stations, evaluation of new or improved methods for minimizing air pollution
13 from power plants and other matters pertaining to the effect of power plants on the air
14 environment;

15 (5) An environmental evaluation of electric power plant sites proposed for
16 future development and expansion and their relationship to the waters and air of the State;

17 (6) An evaluation of the environmental effects of new electric power
18 generation technologies and extraordinary systems related to power plants designed to
19 minimize environmental effects;

20 (7) Determining the potential for constructive uses of waste energy to be
21 released at proposed electric plant sites;

22 (8) Analysis of the socioeconomic impact of electric power generation
23 facilities on the land uses of the State; [and]

24 (9) An evaluation of the pollinator benefits that would occur under a
25 pollinator–friendly vegetation management standard or pollinator habitat plan
26 implemented on land:

27 (i) On which a proposed or an existing ground–mounted solar
28 generation facility is located; and

29 (ii) That does not include land that is adjacent to the land on which
30 the solar generation facility is located; AND

31 **(10) AN EVALUATION OF:**

32 **(I) THE GREENHOUSE GAS EMISSIONS AND CLIMATE EFFECTS**
33 **OF DIFFERENT ELECTRIC POWER GENERATION TECHNOLOGIES BASED ON THE BEST**
34 **AVAILABLE SCIENTIFIC INFORMATION RECOGNIZED BY THE INTERGOVERNMENTAL**
35 **PANEL ON CLIMATE CHANGE; AND**

1 **(II) WHETHER THE GREENHOUSE GAS EMISSIONS AND CLIMATE**
2 **EFFECTS OF ELECTRIC POWER GENERATION TECHNOLOGIES ARE CONSISTENT WITH**
3 **THE STATE’S CLIMATE COMMITMENTS FOR REDUCING STATEWIDE GREENHOUSE**
4 **GAS EMISSIONS, INCLUDING THOSE SPECIFIED IN TITLE 2, SUBTITLE 12 OF THE**
5 **ENVIRONMENT ARTICLE.**

9 (i) supervise and regulate the public service companies subject to
10 the jurisdiction of the Commission to:

11 1. ensure their operation in the interest of the public; and

12 2. promote adequate, economical, and efficient delivery of
13 utility services in the State without unjust discrimination; and

14 (ii) enforce compliance with the requirements of law by public
15 service companies, including requirements with respect to financial condition,
16 capitalization, franchises, plant, manner of operation, rates, and service.

(e) The Commission shall take final action on an application for a certificate of public convenience and necessity only after due consideration of:

(1) the recommendation of the governing body of each county or municipal corporation in which any portion of the construction of the generating station, overhead transmission line, or qualified generator lead line is proposed to be located;

(2) the effect of the generating station, overhead transmission line, or qualified generator lead line on:

(i) the stability and reliability of the electric system;

(ii) economics;

(iii) esthetics;

(iv) historic sites;

(v) aviation safety as determined by the Maryland Aviation Administration and the administrator of the Federal Aviation Administration;

(vi) when applicable, air quality and water pollution; and

(vii) the availability of means for the required timely disposal of wastes produced by any generating station; [and]

(3) THE EFFECT OF CLIMATE CHANGE ON THE GENERATING STATION, OVERHEAD TRANSMISSION LINE, OR QUALIFIED GENERATOR LEAD LINE BASED ON THE BEST AVAILABLE SCIENTIFIC INFORMATION RECOGNIZED BY THE INTERGOVERNMENTAL PANEL ON CLIMATE CHANGE; AND

(i) the consistency of the application with the comprehensive plan and zoning of each county or municipal corporation where any portion of the generating station is proposed to be located; [and]
