A BILL ENTITLED

1 AN ACT concerning

2 **Local Government – Animal Control Facilities – Adoption Fee Waiver for**
3 **Veterans**
4 **(Pets for Vets Act of 2021)**

5 FOR the purpose of requiring an animal control facility operated by a county or
6 municipality to waive the adoption fee for a dog or cat for a veteran who presents a
7 certain valid driver's license or identification card that includes a notation of veteran
8 status; authorizing an animal control facility to limit the number of adoption fee
9 waivers granted under this Act in a certain manner; providing for the application of
10 this Act; and generally relating to animal control facilities operated by a county or
11 municipality.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Local Government**

20 **1–1314.**

21 **(A) THIS SECTION APPLIES TO ALL COUNTIES AND MUNICIPALITIES.**

22 **(B) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, AN ANIMAL**
23 **CONTROL FACILITY OPERATED BY A COUNTY OR MUNICIPALITY SHALL WAIVE THE**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 **ADOPTION FEE FOR A DOG OR CAT ADOPTED BY A VETERAN WHO PRESENTS A VALID**
2 **DRIVER'S LICENSE OR IDENTIFICATION CARD ISSUED BY THE MOTOR VEHICLE**
3 **ADMINISTRATION THAT INCLUDES A NOTATION OF VETERAN STATUS IN**
4 **ACCORDANCE WITH § 12-302 OF THE TRANSPORTATION ARTICLE.**

5 **(2) AN ANIMAL CONTROL FACILITY MAY LIMIT THE NUMBER OF**
6 **ADOPTION FEE WAIVERS GRANTED TO AN INDIVIDUAL UNDER THIS SUBSECTION TO**
7 **ONE DOG AND ONE CAT WITHIN A 6-MONTH PERIOD.**

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 October 1, 2021.
