### CHAPTER \_\_\_\_\_

1 AN ACT concerning

#### 2 **State Lottery Fund – Maryland Humanities Council – Funding**

3 FOR the purpose of repealing certain provisions of law requiring the Comptroller to pay  
4 from the Racing Special Fund a certain grant to a certain entity; requiring the  
5 Comptroller to pay a certain amount of money from the State Lottery Fund to a  
6 certain entity to be used for certain purposes; making certain technical corrections;  
7 and generally relating to the State Lottery Fund and the Maryland Humanities  
8 Council.

9 BY repealing and reenacting, with amendments,  
10 Article – Business Regulation  
11 Section 11–403(a)(9)  
12 Annotated Code of Maryland

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
 8 That the Laws of Maryland read as follows:

11 (a) The Comptroller shall pay from the Special Fund an annual grant of:

12 (9) beginning July 1, 2017, from the money distributed under § 9–120(b) of  
 13 the State Government Article;

 15 thoroughbred race under § 11–522.1 of this title[;] ~~AND~~ and

23 (b) (1) By the end of the month following collection, the Comptroller shall  
 24 deposit [or], cause to be deposited, OR PAY:

25 (i) into the Maryland Stadium Facilities Fund established under §  
 26 7–312 of the State Finance and Procurement Article from the money that remains in the  
 27 State Lottery Fund, after the distribution under subsection (a) of this section, an amount  
 28 not to exceed \$20,000,000 in any fiscal year;

29 (ii) after June 30, 2014, into the Maryland Veterans Trust Fund 10%  
 30 of the money that remains in the State Lottery Fund from the proceeds of sales of tickets  
 31 from instant ticket lottery machines by veterans' organizations under § 9–112(d) of this  
 32 subtitle, after the distribution under subsection (a) of this section;

1 (iii) after June 30, 2014, into the Baltimore City Public School  
 2 Construction Financing Fund established under § 10–656 of the Economic Development  
 3 Article the money that remains in the State Lottery Fund from the proceeds of all lotteries  
 4 after the distributions under subsection (a) of this section and items (i) and (ii) of this  
 5 paragraph, an amount equal to \$20,000,000 in each fiscal year that bonds are outstanding  
 6 and unpaid, to be paid in two installments with at least \$10,000,000 paid no later than  
 7 December 1 of each fiscal year;

8 (iv) after June 30, 2021, into the Racing and Community  
 9 Development Financing Fund established under § 10–657.2 of the Economic Development  
 10 Article from the money that remains in the State Lottery Fund, after the distribution under  
 11 subsection (a) of this section, an amount equal to \$17,000,000 in each fiscal year until the  
 12 bonds issued for a racing facility have matured; ~~and~~

13 (v) after June 30, 2020, into the Michael Erin Busch Sports Fund  
 14 established under § 10–612.2 of the Economic Development Article from the money that  
 15 remains in the State Lottery Fund from the proceeds of all lotteries after the distributions  
 16 under subsection (a) of this section and items (i), (ii), and (iii)] THROUGH (IV) of this  
 17 paragraph, an amount equal to \$1,000,000 in each fiscal year; [and]

18 ~~(v)~~ **(VI) AFTER JUNE 30, 2021, A GRANT TO THE MARYLAND**  
 19 **HUMANITIES COUNCIL FOR MARYLAND HISTORY DAY AND OTHER PROGRAMMING**  
 20 **FROM THE MONEY THAT REMAINS IN THE STATE LOTTERY FUND AFTER THE**  
 21 **DISTRIBUTIONS UNDER SUBSECTION (A) OF THIS SECTION AND ITEMS (I), (II), (III),**  
 22 **AND (IV) (I) THROUGH (V) OF THIS PARAGRAPH, AN AMOUNT EQUAL TO \$150,000 IN**  
 23 **EACH FISCAL YEAR; AND**

 25 in the State Lottery Fund from the proceeds of all lotteries after the distributions under  
 26 subsection (a) of this section and items ~~(i), (ii), (iii), [and] (iv), AND (v)~~ **(I) THROUGH (VI)**  
 27 of this paragraph.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
 29 1, 2021.
