10. Description and Purpose of Organization (Limit length to visible area)		
Howard County Government via the Howard County Department of Recreation and Parks. The Howard County Department of Recreation and Parks is responsible for the stewardship of over 9,600 acres of public lands; the maintenance and operation of more than 30 parks, 4 natural resource areas, 26 historic sites, 3 community center, a nature center, an athletic center, and various other facilities; and offering over 7,000 recreational programs. The mission of the Department is to responsibly manage natural resources; provide excellent parks, facilities, and recreation opportunities for the community; and ensure the highest quality of life for current and future generations.		

11. Description and Purpose of Project (Limit length to visible area)

Howard County is requesting a \$300,000.00 Bond Bill Grant for the design, construction, and equipping of a conversion of the existing Patapsco Female Institute's open-air chapel ruin into a renovated space. Improvements will include water and sewer connections, restrooms, meeting and storage rooms, office space, and a new open-air stage. All improvements will provide ADA- compliant access to the site and enhance the adaptive reuse and enjoyment of this historic property.
