AMENDMENTS TO SENATE BILL 152
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, before “**Institutions**” insert “**Public**”; strike beginning with “**Transcripts**” in line 2 down through “**Debt**” in line 3 and substitute “**Transcript Requests by Students With Unpaid Student Account Balances**”; in line 4, strike “prohibiting an” and substitute “requiring a public”; strike beginning with “from” in line 4 down through “education” in line 7 and substitute “to allow certain students with an unpaid balance on a student account that is a certain amount or less to request and receive a transcript; requiring a public institution of higher education to allow certain students with an unpaid balance on a student account that is greater than a certain amount to request and receive a transcript under certain circumstances”; strike beginning with “the” in line 7 down through “regarding” in line 8; and in line 9, strike “who owe debts to the institution” and substitute “with unpaid balances on student accounts”.

AMENDMENT NO. 2

On page 1, in line 19, strike “(1)”; and in the same line, after “SECTION” insert a comma.

On pages 1 and 2, strike beginning with the first “THE” in line 19 on page 1 down through “(3)” in line 12 on page 2.

On page 2, in line 12, strike “STUDENT” and substitute “**STUDENT**”; strike beginning with “AN” in line 14 down through “COLLECTION” in line 23 and substitute “**A PUBLIC INSTITUTION OF HIGHER EDUCATION SHALL ALLOW A STUDENT WITH AN UNPAID BALANCE OF \$1,000 OR LESS ON A STUDENT ACCOUNT TO REQUEST AND RECEIVE A TRANSCRIPT**”;

after line 23, insert:

“(C) (1) A PUBLIC INSTITUTION OF HIGHER EDUCATION SHALL ALLOW A STUDENT WITH AN UNPAID BALANCE OF MORE THAN \$1,000 ON A STUDENT ACCOUNT TO REQUEST AND RECEIVE A TRANSCRIPT IF THE STUDENT ENTERS INTO AN INSTALLMENT PAYMENT PLAN WITHIN 90 DAYS AFTER THE DAY ON WHICH THE STUDENT MAKES THE REQUEST.

(2) THE INSTALLMENT PAYMENT PLAN UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL REQUIRE THE STUDENT TO MAKE PAYMENTS TO SETTLE THE UNPAID BALANCE ON THE STUDENT ACCOUNT BY THE AGREED ON DATE.”;

and in line 24, strike “July” and substitute “June”.
