### CHAPTER \_\_\_\_\_

1 AN ACT concerning

#### 2 **Vehicle Laws – Dedicated Bus Lanes – Prohibition and Monitoring Systems**

3 FOR the purpose of prohibiting a person from driving a motor vehicle in a dedicated bus  
4 lane unless authorized by a local jurisdiction, subject to certain exceptions; requiring  
5 the City of Baltimore to issue a new request for proposals to select a certain contractor  
6 to carry out certain provisions of this Act; authorizing Baltimore City to use, in  
7 accordance with certain standards and procedures, a bus lane monitoring system to  
8 enforce the prohibition against driving a motor vehicle in a designated bus lane;  
9 providing that the driver of a motor vehicle recorded unlawfully driving in a  
10 dedicated bus lane in Baltimore City is subject to a civil penalty unless the driver  
11 received a citation from a police officer at the time of the violation; requiring the  
12 Baltimore City Police Department to issue a warning notice in place of a citation to a  
13 liable owner during a certain period of time; authorizing the Motor Vehicle  
14 Administration to refuse to register or reregister a motor vehicle if a civil penalty for

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
 25 That the Laws of Maryland read as follows:

26 **Article – Courts and Judicial Proceedings**

27 4–401.

28 Except as provided in § 4–402 of this subtitle, and subject to the venue provisions of  
 29 Title 6 of this article, the District Court has exclusive original civil jurisdiction in:

30 (13) A proceeding for a civil infraction under § 21–202.1, § 21–704.1, §  
 31 21–706.1, § 21–809, § 21–810, **§ 21–1134**, or § 24–111.3 of the Transportation Article or §  
 32 10–112 of the Criminal Law Article;

33 7–302.

34 (e) (1) **(I)** A citation issued pursuant to § 21–202.1, § 21–706.1, § 21–809, §  
 35 21–810, **§ 21–1134**, or § 24–111.3 of the Transportation Article shall provide that the

1 person receiving the citation may elect to stand trial by notifying the issuing agency of the  
2 person's intention to stand trial at least 5 days prior to the date of payment as set forth in  
3 the citation.

4 (II) On receipt of the notice to stand trial, the agency shall forward  
5 to the District Court having venue a copy of the citation and a copy of the notice from the  
6 person who received the citation indicating the person's intention to stand trial.

7 (III) On receipt thereof, the District Court shall schedule the case for  
8 trial and notify the defendant of the trial date under procedures adopted by the Chief Judge  
9 of the District Court.

10 (2) (I) A citation issued as the result of a vehicle height monitoring  
11 system, a traffic control signal monitoring system, or a speed monitoring system, including  
12 a work zone speed control system, controlled by a political subdivision [or], a school bus  
13 monitoring camera, **OR A BUS LANE MONITORING SYSTEM** shall provide that, in an  
14 uncontested case, the penalty shall be paid directly to that political subdivision.

15 (II) A citation issued as the result of a traffic control signal  
16 monitoring system or a work zone speed control system controlled by a State agency, or as  
17 a result of a vehicle height monitoring system, a traffic control signal monitoring system, a  
18 speed monitoring system, [or] a school bus monitoring camera, **OR A BUS LANE**  
19 **MONITORING SYSTEM** in a case contested in District Court, shall provide that the penalty  
20 shall be paid directly to the District Court.

21 (3) Civil penalties resulting from citations issued using a vehicle height  
22 monitoring system, traffic control signal monitoring system, speed monitoring system,  
23 work zone speed control system, [or] school bus monitoring camera, **OR BUS LANE**  
24 **MONITORING SYSTEM** that are collected by the District Court shall be collected in  
25 accordance with subsection (a) of this section and distributed in accordance with § 12–118  
26 of the Transportation Article.

27 (4) (i) From the fines collected by a political subdivision as a result of  
28 violations enforced by speed monitoring systems [or], school bus monitoring cameras, **OR**  
29 **BUS LANE MONITORING SYSTEMS**, a political subdivision:

30 1. May recover the costs of implementing and administering  
31 the speed monitoring systems [or], school bus monitoring cameras, **OR BUS LANE**  
32 **MONITORING SYSTEMS**; and

33 2. Subject to subparagraphs (ii), (iii), and (iv) of this  
34 paragraph, may spend any remaining balance solely for public safety purposes, including  
35 pedestrian safety programs.

36 (ii) 1. For any fiscal year, if the balance remaining from the fines  
37 collected by a political subdivision as a result of violations enforced by speed monitoring

1 systems, after the costs of implementing and administering the systems are recovered in  
2 accordance with subparagraph (i)1 of this paragraph, is greater than 10% of the total  
3 revenues of the political subdivision for the fiscal year, the political subdivision shall remit  
4 any funds that exceed 10% of the total revenues to the Comptroller.

5                                   2.       The Comptroller shall deposit any money remitted under  
6 this subparagraph to the General Fund of the State.

7                                   (iii)   The fines collected by Prince George's County as a result of  
8 violations enforced by speed monitoring systems on Maryland Route 210 shall be remitted  
9 to the Comptroller for distribution to the State Highway Administration to be used solely  
10 to assist in covering the costs of:

11                                   1.       Examining the engineering, infrastructure, and other  
12 relevant factors that may contribute to safety issues on Maryland Route 210 in Prince  
13 George's County;

14                                   2.       Reporting its findings and recommendations on any  
15 solutions to these safety issues; and

16                                   3.       Implementing any solutions to these safety issues.

17                                   (iv)   1.       From the fines collected by Baltimore City as a result of  
18 violations enforced by speed monitoring systems on Interstate 83, any balance remaining  
19 after the allocation of fines under subparagraph (i)1 of this paragraph shall be remitted to  
20 the Comptroller for distribution to the Baltimore City Department of Transportation to be  
21 used solely to assist in covering the cost of roadway improvements on Interstate 83 in  
22 Baltimore City.

23                                   2.       Fines remitted to the Baltimore City Department of  
24 Transportation under [subparagraph (iv)1 of this paragraph] **SUBSUBPARAGRAPH 1 OF**  
25 **THIS SUBPARAGRAPH** are supplemental to and are not intended to take the place of  
26 funding that would otherwise be appropriated for uses described under [subparagraph (iv)1  
27 of this paragraph] **SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH**.

28                                   (v)   From the fines collected by Anne Arundel County as a result of  
29 violations enforced by speed monitoring systems on Maryland Route 175 (Jessup Road)  
30 between the Maryland Route 175/295 interchange and the Anne Arundel  
31 County–Howard County line, any balance remaining after the allocation of fines under  
32 subparagraph (i)1 of this paragraph shall be remitted to the Comptroller for distribution to  
33 the State Highway Administration to be used solely to assist in covering the cost of speed  
34 reduction measures and roadway and pedestrian safety improvements on Maryland Route  
35 175 (Jessup Road) between the Maryland Route 175/295 interchange and the Anne Arundel  
36 County–Howard County line.

1 (5) From the fines collected by Baltimore City as a result of violations  
2 enforced by vehicle height monitoring systems, Baltimore City may:

3 (i) Recover the costs of implementing and administering the vehicle  
4 height monitoring systems; and

5 (ii) Spend the remaining balance solely on roadway improvements.

7 (a) A recorded image of a motor vehicle produced by a traffic control signal  
8 monitoring system in accordance with § 21–202.1 of the Transportation Article is  
9 admissible in a proceeding concerning a civil citation issued under that section for a  
10 violation of § 21–202(h) of the Transportation Article without authentication.

11 (b) A recorded image of a motor vehicle produced by a speed monitoring system  
12 in accordance with § 21–809 or § 21–810 of the Transportation Article is admissible in a  
13 proceeding concerning a civil citation issued under that section for a violation of Title 21,  
14 Subtitle 8 of the Transportation Article without authentication.

15 (c) A recorded image of a motor vehicle produced by a school bus monitoring  
16 camera in accordance with § 21–706.1 of the Transportation Article is admissible in a  
17 proceeding concerning a civil citation issued under that section for a violation of § 21–706  
18 of the Transportation Article without authentication.

19 (d) A recorded image of a motor vehicle produced by a vehicle height monitoring  
20 system in accordance with § 24–111.3 of the Transportation Article is admissible in a  
21 proceeding concerning a civil citation issued under that section for a violation of a State or  
22 local law restricting the presence of certain vehicles during certain times without  
23 authentication.

24 (e) **A RECORDED IMAGE OF A MOTOR VEHICLE PRODUCED BY A BUS LANE**  
25 **MONITORING SYSTEM IN ACCORDANCE WITH § 21–1134 OF THE TRANSPORTATION**  
26 **ARTICLE IS ADMISSIBLE IN A PROCEEDING CONCERNING A CIVIL CITATION ISSUED**  
27 **UNDER THAT SECTION FOR A VIOLATION OF § 21–1133 OF THE TRANSPORTATION**  
28 **ARTICLE WITHOUT AUTHENTICATION.**

29 (F) In any other judicial proceeding, a recorded image produced by a vehicle  
30 height monitoring system, traffic control signal monitoring system, speed monitoring  
31 system, work zone speed control system, [or] school bus monitoring camera, **OR BUS LANE**  
32 **MONITORING SYSTEM** is admissible as otherwise provided by law.

2 (A) IN THIS SECTION, “BUS LANE SYSTEM OPERATOR” HAS THE MEANING  
 3 STATED IN § 21-1133 OF THE TRANSPORTATION ARTICLE.

4 (B) (1) IF THE CITY OF BALTIMORE ELECTS TO DESIGNATE A  
 5 CONTRACTOR TO SERVE AS THE BUS LANE SYSTEM OPERATOR FOR THE CITY OF  
 6 BALTIMORE, THE CITY OF BALTIMORE SHALL ISSUE A COMPETITIVE REQUEST FOR  
 7 PROPOSALS TO SELECT THE CONTRACTOR.

8 (2) IF THE BALTIMORE CITY POLICE DEPARTMENT ELECTS TO  
 9 DESIGNATE A CONTRACTOR TO ADMINISTER AND PROCESS CIVIL CITATIONS ISSUED  
 10 UNDER § 21-1134 OF THE TRANSPORTATION ARTICLE, THE CITY OF BALTIMORE  
 11 SHALL ISSUE A COMPETITIVE REQUEST FOR PROPOSALS TO SELECT THE  
 12 CONTRACTOR.

13 (C) IF THE CITY OF BALTIMORE ISSUES A REQUEST FOR PROPOSALS UNDER  
 14 SUBSECTION (B) OF THIS SECTION, THE CITY OF BALTIMORE SHALL APPLY THE  
 15 RELEVANT PROCUREMENT PREFERENCES FOR MINORITY AND WOMEN’S BUSINESS  
 16 ENTERPRISES AND CONSIDER THE PROCUREMENT PARTICIPATION GOALS  
 17 REGARDING MINORITY AND WOMEN’S BUSINESS ENTERPRISES IN SELECTING A  
 18 CONTRACTOR.

21 (a) In this title and Title 25 of this article the following words have the meanings  
 22 indicated.

23 (i-1) “DEDICATED BUS LANE” MEANS A LANE DESIGNATED FOR USE BY MASS  
 24 TRANSIT VEHICLES OWNED, OPERATED, OR CONTRACTED FOR BY THE MARYLAND  
 25 TRANSIT ADMINISTRATION OR A LOCAL DEPARTMENT OF TRANSPORTATION.

26 21-1133.

27 (A) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, A PERSON  
 28 MAY NOT DRIVE A VEHICLE IN A DEDICATED BUS LANE UNLESS AUTHORIZED BY THE  
 29 LOCAL JURISDICTION IN WHICH THE DEDICATED BUS LANE IS LOCATED.

30 (B) THE FOLLOWING VEHICLES MAY BE DRIVEN IN A DEDICATED BUS LANE:

1           (1) A TRANSIT VEHICLE OWNED, OPERATED, OR CONTRACTED FOR BY  
2 THE MARYLAND TRANSIT ADMINISTRATION OR A LOCAL DEPARTMENT OF  
3 TRANSPORTATION;

4           (2) A SCHOOL BUS;

5           (3) A BICYCLE;

6           (4) AN EMERGENCY VEHICLE; AND

7           (5) A VEHICLE MAKING A RIGHT TURN AT THE NEXT IMMEDIATE  
8 INTERSECTION.

9 21-1134.

10          (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS  
11 INDICATED.

12           (2) “BUS LANE MONITORING SYSTEM” MEANS AN ENFORCEMENT  
13 SYSTEM THAT IS DESIGNED TO CAPTURE A RECORDED IMAGE OF A DRIVER OF A  
14 MOTOR VEHICLE COMMITTING A VIOLATION.

15           (3) “BUS LANE MONITORING SYSTEM OPERATOR” MEANS A  
16 REPRESENTATIVE OF THE BALTIMORE CITY POLICE DEPARTMENT OR A  
17 CONTRACTOR THAT OPERATES A BUS LANE MONITORING SYSTEM.

18           (4) (I) “OWNER” MEANS THE REGISTERED OWNER OF A MOTOR  
19 VEHICLE OR A LESSEE OF A MOTOR VEHICLE UNDER A LEASE OF 6 MONTHS OR  
20 MORE.

21                   (II) “OWNER” DOES NOT INCLUDE:

22                           1. A MOTOR VEHICLE LEASING COMPANY; OR

23                           2. A HOLDER OF A SPECIAL REGISTRATION PLATE  
24 ISSUED UNDER TITLE 13, SUBTITLE 9, PART III OF THIS ARTICLE.

25           (5) “RECORDED IMAGE” MEANS AN IMAGE RECORDED BY A BUS LANE  
26 MONITORING SYSTEM:

27                   (I) ON:

28                           1. A PHOTOGRAPH;

- 1                                   2.     A MICROPHOTOGRAPH;
- 2                                   3.     AN ELECTRONIC IMAGE;
- 3                                   4.     VIDEOTAPE; OR
- 4                                   5.     ANY OTHER VISUAL MEDIUM; AND

5                                   (II)   SHOWING A MOTOR VEHICLE AND, ON AT LEAST ONE IMAGE  
6 OR PORTION OF THE RECORDING, CLEARLY IDENTIFYING THE REGISTRATION PLATE  
7 NUMBER OF THE MOTOR VEHICLE.

8                                   (6)   “VIOLATION” MEANS A VIOLATION OF § 21-1133 OF THIS  
9 SUBTITLE.

10                                  (B)   THIS SECTION APPLIES ONLY IN BALTIMORE CITY.

11                                  (C)   (1)   BALTIMORE CITY MAY USE A BUS LANE MONITORING SYSTEM  
12 THAT MEETS THE REQUIREMENTS OF THIS SUBSECTION TO RECORD THE IMAGES OF  
13 MOTOR VEHICLES TRAVELING IN A BUS LANE.

14                                  (2)   A BUS LANE MONITORING SYSTEM MAY BE USED ONLY:

15    (I)   WHEN BEING OPERATED BY A BUS LANE MONITORING  
16 SYSTEM OPERATOR; ~~AND~~

17    (II)  IF, IN ACCORDANCE WITH THE MARYLAND MANUAL ON  
18 UNIFORM TRAFFIC CONTROL DEVICES, A CONSPICUOUS ROAD SIGN IS PLACED AT  
19 A REASONABLE DISTANCE CONSISTENT WITH NATIONAL GUIDELINES BEFORE THE  
20 BUS LANE ALERTING DRIVERS THAT A BUS LANE MONITORING SYSTEM MAY BE IN  
21 OPERATION IN THE BUS LANE; AND

22    (III) IF THE SYSTEM PRODUCES VIDEO FOR EACH ALLEGED  
23 VIOLATION THAT ALLOWS FOR THE DIFFERENTIATION BETWEEN A VEHICLE THAT IS  
24 DRIVEN IN A DEDICATED BUS LANE IN VIOLATION OF § 21-1133 OF THIS SUBTITLE  
25 AND A VEHICLE THAT IS LAWFULLY STOPPED OR MOVING IN ORDER TO EXECUTE A  
26 RIGHT TURN AT AN INTERSECTION.

27                                  (3)   A BUS LANE MONITORING SYSTEM MAY BE USED TO RECORD ONLY  
28 THE IMAGES OF VEHICLES THAT ARE TRAVELING IN A BUS LANE.

29                                  (D)   (1)   (I)   A BUS LANE MONITORING SYSTEM OPERATOR SHALL  
30 COMPLETE TRAINING BY THE MANUFACTURER OF THE BUS LANE MONITORING



1 SYSTEM IN THE PROCEDURES FOR SETTING UP, TESTING, AND OPERATING THE BUS  
2 LANE MONITORING SYSTEM.

3 (II) ON COMPLETION OF THE TRAINING, THE MANUFACTURER  
4 SHALL ISSUE A SIGNED CERTIFICATE TO THE BUS LANE MONITORING SYSTEM  
5 OPERATOR.

6 (III) THE CERTIFICATE OF TRAINING SHALL BE ADMITTED AS  
7 EVIDENCE IN ANY COURT PROCEEDING FOR A VIOLATION.

8 (2) A BUS LANE MONITORING SYSTEM OPERATOR SHALL FILL OUT  
9 AND SIGN A DAILY SET-UP LOG FOR EACH BUS LANE MONITORING SYSTEM THAT:

10 (I) STATES THE DATE AND TIME WHEN THE SYSTEM WAS SET  
11 UP;

12 (II) STATES THAT THE BUS LANE MONITORING SYSTEM  
13 OPERATOR SUCCESSFULLY PERFORMED, AND THE DEVICE PASSED, THE  
14 MANUFACTURER-SPECIFIED SELF-TESTS OF THE BUS LANE MONITORING SYSTEM  
15 BEFORE PRODUCING A RECORDED IMAGE;

16 (III) SHALL BE KEPT ON FILE; AND

17 (IV) SHALL BE ADMITTED AS EVIDENCE IN ANY COURT  
18 PROCEEDING FOR A VIOLATION.

19 (E) (1) A BUS LANE MONITORING SYSTEM SHALL UNDERGO AN ANNUAL  
20 CALIBRATION CHECK PERFORMED BY AN INDEPENDENT CALIBRATION  
21 LABORATORY.

22 (2) THE INDEPENDENT CALIBRATION LABORATORY SHALL ISSUE A  
23 SIGNED CERTIFICATE OF CALIBRATION AFTER THE ANNUAL CALIBRATION CHECK  
24 THAT:

25 (I) SHALL BE KEPT ON FILE; AND

26 (II) SHALL BE ADMITTED AS EVIDENCE IN ANY COURT  
27 PROCEEDING FOR A VIOLATION OF § 21-1133 OF THIS SUBTITLE.

28 (F) (1) UNLESS THE DRIVER OF THE MOTOR VEHICLE RECEIVED A  
29 CITATION FROM A POLICE OFFICER AT THE TIME OF THE VIOLATION, THE OWNER  
30 OR, IN ACCORDANCE WITH SUBSECTION (I)(5) OF THIS SECTION, THE DRIVER OF A  
31 MOTOR VEHICLE IS SUBJECT TO A CIVIL PENALTY IF THE MOTOR VEHICLE IS

1 RECORDED BY A BUS LANE MONITORING SYSTEM DURING THE COMMISSION OF A  
2 VIOLATION.

3 (2) A CIVIL PENALTY UNDER THIS SECTION MAY NOT EXCEED ~~\$100~~  
4 \$75.

5 (3) FOR PURPOSES OF THIS SECTION, THE DISTRICT COURT SHALL  
6 PRESCRIBE:

7 (I) A UNIFORM CITATION FORM CONSISTENT WITH  
8 SUBSECTION (G)(1) OF THIS SECTION AND § 7-302 OF THE COURTS ARTICLE; AND

9 (II) A CIVIL PENALTY, WHICH SHALL BE INDICATED ON THE  
10 CITATION, TO BE PAID BY PERSONS WHO CHOOSE TO PREPAY THE CIVIL PENALTY  
11 WITHOUT APPEARING IN DISTRICT COURT.

12 (G) (1) SUBJECT TO THE PROVISIONS OF PARAGRAPHS (2) THROUGH (5)  
13 OF THIS SUBSECTION, THE BALTIMORE CITY POLICE DEPARTMENT OR A  
14 CONTRACTOR OF THE POLICE DEPARTMENT SHALL MAIL TO THE OWNER LIABLE  
15 UNDER SUBSECTION (F) OF THIS SECTION A CITATION THAT SHALL INCLUDE:

16 (I) THE NAME AND ADDRESS OF THE REGISTERED OWNER OF  
17 THE VEHICLE;

18 (II) THE REGISTRATION NUMBER OF THE MOTOR VEHICLE  
19 INVOLVED IN THE VIOLATION;

20 (III) THE VIOLATION CHARGED;

21 (IV) TO THE EXTENT POSSIBLE, THE LOCATION OF THE  
22 VIOLATION;

23 (V) THE DATE AND TIME OF THE VIOLATION;

24 (VI) A COPY OF THE RECORDED IMAGE;

25 (VII) THE AMOUNT OF THE CIVIL PENALTY IMPOSED AND THE  
26 DATE BY WHICH THE CIVIL PENALTY MUST BE PAID;

27 (VIII) A SIGNED STATEMENT BY A POLICE OFFICER EMPLOYED BY  
28 THE BALTIMORE CITY POLICE DEPARTMENT THAT, BASED ON INSPECTION OF THE  
29 RECORDED IMAGES, THE MOTOR VEHICLE WAS BEING OPERATED DURING THE  
30 COMMISSION OF A VIOLATION;

1 (IX) A STATEMENT THAT THE RECORDED IMAGE IS EVIDENCE OF  
2 A VIOLATION; AND

3 (X) INFORMATION ADVISING THE PERSON ALLEGED TO BE  
4 LIABLE UNDER THIS SECTION:

5 1. OF THE MANNER AND TIME IN WHICH LIABILITY AS  
6 ALLEGED IN THE CITATION MAY BE CONTESTED IN THE DISTRICT COURT; AND

7 2. THAT FAILURE TO PAY THE CIVIL PENALTY OR TO  
8 CONTEST LIABILITY IN A TIMELY MANNER IS AN ADMISSION OF LIABILITY AND MAY  
9 RESULT IN REFUSAL OR SUSPENSION OF THE MOTOR VEHICLE REGISTRATION.

10 (2) (I) ~~THE~~ SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH,
