CHAPTER _____

1 AN ACT concerning

2 **Health Insurance – Nonprofit Health Service Plan – Board of Directors**

3 FOR the purpose of altering the required composition of the board of directors of a nonprofit
4 health service plan; and generally relating to nonprofit health service plans.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Insurance**

18 14–115.

1 (d) (1) This subsection applies to a corporation that is:

2 (i) issued a certificate of authority as a nonprofit health service
3 plan; and

4 (ii) the sole member of a corporation issued a certificate of authority
5 as a nonprofit health service plan.

6 (2) The board shall be composed of **AT LEAST 11 MEMBERS AND** no more
7 than 23 members, including:

8 (i) one nonvoting member, who is not a member of the Maryland
9 General Assembly, appointed by and serving at the pleasure of the President of the Senate
10 of Maryland;

11 (ii) one nonvoting member, who is not a member of the Maryland
12 General Assembly, appointed by and serving at the pleasure of the Speaker of the House of
13 Delegates; ~~and~~

14 (iii) **NO MORE THAN 21 VOTING** members selected by the board, in
15 accordance with the bylaws of the corporation ~~including~~; ~~AND~~

16 ~~(iv) two~~, **INCLUDING THREE** consumer members, who **ARE**
17 **COVERED BY THE NONPROFIT HEALTH SERVICE PLAN OR ITS AFFILIATES AT THE**
18 **TIME OF THEIR INITIAL ELECTION TO THE BOARD AND WHO** satisfy the requirements
19 of paragraphs (13), (14), and (15) of this subsection.

20 (3) No more than [four] **FIVE** members of the board may be:

21 (i) licensed health care professionals;

22 (ii) hospital administrators; or

23 (iii) employees of health care professionals or hospitals.

24 (4) To the extent possible, the board shall **SEEK TO** include individuals
25 with **A DIVERSE RANGE OF EXPERIENCE RELEVANT TO THE MISSION OF THE**
26 **CORPORATION AS A NONPROFIT HEALTH SERVICE PLAN AS REQUIRED UNDER §**
27 **14-102 OF THIS SUBTITLE, INCLUDING** experience in **DATA, CONSUMER EXPERIENCE,**
28 **GOVERNMENT PROGRAMS, POPULATION HEALTH, GERIATRICS, DIVERSITY, EQUITY**
29 **AND INCLUSION, AUDIT, HUMAN RESOURCES, BENEFIT CONSULTING, EXECUTIVE**
30 **LEVEL, ACTUARIAL,** accounting, information technology, finance, law, large and small
31 businesses, nonprofit businesses, and organized labor.

32 (13) ~~Of the two consumer members, one shall be a subscriber and one shall~~
33 ~~be a certificate holder~~ **THE THREE CONSUMER MEMBERS SHALL BE EITHER**

1 **SUBSCRIBERS OR CERTIFICATE HOLDERS** of the nonprofit health service plan **OR ITS**
2 **AFFILIATES AT THE TIME OF THEIR INITIAL ELECTION TO THE BOARD.**

3 (14) Each consumer member of the board:

4 (i) shall be a member of the general public;

5 (ii) may not be considered an agent or employee of the State for any
6 purpose; and

7 (iii) is entitled to the same rights, powers, and privileges as the other
8 members of the board.

9 (15) A consumer member of the board may not:

10 (i) be a licensee of or otherwise be subject to regulation by the
11 Commissioner;

12 (ii) be employed by or have a financial interest in:

13 1. a nonprofit health service plan or its affiliates or
14 subsidiaries; or

15 2. a person regulated under this article or the Health –
16 General Article; or

17 (iii) within 3 years before appointment, have been employed by, had
18 a financial interest in, or have received compensation from:

19 1. a nonprofit health service plan or its affiliates or
20 subsidiaries; or

21 2. a person regulated under this article or the Health –
22 General Article.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2022.
