1 AN ACT concerning

2 **Public Schools – Grant Program to Reduce and Compost School Waste**

3 FOR the purpose of establishing the Grant Program to Reduce and Compost School Waste
4 for county boards of education and public schools; requiring the Maryland
5 Association for Environmental and Outdoor Education to review grant applications
6 and select recipients to be awarded grants by the State Department of Education;
7 and generally relating to the Grant Program to Reduce and Compost School Waste.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 **7–129.**

17 **(A) IN THIS SECTION, “PROGRAM” MEANS THE GRANT PROGRAM TO**
18 **REDUCE AND COMPOST SCHOOL WASTE.**

[Brackets] indicate matter deleted from existing law.

1 (B) THERE IS A GRANT PROGRAM TO REDUCE AND COMPOST SCHOOL
2 WASTE WITHIN THE DEPARTMENT.

3 (C) (1) THE PURPOSE OF THE PROGRAM IS TO AWARD GRANTS TO
4 COUNTY BOARDS AND PUBLIC SCHOOLS TO DEVELOP AND IMPLEMENT PROGRAMS
5 FOR REDUCING FOOD WASTE AND TO ESTABLISH COMPOSTING OF PRE- AND
6 POST-CONSUMER WASTE.

7 (2) A COUNTY BOARD OR A PUBLIC SCHOOL MAY APPLY FOR A GRANT
8 UNDER THIS SECTION.

9 (D) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,
10 THE DEPARTMENT SHALL ADMINISTER THE PROGRAM.

11 (2) (I) THE MARYLAND ASSOCIATION FOR ENVIRONMENTAL AND
12 OUTDOOR EDUCATION SHALL REVIEW GRANT APPLICATIONS AND SELECT GRANT
13 AWARDEES UNDER THE PROGRAM.

14 (II) THE DEPARTMENT SHALL AWARD GRANTS TO THE
15 APPLICANTS SELECTED BY THE MARYLAND ASSOCIATION FOR ENVIRONMENTAL
16 AND OUTDOOR EDUCATION.

17 (E) A PROJECT IS ELIGIBLE FOR A GRANT IF IT IS SUBMITTED BY A COUNTY
18 BOARD OR PUBLIC SCHOOL AND WILL:

19 (1) EDUCATE STUDENTS, STAFF, AND PARENTS ON THE CONNECTION
20 BETWEEN FOOD WASTE, CLIMATE, ENVIRONMENT, AND HUNGER;

21 (2) SUPPORT SCHOOL INFRASTRUCTURE TO MEASURE FOOD WASTE
22 AND REDUCTION OF FOOD WASTE;

23 (3) TRAIN AND EDUCATE STUDENTS AND STAFF ON THE
24 IMPLEMENTATION OF FOOD WASTE REDUCTION AND COMPOSTING; AND

25 (4) INCLUDE AT LEAST ONE OF THE FOLLOWING ACTIVITIES:

27 OFFER VERSUS SERVE MODEL IN CAFETERIAS, WHICH ALLOWS STUDENTS TO

 15 SUPPORT LOCAL COMMUNITIES; OR

16 ~~(11)~~ (VIII) ESTABLISH ESTABLISHING ANY OTHER PROGRAM OR
 17 ACTIVITY THAT PREVENTS AND REDUCES FOOD WASTE IN A PUBLIC SCHOOL.

18 (F) TO CARRY OUT THE PURPOSE OF THE PROGRAM, GRANT AWARDS SHALL
 19 BE PRIORITIZED TO THE FOLLOWING PROGRAMS OR SCHOOLS:

20 (1) PROGRAMS THAT WILL BE LED BY STUDENTS;

21 (2) SCHOOLS WITH HIGH NUMBERS OF STUDENTS WHO RECEIVE FREE
 22 AND REDUCED PRICE MEALS;

23 (3) PROGRAMS THAT WILL ~~INVOLVE~~ CONTRACT WITH A SMALL AND
 24 MINORITY- OR VETERAN-OWNED BUSINESS; AND

25 (4) PROGRAMS THAT:

2 THROUGH THE PROGRAM ANNUALLY SHALL REPORT TO THE DEPARTMENT ON
3 PROGRAM OUTCOMES, INCLUDING:

4 (1) THE AMOUNT OF FOOD WASTE PREVENTED, DIVERTED, AND
5 COMPOSTED; AND

6 (2) IMPROVEMENT IN EDUCATION OF STUDENTS AND STAFF ON
7 ENVIRONMENTAL BEST PRACTICES RELATED TO FOOD WASTE MANAGEMENT.

8 (H) ~~(1) (i) THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET
9 BILL AN APPROPRIATION OF AT LEAST \$500,000 FOR THE PROGRAM.~~

10 ~~(ii) THE DEPARTMENT AND MARYLAND ASSOCIATION FOR
11 ENVIRONMENTAL AND OUTDOOR EDUCATION MAY RETAIN A PORTION OF THE
12 FUNDS UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH FOR ADMINISTRATIVE
13 COSTS OF THE PROGRAM.~~

14 ~~(2)~~ THE DEPARTMENT SHALL COORDINATE WITH THE DEPARTMENT
15 OF THE ENVIRONMENT TO IDENTIFY AND APPLY FOR FEDERAL FUNDING THAT MAY
16 BE USED TO SUPPORT THE PROGRAM.

17 (I) ON OR BEFORE DECEMBER 1, 2023, AND EACH DECEMBER 1
18 THEREAFTER, THE DEPARTMENT SHALL REPORT TO THE GENERAL ASSEMBLY, IN
19 ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, ON THE
20 PROGRAM.

21 (J) THE DEPARTMENT MAY ADOPT REGULATIONS NECESSARY TO
22 IMPLEMENT THIS SECTION.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2022. It shall remain effective for a period of 5 years and, at the end of June 30, 2027,
25 this Act, with no further action required by the General Assembly, shall be abrogated and
26 of no further force and effect.
