1 AN ACT concerning

2 **Environment – PFAS Chemicals – Prohibitions and Requirements**
3 **(George “Walter” Taylor Act)**

4 FOR the purpose of altering certain provisions of law establishing a certain prohibition on
5 certain uses of certain fire-fighting foam by prohibiting, on or after a certain date, a
6 person from using, manufacturing, or knowingly selling, offering for sale, or
7 distributing for sale or use certain fire-fighting foam in the State, subject to certain
8 exceptions; prohibiting a certain person from releasing certain foam into the
9 environment in a certain manner and requiring the person to take certain actions
10 and maintain certain documentation; providing for the process for the Department
11 of the Environment, the Attorney General, the State’s Attorney for a county or
12 Baltimore City, a county attorney, or a City Attorney to obtain certain compliance
13 information; providing that a failure to meet certain requirements does not preclude

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

5 (a) In this subtitle the following words have the meanings indicated.

6 (b) “Class B fire–fighting foam” OR “FOAM” means a foam designed for
7 flammable liquid fire.

8 (C) “**INTENTIONALLY ADDED**” MEANS THE ACT OF DELIBERATELY USING A
9 CHEMICAL IN THE FORMATION OF A PRODUCT WHERE THE CHEMICAL’S CONTINUED
10 PRESENCE IS DESIRED IN THE PRODUCT TO PROVIDE A SPECIFIC CHARACTERISTIC.

11 (D) “**PERSONAL PROTECTIVE EQUIPMENT**” MEANS ITEMS DESIGNED,
12 INTENDED, OR MARKETED TO BE WORN BY FIRE–FIGHTING PERSONNEL IN THE
13 PERFORMANCE OF THEIR FIRE AND RESCUE ACTIVITIES, INCLUDING JACKETS,
14 PANTS, SHOES, GLOVES, HELMETS, AND RESPIRATORY EQUIPMENT.

15 [(c) (E) “PFAS chemicals” means, WHEN USED IN FIRE–FIGHTING AGENTS,
16 FIRE–FIGHTING EQUIPMENT, FOOD PACKAGING, AND RUGS AND CARPETS, a class of
17 fluorinated organic chemicals that[:

18 (1) Contain] **CONTAIN** at least one fully fluorinated carbon atom, including
19 perfluoroalkyl and polyfluoroalkyl substances[; and

20 (2) Are designed to be fully functional in Class B fire–fighting foam
21 formulations].

22 (F) “**RUG OR CARPET**” MEANS A THICK FABRIC USED TO COVER A FLOOR,
23 INCLUDING:

24 (1) **COMMERCIAL OR RESIDENTIAL BROADLOOM CARPET; AND**

25 (2) **A PAD OR AN UNDERLAYMENT USED IN CONJUNCTION WITH A**
26 **CARPET.**

27 (G) “**TERMINAL**” MEANS:

28 (1) **A BULK LIQUID STORAGE FACILITY EXCLUSIVELY ENGAGED IN**
29 **THE MERCHANT WHOLESALE DISTRIBUTION OF PETROLEUM PRODUCTS,**
30 **INCLUDING LIQUEFIED PETROLEUM GAS, THAT CONTAINS AT LEAST ONE STORAGE**

1 TANK CONTAINING PETROLEUM PRODUCTS WITH A SURFACE AREA OF 120 SQUARE
2 METERS OR GREATER; OR

3 (2) A FACILITY ENGAGED IN THE DISTRIBUTION OF CRUDE
4 PETROLEUM FROM EXTRACTION OR PROCESSING FACILITIES THAT INCLUDES AT
5 LEAST ONE STORAGE TANK CONTAINING CRUDE PETROLEUM WITH A SURFACE AREA
6 OF 120 SQUARE METERS OR GREATER.

9 Baltimore-Washington International Thurgood Marshall Airport.

10 (b) This subtitle does not restrict:

11 (1) The manufacture, sale, or distribution of Class B fire-fighting foam

13 (2) The discharge or other use of Class B fire-fighting foam that contains
14 intentionally added PFAS chemicals in emergency fire-fighting or fire prevention
15 operations.]

3 **FIRE-FIGHTING FOAM THAT CONTAINS INTENTIONALLY ADDED PFAS CHEMICALS**
4 **IN THE STATE:**

5 **(1) ON OR BEFORE SEPTEMBER 30, 2024, IF THE FIRE-FIGHTING**
6 **FOAM WILL BE USED AT AN AIRPORT, A PORT, A REFINERY, OR A CHEMICAL PLANT;**

7 **(2) ON OR BEFORE DECEMBER 31, 2027, IF THE FIRE-FIGHTING**
8 **FOAM WILL BE USED AT A TERMINAL; AND**

9 **(3) ON OR BEFORE ANY APPLICABLE DATE SPECIFIED IN FEDERAL**
10 **LAW, IF THE FIRE-FIGHTING FOAM WILL BE USED BY A PERSON THAT IS REQUIRED**
11 **TO USE CLASS B FIRE-FIGHTING FOAM THAT CONTAINS INTENTIONALLY ADDED**
12 **PFAS CHEMICALS.**

28 4. **WITHIN 5 DAYS AFTER A RELEASE IN VIOLATION OF**
29 **ITEM (I) OF THIS PARAGRAPH, REPORT THE RELEASE TO THE DEPARTMENT,**
30 **INCLUDING INFORMATION ON THE IDENTITY OF THE FOAM, THE QUANTITY USED,**

28 **DEPARTMENT SHALL PURCHASE TAKE BACK FROM THE FIRE DEPARTMENT CLASS**
29 **B FIRE-FIGHTING FOAM THAT CONTAINS INTENTIONALLY ADDED PFAS**
30 **CHEMICALS FOR THE PRICE THAT THE FIRE DEPARTMENT PAID WHEN IT**
31 **PURCHASED THE FIRE-FIGHTING FOAM.**

32 **(2) THE DEPARTMENT SHALL DISPOSE OF FIRE-FIGHTING FOAM**
33 **PURCHASED RECEIVED UNDER THIS SUBSECTION IN A MANNER CONSISTENT WITH**
34 **THIS SUBTITLE.**

1 **(3) FOR FISCAL YEAR 2024, THE GOVERNOR SHALL INCLUDE IN THE**
2 **ANNUAL BUDGET BILL AN APPROPRIATION OF \$500,000 TO THE DEPARTMENT FOR**

11 **PYROLYSIS, GASIFICATION, THERMAL OXIDATION, ACID RECOVERY FURNACE OR**
12 **OXIDIZER, ORE ROASTER, CEMENT KILN, LIGHTWEIGHT AGGREGATE KILN,**
13 **INDUSTRIAL FURNACE BOILER, AND PROCESS HEATER; OR**

14 **(2) IN A LANDFILL.**

15 **6-1604.1.**

16 **(A) THIS SECTION DOES NOT APPLY TO THE SALE OR RESALE OF A USED RUG**
17 **OR CARPET.**

18 **(B) ON OR AFTER JANUARY 1, ~~2023~~, 2024, A PERSON MAY NOT**
19 **~~MANUFACTURE,~~ MANUFACTURE OR KNOWINGLY SELL, OFFER FOR SALE, OR**
20 **DISTRIBUTE FOR SALE OR USE IN THE STATE A RUG OR CARPET TO WHICH PFAS**
21 **CHEMICALS HAVE BEEN INTENTIONALLY ADDED.**

22 **(C) (1) A PERSON THAT ~~MANUFACTURES, SELLS, OFFERS FOR SALE, OR~~**

10 (i) Sale to a consumer; or

11 (ii) Promotional purposes.

12 (c) **“FOOD PACKAGE” MEANS A PACKAGE THAT IS DESIGNED AND INTENDED**
13 **FOR DIRECT FOOD CONTACT AND IS COMPOSED, IN SUBSTANTIAL PART, OF PAPER,**
14 **PAPERBOARD, OR OTHER MATERIALS ORIGINALLY DERIVED FROM PLANT FIBERS,**
15 **INCLUDING:**

16 (1) **A FOOD OR BEVERAGE PRODUCT THAT IS CONTAINED IN A FOOD**
17 **PACKAGE OR TO WHICH A FOOD PACKAGE IS APPLIED;**

18 (2) **A PACKAGING COMPONENT OF A FOOD PACKAGE; AND**

19 (3) **PLASTIC DISPOSABLE GLOVES USED IN COMMERCIAL OR**
20 **INSTITUTIONAL FOOD SERVICE.**

21 (d) **“INTENTIONALLY ADDED” MEANS THE ACT OF DELIBERATELY USING A**
22 **CHEMICAL IN THE FORMATION OF A PACKAGE OR PACKAGING COMPONENT WHEN**
23 **THE CHEMICAL’S CONTINUED PRESENCE IS DESIRED IN THE FINAL PACKAGE OR**
24 **PACKAGING COMPONENT TO PROVIDE A SPECIFIC CHARACTERISTIC.**

25 [(c)] (e) (1) “Manufacturer” means any person that manufactures a package
26 or packaging component.

27 (2) “Manufacturer” includes any person that sells a package or packaging
28 component to a distributor.

1 [(d)] (F) (1) “Package” means a container used to market, protect, or handle
2 a product.

3 (2) “Package” includes:

4 (i) A unit package, an intermediate package, and a shipping
5 container as defined by the American Society for Testing and Materials; and

6 (ii) An unsealed receptacle such as a carrying case, crate, cup, pail,
7 rigid foil or other tray, wrap, wrapping film, bag, and tub.

8 [(e)] (G) (1) “Packaging component” means any individual assembled part of
9 a package.

10 (2) “Packaging component” includes any interior or exterior blocking,
11 bracing, cushioning, weatherproofing, coating, closure, label, ink, dye, pigment, adhesive,
12 or any other additive.

13 (3) “Packaging component” does not include any package or packaging
14 component that contains cadmium and is intended for reuse more than 5 times.

15 **(H) “PFAS CHEMICALS” MEANS, WHEN USED IN FIRE-FIGHTING AGENTS,**
16 **FIRE-FIGHTING EQUIPMENT, FOOD PACKAGING, AND RUGS AND CARPETS, A CLASS**
17 **OF FLUORINATED ORGANIC CHEMICALS THAT CONTAIN AT LEAST ONE FULLY**
18 **FLUORINATED CARBON ATOM, INCLUDING PERFLUOROALKYL AND**
19 **POLYFLUOROALKYL SUBSTANCES.**

20 9–1902.

21 (a) Except as provided in §§ 9–1903 and 9–1904 of this subtitle, on or after July
22 1, 1993, a manufacturer or distributor may not sell or offer for sale or for promotional
23 purposes any package or packaging component or any product in a package or packaging
24 component to which any of the following was intentionally added during manufacture or
25 distribution:

26 (1) Lead;

27 (2) Cadmium;

28 (3) Mercury; or

29 (4) Hexavalent chromium.

30 (b) The sum of the concentration levels of lead, cadmium, mercury, and
31 hexavalent chromium incidentally present in a package or packaging component may not
32 exceed:

1 (1) By July 1, 1993, 600 parts per million by weight or 0.06%;

2 (2) By July 1, 1994, 250 parts per million by weight or 0.025%; and

3 (3) By July 1, 1995, 100 parts per million by weight or 0.01%.

4 (c) Tin plated steel that meets the American Society for Testing and Materials
5 Specification A-623 shall be considered a single packaging component.

6 (D) ON OR AFTER JANUARY 1, ~~2023~~, 2024, A MANUFACTURER OR
7 DISTRIBUTOR MAY NOT MANUFACTURE, OR KNOWINGLY SELL, OFFER FOR SALE, OR
8 DISTRIBUTE FOR SALE OR USE IN THE STATE A FOOD PACKAGE OR FOOD PACKAGING
9 COMPONENT DESIGNED AND INTENDED FOR DIRECT FOOD CONTACT TO WHICH
10 PFAS CHEMICALS WERE INTENTIONALLY ADDED.

11 9-1903.

12 The provisions of **§ 9-1902(A) THROUGH (C) OF** this subtitle do not apply to:

13 (1) If it contains a code indicating the date of manufacture, a package or
14 packaging component that was manufactured prior to July 1, 1993;

15 (2) Until July 1, 1997, a package and packaging component that would not
16 exceed the concentration levels set forth in § 9-1902 of this subtitle but for the addition of
17 recycled materials;

18 (3) A package or packaging component conditionally exempt under §
19 9-1904 of this subtitle; and

20 (4) Any alcoholic beverage bottled before October 1, 1992.

21 9-1904.

22 (a) A manufacturer or distributor of a package or packaging component may
23 submit to the Department an application for a conditional exemption from the provisions
24 of **§ 9-1902(A) THROUGH (C) OF** this subtitle.

25 (b) On the written application of a manufacturer or distributor, the Department
26 may grant a conditional exemption if the Department finds that:

27 (1) In order to comply with a health or safety requirement of federal law,
28 lead, cadmium, mercury, or hexavalent chromium have been added to the package or
29 packaging component in the manufacturing, forming, printing, or distribution process; or

1 (2) The regulated substance is essential to the protection, safe handling, or
2 function of the package contents.

3 (c) A conditional exemption granted under this section:

4 (1) Expires 2 years after the date the Department grants the exemption;
5 and

6 (2) If the manufacturer or distributor meets the criteria under subsection
7 (b) of this section, may be renewed for additional periods of 2 years.

8 9–1905.

9 (a) To enforce the provisions of this subtitle, the Department may:

10 (1) Notify a manufacturer that there are grounds for suspecting that a
11 package or packaging component produced by the manufacturer may not be in compliance
12 with the provisions of this subtitle; and

13 (2) Request the manufacturer to certify that the package or packaging
14 component is in compliance, **INCLUDING BY REQUESTING THE MANUFACTURER’S**
15 **CERTIFICATE OF COMPLIANCE ESTABLISHED UNDER SUBSECTION (C) OF THIS**
16 **SECTION.**

17 (b) If the manufacturer certifies that the package or packaging component is
18 exempt under § 9–1903 of this subtitle, the manufacturer shall identify the specific basis
19 on which the exemption is claimed.

20 **(C) (1) A MANUFACTURER ~~OR DISTRIBUTOR~~ THAT MANUFACTURES,**
21 **SELLS, OFFERS FOR SALE, OR DISTRIBUTES FOR USE IN THE STATE A FOOD PACKAGE**
22 **OR FOOD PACKAGING COMPONENT SHALL ESTABLISH A CERTIFICATE OF**
23 **COMPLIANCE TO ATTEST THAT THE FOOD PACKAGE OR FOOD PACKAGING**
24 **COMPONENT IS IN COMPLIANCE WITH THE REQUIREMENTS OF § 9–1902(D) OF THIS**
25 **SUBTITLE.**

26 **(2) WITHIN 30 DAYS AFTER A REQUEST BY THE DEPARTMENT, A**
27 **MANUFACTURER SHALL PROVIDE THE CERTIFICATE OF COMPLIANCE ESTABLISHED**
28 **UNDER PARAGRAPH (1) OF THIS SUBSECTION TO THE DEPARTMENT.**

29 **[(c)] (D)** If the manufacturer ~~OR DISTRIBUTOR~~ fails to certify that the package
30 or packaging component is in compliance or is exempt, the Department may seek an
31 injunction under § 9–1906 of this subtitle to require the manufacturer ~~OR DISTRIBUTOR~~
32 to withdraw the package or packaging component in question from sale or promotional use
33 within the State.

34 SECTION 2. AND BE IT FURTHER ENACTED, That:

1 (a) On or before December 31, 2022, the Department of the Environment shall
2 report to the General Assembly, in accordance with § 2–1257 of the State Government
3 Article, on:

4 (1) the location and results of any testing for PFAS chemicals, as defined
5 in § 6–1601 of the Environment Article, that the Department has conducted on waters of
6 the State;

7 (2) any plan the Department has for further testing for PFAS chemicals in
8 waters of the State; and

9 (3) any plan the Department has for remediation and public education in
10 areas where the water has been found to be contaminated by PFAS chemicals.

11 (b) On or before December 31, 2023, the Department of the Environment and the
12 Maryland Department of Health jointly shall prepare, in coordination with other relevant
13 State agencies, the federal government, local governments, and the public, and submit to
14 the General Assembly, in accordance with § 2–1257 of the State Government Article, a
15 PFAS Action Plan to identify strategies, actions, and funding alternatives to:

16 (1) minimize environmental exposure to PFAS chemicals for Maryland
17 residents, in addition to regulating its use in fire-fighting foam, food packaging and food
18 packaging components, rugs, and carpets;

19 (2) minimize future releases of PFAS chemicals into the environment;

20 (3) identify, assess, and clean up historical releases of PFAS chemicals in
21 Maryland;

22 (4) assess any concerns related to environmental justice, health equity, and
23 PFAS chemical contamination; and

24 (5) educate and communicate to Maryland residents the risks associated
25 with PFAS chemicals.

26 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
27 1, 2022.
