CHAPTER _____

1 AN ACT concerning

2 **Hate Crimes – Civil Remedy**

3 FOR the purpose of providing that a person who is the victim of an act that would constitute
4 a violation of certain hate crime laws may bring a civil action against a certain
5 person; and generally relating to the right to file a civil action for a hate crime.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Criminal Law**

14 **10–309.**

15 (A) A PERSON WHO IS THE VICTIM OF AN ACT THAT WOULD CONSTITUTE A
16 VIOLATION OF THIS SUBTITLE MAY BRING A CIVIL ACTION AGAINST THE PERSON OR
17 PERSONS WHO COMMITTED THE ACT IN A COURT OF COMPETENT JURISDICTION.

18 (B) THE COURT MAY:

1 **(1) ISSUE AN INJUNCTION TO PREVENT OR RESTRAIN AN ACT THAT**
2 **WOULD CONSTITUTE A VIOLATION OF THIS SUBTITLE; AND**

3 **(2) AWARD DAMAGES IN ACCORDANCE WITH SUBSECTION (C) OF THIS**
4 **SECTION.**

5 **(C) (1) DAMAGES AWARDED BY A COURT UNDER THIS SECTION MAY**
6 **INCLUDE:**

7 **(I) ECONOMIC DAMAGES AND ANY OTHER PECUNIARY LOSS**
8 **SUSTAINED BY THE PLAINTIFF THAT WAS PROXIMATELY CAUSED BY THE VIOLATION**
9 **OF THIS SUBTITLE; AND**

10 **(II) NONECONOMIC DAMAGES, INCLUDING:**

11 1. **PAIN AND SUFFERING;**

12 2. **SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION,**
13 **EMOTIONAL DISTRESS;**

14 3. **SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION,**
15 **MENTAL ANGUISH;**

16 4. **LOSS OF ENJOYMENT;**

17 5. **LOSS OF COMPANIONSHIP, SERVICES, AND**
18 **CONSORTIUM; AND**

19 6. **OTHER NONPECUNIARY LOSS SUSTAINED BY THE**
20 **PLAINTIFF THAT WAS PROXIMATELY CAUSED BY THE ACT THAT WOULD CONSTITUTE**
21 **A VIOLATION OF THIS SUBTITLE.**

22 **(2) THE COURT MAY ALSO AWARD REASONABLE ATTORNEY'S FEES**
23 **AND COURT COSTS TO A PREVAILING PLAINTIFF.**

24 **(3) NONECONOMIC DAMAGES UNDER PARAGRAPH (1)(II)2 AND 3 OF**
25 **THIS SUBSECTION MAY NOT INCLUDE EMOTIONAL DISTRESS OR MENTAL ANGUISH**
26 **CAUSED SOLELY BY THE NEED TO REPLACE OR REPAIR PERSONAL OR REAL**
27 **PROPERTY.**

28 **(D) DAMAGES AWARDED BY A COURT UNDER SUBSECTION (C)(1) OF THIS**
29 **SECTION MAY BE EQUAL TO THREE TIMES THE AMOUNT OF ACTUAL DAMAGES.**

1 **(E) THIS SECTION DOES NOT AFFECT ANY LEGAL OR EQUITABLE RIGHT OR**
2 **REMEDY OTHERWISE PROVIDED BY LAW.**

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to
4 apply only prospectively and may not be applied or interpreted to have any effect on or
5 application to any cause of action arising before the effective date of this Act.

6 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 October 1, 2022.
