1 AN ACT concerning

2 **Public Service Commission – Reporting Requirements**

3 FOR the purpose of altering the date by which the Public Service Commission must submit
4 a report on the status of a certain net metering program; repealing a reporting
5 requirement on customer education about competitive electricity supply; and
6 generally relating to reporting requirements of the Public Service Commission.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Public Utilities**

4 1–101.

5 (a) In this division the following words have the meanings indicated.

6 (d) “Commission” means the Public Service Commission.

7 7–306.

8 (i) On or before [September] **NOVEMBER** 1 of each year, the Commission shall
9 report to the General Assembly, in accordance with § 2–1257 of the State Government
10 Article, on the status of the net metering program under this section, including:

11 (1) the amount of capacity of electric generating facilities owned and
12 operated by eligible customer–generators in the State by type of energy resource;

13 (2) based on the need to encourage a diversification of the State’s energy
14 resource mix to ensure reliability, whether the rated generating capacity limit in subsection
15 (d) of this section should be altered; and

16 (3) other pertinent information.

17 7–510.1.

18 [(f) On or before December 31 of each year, the Commission shall report, in
19 accordance with § 2–1257 of the State Government Article, to the General Assembly on the
20 status and success of the Commission’s efforts to educate customers about customer choice
21 under this section.]

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
23 1, 2022.
