16 WHEREAS, The Prince George's County Board of Education has transitioned
 17 between different board structures; and

18 WHEREAS, There is strong support across Prince George's County for an all-elected
 19 board of education and a recommendation from the County Executive's Task Force to
 20 transition toward an all-elected board; and

21 WHEREAS, There are unanswered questions about how to structure electoral
 22 procedures to optimize board of education outcomes and renew our focus on Prince George's
 23 County students and families; and

24 WHEREAS, Stakeholders across the education sector have explained that a change
 25 in the structure of the board of education alone will not serve as a solution to issues with
 26 the board; and

27 WHEREAS, Clarifying roles and responsibilities of members of the board of
 28 education was highlighted as a critical component of any solution to the current issues with
 29 the board, including addressing distinctions between the duties of the board and the Chief
 30 Executive Officer; and

31 WHEREAS, Other issues surrounding appropriate training, oversight, and
 32 accountability measures for the board of education require further investigation and these
 33 issues will be critical to any solution the legislature considers; now, therefore,

34 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 35 That:

1 (a) There is a Workgroup on the Membership and Operation of the Prince
2 George's County Board of Education.

3 (b) The Workgroup consists of the following members:

4 (1) the Chair of the Prince George's County Senate Delegation, or the
5 Chair's designee;

6 (2) one member of the Senate of Maryland who represents Prince George's
7 County, appointed by the Chair of the Prince George's County Senate Delegation;

8 (3) the Chair of the Prince George's County House Delegation, or the
9 Chair's designee;

10 (4) one member of the House of Delegates who represents Prince George's
11 County, appointed by the Chair of the Prince George's County House Delegation;

12 ~~(5) the Chair of the Prince George's County Board of Education, or the~~
13 ~~Chair's designee;~~

14 (5) one member of the Prince George's County Council, appointed by the
15 Chair of the Prince George's County Council;

16 ~~(6) the Chief Executive Officer of the Prince George's County Public School~~

15 (2) is entitled to reimbursement for expenses under the Standard State
 16 Travel Regulations, as provided in the State budget.

17 (f) The Workgroup shall study and make recommendations regarding the Prince
 18 George's County Board of Education as to:

28 (v) minimizing politicization of the process and renewing a focus on

3 reflects the gender and racial diversity of Prince George's County;

4 (2) appropriate compensation for Board members and an appropriate
5 scholarship for the student member, including an assessment of current staffing and budget
6 needs for members of the Board;

7 (3) an appropriate phase-in period for any recommended changes to the
8 existing Board composition Board;

10 ~~Prince George's County;~~

11 ~~(5)~~ criteria that improve Board results, accountability, transparency, and
12 oversight, including:

13 (i) evaluating best practices for mandatory continuing education
14 requirements for members of the Board and a required annual retreat focused on additional
15 training, goal-setting, and evaluating Board results;

16 (ii) investigating course options provided by:

17 1. the National School Board Association;

18 2. the Council on Urban Boards of Education; or

19 3. other reputable organizations that provide training in
20 board governance and best practices; and

21 (iii) clarifying the roles and responsibility of members of the Board
22 and the distinctions between the roles of CEO and member of the Board;

23 (5) the establishment and use of advisory committees, when deemed
24 appropriate by members of the Board;

25 (6) the appropriate removal authority and mechanisms for members of the
26 Board, including:

27 (i) the feasibility of establishing an ethics panel process;

28 (ii) guidelines for how an ethics complaint should be processed;

29 (iii) actions that may be taken based on the findings of an ethics
30 complaint; and

1 (iv) removal of the Governor from the oversight process;

2 ~~(6)~~ (7) criteria for establishing and measuring Board outcomes;

3 ~~(7)~~ (8) a protocol for Board audits and addressing audit findings; and

4 ~~(8)~~ (9) any other relevant issues.

5 (g) (1) The Workgroup shall hold at least three public meetings in
6 geographically diverse areas of Prince George's County that allow members of the general
7 public and stakeholder organizations to testify on issues being studied by the Workgroup.

8 (2) The Workgroup shall extend an invitation to representatives from the
9 following stakeholder organizations to testify at a public meeting:

10 (i) the Prince George's County Educators' Association;

11 (ii) the Prince George's County SEIU Local 400;

12 (iii) the Prince George's County Association of Supervisory and

 12 of the county board shall be a combination of members who are elected and appointed.

13 (d) In Caroline County, in accordance with Subtitle 3A of this title, the members
 14 of the county board shall be a combination of members who are elected and appointed.

15 (e) In Harford County, in accordance with Subtitle 6A of this title, the members
 16 of the county board shall be a combination of members who are elected and appointed.

17 (f) [In Prince George's County, in accordance with Subtitle 10 of this title, the
 18 members of the county board shall be a combination of members who are elected and
 19 appointed.

20 (g) An individual subject to the authority of the county board may not serve as a
 21 member of the county board. At the time of filing a certificate of candidacy for election to a
 22 county board, a person shall certify to the local board of supervisors of elections whether or
 23 not the person is subject to the authority of the county board. The Governor may not issue
 24 a commission of election to a person who has certified affirmatively and who is elected to a
 25 county board until the member–elect offers proof that the member–elect is no longer subject
 26 to the authority of the county board.

27 [(h)] (G) The election of the county boards shall be held as provided in Subtitles
 28 2 through 14 of this title and the Election Law Article.

30 (a) [(1)] In this subtitle [the following words have the meanings indicated.

1 (2) “Appointed member” means a member of the Prince George’s County
2 Board appointed under subsection (f) of this section.

3 (3) “Elected], “ELECTED member” means a member of the Prince George’s
4 County Board elected from one of the nine school board districts described in § 3–1001 of
5 this subtitle.

6 (b) The Prince George’s County Board consists of [14] 10 members as follows:

7 (1) Nine elected members, each of whom resides in a different school board
8 district; AND

9 [(2) Four appointed members; and]

10 [(3)] (2) One student member selected under subsection [(g)(2)] (F)(2) of
11 this section.

12 (c) (1) One member of the county board shall be elected from each of the nine
13 school board districts described in § 3–1001 of this subtitle.

14 (2) From the time of filing as a candidate for election, each candidate shall
15 be a registered voter of the county and a resident of the school board district the candidate
16 seeks to represent.

17 (3) An elected [county board] member shall forfeit the office if the member:

18 (i) Fails to reside in the school board district from which the
19 member was elected, unless this change is caused by a change in the boundaries of the
20 district; or

21 (ii) Fails to be a registered voter of the county.

22 (4) A [county board] member may not hold another office of profit in county
23 government during the member’s term.

24 (5) Each elected member of the county board shall be nominated by the
25 registered voters of the member’s school board district.

26 (d) The elected members of the county board shall be elected:

27 (1) At the general election every 4 years [as required by subsection (h) of
28 this section]; and

29 (2) By the voters of the school board district that each member represents.

1 (e) (1) If a candidate for the county board dies or withdraws the candidacy
2 during the period beginning with the date of the primary and ending 70 days before the
3 date of the general election, the Board of Elections shall:

4 (i) Replace the name of the deceased or withdrawn candidate on the
5 ballot for the general election with the name of the candidate who received the next highest
6 number of votes in the primary election; or

7 (ii) If a contested primary was not held, reopen the filing process to
8 allow other persons to file as candidates.

9 (2) (i) Except as otherwise provided in subparagraph (ii) of this
10 paragraph, the Board of Elections shall add to the ballot for the general election the name
11 of any person who files as a candidate in accordance with paragraph (1)(i) of this
12 subsection.

13 (ii) The Board of Elections may not add additional candidates to the
14 ballot for the general election within 70 days before the date of the election.

15 [(f) (1) The appointed members of the county board shall be appointed as
16 follows:

17 (i) Three members shall be appointed by the County Executive of
18 Prince George's County as follows:

19 1. One member shall possess a high level of knowledge and
20 expertise concerning education;

21 2. One member shall possess a high level of business,
22 finance, or higher education experience; and

23 3. One member shall possess a high level of knowledge and
24 expertise concerning the successful administration of a large business, nonprofit, or
25 governmental entity; and

26 (ii) The Prince George's County Council shall appoint one member
27 who is a parent of a student enrolled in the Prince George's County public school system as
28 of the date of the appointment of the member.

29 (2) Each appointed member of the county board shall be a resident of
30 Prince George's County.]

31 [(g)] (F) (1) The student member shall be an eleventh or twelfth grade
32 student in the Prince George's County public school system during the student's term in
33 office.

1 (2) An eligible student shall file a nomination form at least 2 weeks before
2 a special election meeting of the Prince George's Regional Association of Student
3 Governments. Nomination forms shall be made available in the administrative offices of all
4 public senior high schools in the county, the office of student concerns, and the office of the
5 president of the regional association. The delegates to the regional association annually
6 shall elect the student member to the board at a special election meeting to be held each
7 school year.

8 (3) The student member may vote on all matters before the board except
9 those relating to:

10 (i) Capital and operating budgets;

11 (ii) School closings, reopenings, and boundaries;

12 (iii) Collective bargaining decisions;

13 (iv) Student disciplinary matters;

14 (v) Teacher and administrator disciplinary matters as provided
15 under § 6-202(a) of this article; and

16 (vi) Other personnel matters.

17 (4) On an affirmative vote of a majority of the elected [and appointed]
18 members of the county board, the board may determine if a matter before the board relates
19 to a subject that the student member may not vote on under paragraph (3) of this
20 subsection.

21 (5) Unless invited to attend by an affirmative vote of a majority of the
22 elected [and appointed] members of the county board, the student member may not attend
23 an executive session that relates to hearings on appeals of special education placements,
24 hearings held under § 6-202(a) of this article, or collective bargaining.

25 (6) The Prince George's Regional Association of Student Governments may
26 establish procedures for the election of the student member of the county board.

27 (7) The election procedures established by the Prince George's Regional
28 Association of Student Governments are subject to the approval of the elected [and
29 appointed] members of the county board.

30 [(h)] (G) (1) [Except as provided in paragraph (2) of this subsection, an] AN
31 elected member serves for a term of 4 years beginning on the first Monday in December
32 after the member's election and until the member's successor is elected and qualifies.

33 [(2) The terms of the elected members are staggered as follows:

1 (i) The five elected members who received the lowest percentage of
2 votes, as determined by the final vote count of the 2010 General Election as certified by the
3 Board of Elections, shall serve for a term of 2 years; and

4 (ii) The other four members elected in the 2010 General Election
5 shall serve for a term of 4 years.

6 (3) Except as provided in paragraph (4) of this subsection, an appointed
7 member:

8 (i) Serves for a term of 4 years beginning on the date of
9 appointment;

10 (ii) May be reappointed; and

11 (iii) Serves until a successor is appointed and qualifies.

12 (4) The terms of the appointed members are staggered as follows:

13 (i) The members appointed under subsection (f)(1)(i)1 and 2 of this
14 section on or before June 1, 2013, shall serve for an initial term of 4 years; and

15 (ii) The member appointed under subsection (f)(1)(i)3 and (ii) of this
16 section on or before June 1, 2013, shall serve for an initial term of 2 years.]

17 ~~[(5)]~~ (2) The student member serves for a term of 1 year beginning at the
18 end of a school year.

19 ~~[(6)]~~ (3) (i) Subject to subparagraph (ii) of this paragraph, if a seat
20 held by an elected member of the county board becomes vacant, the County Executive shall:

21 1. Appoint a qualified individual to fill the seat for the
22 remainder of the term; and

23 2. Transmit the name of the appointee to the clerk of the
24 County Council.

25 (ii) If the County Council does not disapprove an appointment under
26 subparagraph (i) of this paragraph by a two-thirds vote of all members of the County
27 Council within 45 days after the transmittal of the name of the appointee, the appointment
28 shall be considered approved.

29 ~~[(i)]~~ (H) (1) With the approval of the Governor, the State Board may remove
30 a member of the county board for any of the following reasons:

1 (i) Immorality;

2 (ii) Misconduct in office;

3 (iii) Incompetency; or

4 (iv) Willful neglect of duty.

5 (2) Before removing a member, the State Board shall send the member a
6 copy of the charges pending and give the member an opportunity within 10 days to request
7 a hearing.

8 (3) If the member requests a hearing within the 10-day period:

9 (i) The State Board promptly shall hold a hearing, but a hearing
10 may not be set within 10 days after the State Board sends the member a notice of the
11 hearing; and

12 (ii) The member shall have an opportunity to be heard publicly
13 before the State Board in the member's own defense, in person or by counsel.

14 (4) A member removed under this subsection has the right to judicial
15 review of the removal by the Circuit Court for Prince George's County based on an
16 administrative record and such additional evidence as would be authorized by § 10-222(f)
17 and (g) of the State Government Article.

18 ~~[(j)]~~ (I) While serving on the county board, a member may not be a candidate
19 for a public office other than a position on the county board.

21 (a) (1) From and after December 4, 2006, at the beginning of each member's
22 full term, the chair of the county board is entitled to receive \$19,000 annually as
23 compensation and the other elected [and appointed] members are each entitled to receive
24 \$18,000 annually as compensation.

25 (2) Each elected [and appointed] member of the county board may be
26 provided health insurance and other fringe benefits regularly provided to employees of the
27 Board of Education under the same terms and conditions extended to other employees of
28 the Board of Education.

29 (b) (1) After submitting vouchers under the rules and regulations adopted by
30 the county board, the chair and the other members, including the student member, are
31 entitled to the allowances for travel and other expenses provided in the Prince George's
32 County budget.

1 (2) A member of the county board may not be reimbursed more than \$7,000
2 in travel and other expenses incurred in a single fiscal year.

3 (c) The county board may not issue a credit card to a member of the county board.
4 3-1004.

5 (a) (1) [Beginning on December 5, 2022, the] THE county board shall elect a
6 chair and vice chair of the county board from among the ELECTED members of the county
7 board.

8 (2) The term of the chair and vice chair appointed under this subsection
9 shall be 2 years.

10 (b) Subject to the provisions of § 4-403 of this article, the affirmative vote of the
11 members of the county board for the passage of a motion by the county board shall be:

12 (1) Except as otherwise provided in item (2) of this subsection:

13 (i) [Eight] SIX members when the student member is voting; or

14 (ii) [Seven] FIVE members when the student member is not voting;

15 or

16 (2) When there are two or more vacancies on the county board:

17 (i) [Seven] FIVE members when the student member is voting; or

18 (ii) [Six] FOUR members when the student member is not voting.

19 (c) At the beginning of each term, each Board member shall attend an orientation
20 and be provided with training materials that clarify the role of a member.

21 SECTION 4. AND BE IT FURTHER ENACTED, That Section 3 of this Act shall take
22 effect July 1, 2024.

23 SECTION ~~2~~ 5. AND BE IT FURTHER ENACTED, That, except as provided in
24 Section 4 of this Act, this Act shall take effect July 1, 2022. ~~§~~ Section 1 of this Act shall
25 remain effective for a period of 1 year and 6 months and, at the end of December 31, 2023,
26 Section 1 of this Act, with no further action required by the General Assembly, shall be
27 abrogated and of no further force and effect.
