A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Corps Program – Revisions**

3 FOR the purpose of altering certain purposes of the Maryland Corps Program; establishing
4 that the Program is exempt from certain provisions of law relating to procurement
5 but is subject to a certain review by the Office of Legislative Audits; altering the
6 membership of the Board of Directors of the Program; establishing that the Board is
7 a body politic and corporate and is an instrumentality of the State; requiring the
8 Board to meet with a certain regularity and that Board meetings are subject to the
9 Open Meetings Act; requiring the Board to appoint an Executive Director and
10 authorizing the Board to employ certain staff; establishing that Board staff are State
11 employees for the purposes of certain provisions of law; establishing that the Board
12 and certain staff are subject to the Public Ethics Law; repealing a requirement that
13 the Governor’s Office on Service and Volunteerism provide certain staff and support
14 to the Board; repealing certain qualifications for an individual to participate in the
15 Program; repealing a requirement that the Board issue a certain request for
16 proposals for an operator for the Program; establishing certain goals for the Program;
17 establishing certain powers of the Board; requiring the Board to act as an
18 intermediary with the AmeriCorps Program for a certain purpose; altering certain
19 purposes of the Maryland Corps Program Fund; requiring the Governor to include
20 certain appropriations to the Fund in certain annual budget bills; establishing the
21 intent of the General Assembly with regard to certain federal funding; altering the
22 uses of certain appropriations; requiring certain marketing and recruitment to
23 prioritize certain institutions; requiring a public senior education institution to
24 waive the in-State residency requirement for an individual who has completed a
25 service program under the Program; providing for the staggering of the terms of
26 certain members of the Board; requiring certain members of the Board to be
27 appointed on or before a certain date; and generally relating to the Maryland Corps
28 Program.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Education**

22 15–106.9.

23 (a) In this section, “residency requirement” means the requirement of a public
24 senior higher education institution that a student has resided in the State for 12
25 consecutive months to be considered a resident and receive in–State tuition status.

26 (b) For in–State tuition purposes, a public senior higher education institution
27 shall waive the in–State residency requirement for an individual who has completed [all]:

28 **(1) ALL service hours for an AmeriCorps Program in the State; OR**

29 **(2) A SERVICE PROGRAM UNDER THE MARYLAND CORPS PROGRAM**
30 **UNDER TITLE 24, SUBTITLE 11 OF THIS ARTICLE.**

31 (c) A student is responsible for the difference between in–State and out–of–state
32 tuition if the student does not retain residence in the State for the remainder of the school
33 year for which in–State tuition was received.

- 1 (a) In this subtitle the following words have the meanings indicated.
- 2 (b) “Board” means the Board of Directors of the Program.
- 3 (c) “Corps participant” means an individual who participates in the Program
4 [and:
- 5 (1) Is between the ages of 17 years old and 23 years old;
- 6 (2) Is eligible for in-State tuition;
- 7 (3) Has obtained a high school diploma or GED; and
- 8 (4) Has not obtained a vocational certificate, an associate’s degree, or a
9 bachelor’s degree from an institution of higher education].
- 10 (d) “Fund” means the Maryland Corps Program Fund.
- 11 **(E) “PARTICIPATING ORGANIZATION” MEANS A NONPROFIT ORGANIZATION**
12 **OR GOVERNMENT AGENCY THAT:**
- 13 **(1) HAS A FOCUS ON COMMUNITY OR OTHER SERVICE, SERVICE**
14 **LEARNING, VOLUNTEERISM, OR OTHER ACTIVITIES OR EXPERIENCES WITH A**
15 **SIMILAR MISSION; AND**
- 16 **(2) HOSTS A PROGRAM PARTICIPANT IN A SERVICE ROLE.**
- 17 **[(e)] (F) “Program” means the Maryland Corps Program.**
- 18 **(G) “WRAPAROUND SERVICES” INCLUDES:**
- 19 **(1) CHILD CARE;**
- 20 **(2) TRANSPORTATION;**
- 21 **(3) HOUSING;**
- 22 **(4) MENTAL HEALTH;**
- 23 **(5) CRISIS INTERVENTION;**
- 24 **(6) SUBSTANCE ABUSE PREVENTION OR TREATMENT;**
- 25 **(7) LEGAL AID;**

- 1 **(8) FINANCIAL LITERACY PROGRAMMING;**
2 **(9) JOB SEARCH AND APPLICATION SUPPORT; AND**
3 **(10) COLLEGE APPLICATION SUPPORT.**

5 (a) There is a Maryland Corps Program in the State administered and managed
6 by the Board.

7 **(B) EXCEPT AS PROVIDED IN TITLE 14, SUBTITLE 3 OF THE STATE FINANCE**
8 **AND PROCUREMENT ARTICLE, THE PROGRAM IS EXEMPT FROM DIVISION II OF THE**
9 **STATE FINANCE AND PROCUREMENT ARTICLE.**

10 **[(b)] (C)** The purpose of the Program is to:

11 (1) Provide meaningful service opportunities to [at least 100 corps]
12 participants that will address the social needs of the community;

13 (2) Equip corps participants with the skills that will enable them to
14 successfully make the transition from high school to an institution of higher education **OR**
15 **TO THE WORKFORCE;** and

16 (3) Provide scholarships to corps participants who have completed the
17 Program to be used at institutions of higher education toward vocational certificates,
18 associate's degrees, or bachelor's degrees.

19 **(D) THE PROGRAM IS SUBJECT TO REVIEW UNDER § 2-1220 OF THE STATE**
20 **GOVERNMENT ARTICLE.**

22 (a) **(1)** A Board of Directors shall administer and manage the Program.

23 **(2) THE BOARD IS A BODY POLITIC AND CORPORATE AND IS AN**
24 **INSTRUMENTALITY OF THE STATE.**

25 (b) The Board consists of the following members:

26 (1) **A BOARD CHAIR, JOINTLY APPOINTED BY THE PRESIDENT OF**
27 **THE SENATE AND THE SPEAKER OF THE HOUSE;**

28 **(2)** Two members appointed by the President of the Senate, **ONE OF WHOM**

1 **MUST REPRESENT A SERVICE ORGANIZATION IN THE STATE;**

2 **[(2)] (3)** Two members appointed by the Speaker of the House, **ONE OF**
3 **WHOM SHALL:**

4 **(I) BE A CURRENT PARTICIPANT IN A PUBLIC SERVICE**
5 **PROGRAM; OR**

6 **(II) HAVE ENDED THEIR PARTICIPATION IN A PUBLIC SERVICE**
7 **PROGRAM DURING THE PRECEDING 3 YEARS; and**

8 **[(3)] (4)** **[Three] TWO** members appointed by the Governor, **ONE OF**
9 **WHOM SHALL BE A REPRESENTATIVE FROM THE GOVERNOR'S OFFICE OF SERVICE**
10 **AND VOLUNTEERISM.**

11 (c) In making appointments to the Board, the President, Speaker, and Governor
12 shall consider:

13 (1) The professional or personal experience of the individual in community
14 or other service, nonprofit management, civic engagement, or volunteerism; and

15 (2) The cultural, geographic, racial, ethnic, and gender diversity of the
16 State.

17 (d) A member of the Board:

18 (1) May not receive compensation as a member of the Board; but

19 (2) Is entitled to reimbursement for expenses under the Standard State
20 Travel Regulations, as provided in the State budget.

21 (e) (1) The term of a member of the Board is 4 years.

22 (2) The terms of the members are staggered as required by the terms
23 provided for members on June 1, **[2016] 2022.**

24 (3) At the end of a term, a member continues to serve until a successor is
25 appointed and qualifies.

26 (f) (1) A member appointed by the President may be removed by the President
27 for the reasons stated in paragraph **[(4)] (5)** of this subsection.

28 (2) A member appointed by the Speaker may be removed by the Speaker
29 for the reasons stated in paragraph **[(4)] (5)** of this subsection.

30 (3) A member appointed by the Governor may be removed by the Governor

1 for the reasons stated in paragraph [(4)] (5) of this subsection.

2 (4) THE BOARD CHAIR MAY BE REMOVED JOINTLY BY THE
3 PRESIDENT AND THE SPEAKER FOR THE REASONS STATED IN PARAGRAPH (5) OF
4 THIS SUBSECTION.

5 [(4)] (5) A member of the Board may be removed for:

6 (i) Incompetence;

7 (ii) Misconduct;

8 (iii) Immorality; or

9 (iv) Failure to perform the duties of the position.

10 (G) BOARD MEMBERS ARE SUBJECT TO THE REQUIREMENTS OF TITLE 5 OF
11 THE GENERAL PROVISIONS ARTICLE.

12 (H) (1) THE BOARD SHALL MEET AT LEAST ONCE EVERY 2 MONTHS.

13 (2) BOARD MEETINGS ARE SUBJECT TO THE REQUIREMENTS OF
14 TITLE 3 OF THE GENERAL PROVISIONS ARTICLE.

16 The Governor's Office on Service and Volunteerism within the Governor's Office of
17 Community Initiatives shall provide:

18 (1) Staff and other support to the Board; and

19 (2) Technical and other assistance to the operator selected under § 24–1105

22 (A) (1) THE BOARD SHALL APPOINT AN EXECUTIVE DIRECTOR.

23 (2) THE EXECUTIVE DIRECTOR SERVES AT THE PLEASURE OF THE
24 BOARD.

25 (3) THE BOARD SHALL DETERMINE THE SALARY OF THE EXECUTIVE
26 DIRECTOR.

27 (B) (1) THE EXECUTIVE DIRECTOR IS THE CHIEF ADMINISTRATIVE

1 OFFICER OF THE PROGRAM.

2 (2) THE EXECUTIVE DIRECTOR SHALL MANAGE THE
3 ADMINISTRATIVE AFFAIRS AND TECHNICAL ACTIVITIES OF THE PROGRAM IN
4 ACCORDANCE WITH THE POLICIES AND PROCEDURES THAT THE BOARD
5 ESTABLISHES.

6 (C) (1) THE BOARD MAY EMPLOY A STAFF IN ACCORDANCE WITH ITS
7 BUDGET.

8 (2) STAFF EMPLOYED UNDER THIS SECTION ARE STATE EMPLOYEES
9 WHO:

10 (I) ARE SUBJECT TO THE REQUIREMENTS OF TITLE 5 OF THE
11 GENERAL PROVISIONS ARTICLE; AND

12 (II) MAY PARTICIPATE IN THE STATE RETIREMENT AND
13 PENSION SYSTEM UNDER DIVISION II OF THE STATE PERSONNEL AND PENSIONS
14 ARTICLE.

15 [24-1105.

16 (a) On or before June 1, 2017, the Board shall issue a Request for Proposals (RFP)
17 for an operator for the Program.

18 (b) The operator shall meet the qualifications established by the Board.

19 (c) The RFP shall include the following elements and expectations for the
20 operator:

21 (1) Identifying meaningful service opportunities for corps participants that
22 address the social needs of the community that are provided by nonprofit organizations or
23 government agencies;

24 (2) Identifying service opportunities that will teach 21st century skills to
25 corps participants;

26 (3) Identifying academic credit opportunities for corps participants;

27 (4) Creating a selective recruitment process for corps participants, giving
28 priority to low-income individuals;

29 (5) Creating and implementing an orientation and training program for
30 corps participants and the nonprofit or government agencies where corps participants
31 effectuate their service;

1 (6) Providing support to corps participants in finding placements;

2 (7) Emphasizing and encouraging the importance of being a successful
3 contributor to society, a measure of which is a vocational certificate, an associate's degree,
4 or a bachelor's degree;

5 (8) Creating tools to measure the success of corps participants as they
6 transition from high school to an institution of higher education for a vocational certificate,
7 an associate's degree, or a bachelor's degree;

8 (9) Facilitating the award of stipends for corps participants during their
9 year of service;

10 (10) Facilitating the award of scholarships for corps participants who
11 complete the Program to be used at institutions of higher education toward vocational
12 certificates, associate's degrees, or bachelor's degrees;

13 (11) Identifying what State support will be necessary and what public and
14 private grant opportunities are available to sustain and increase the size of the Program;
15 and

16 (12) Any other characteristics that the Board determines will improve the
17 quality and success of the Program.]

19 **(A) THE BOARD IS RESPONSIBLE FOR EXPANDING SERVICE**
20 **OPPORTUNITIES IN THE STATE WITH THE FOLLOWING GOALS:**

21 **(1) CREATING A STRONG ANNUAL COHORT BOND OF UNITY FOR**
22 **PROGRAM PARTICIPANTS FROM URBAN, RURAL, AND SUBURBAN AREAS OF THE**
23 **STATE;**

24 **(2) ENSURING ALL MARYLANDERS HAVE EQUITABLE ACCESS TO**
25 **PARTICIPATE IN THE PROGRAM REGARDLESS OF GENDER, RACE, RELIGION,**
26 **NATIONAL ORIGIN, SEXUAL ORIENTATION, GENDER IDENTITY OR EXPRESSION,**
27 **DISABILITY, OR PROTECTED VETERAN STATUS;**

28 **(3) HELPING PROGRAM PARTICIPANTS DEVELOP THE CRITICAL JOB**
29 **SKILLS NECESSARY FOR CREATING A MORE EQUITABLE SOCIETY AS THEY SERVE**
30 **THEIR COMMUNITIES ACROSS THE STATE, USING THE LENS OF ENVIRONMENTAL,**
31 **SOCIAL, AND RACIAL JUSTICE; AND**

32 **(4) ENSURING EACH DISTRICT OF THE STATE CAN COMMUNICATE ITS**

1 UNIQUE COMMUNITY NEEDS AND CHOOSE THE APPROPRIATE SOLUTIONS.

2 (B) THE BOARD SHALL ADOPT REGULATIONS REGARDING:

3 (1) SELECTION CRITERIA FOR REGIONAL OPERATING PARTNERS
4 WITH A GLOBAL VIEW OF THE NEEDS OF THE COMMUNITIES IN WHICH THE
5 REGIONAL OPERATING PARTNER WORKS, WHO WILL IDENTIFY AND IMPLEMENT
6 PLACEMENT PRIORITIES IN CONSULTATION WITH LOCAL COMMUNITY PARTNERS TO
7 EXPAND CAPACITY AND CREATE NEW SERVICE PROGRAMS AS NEEDED;

8 (2) ELIGIBILITY REQUIREMENTS FOR PARTICIPATING
9 ORGANIZATIONS, CLASSIFIED BY THE BOARD BASED ON THE NUMBER OF SERVICE
10 MEMBERS THE ORGANIZATION'S GRANT WILL SUPPORT, AS:

11 (I) COMMUNITY EMPLOYERS; OR

12 (II) LARGE-SCALE EMPLOYERS;

13 (3) PRIORITIZING THE PLACEMENT OF PROGRAM PARTICIPANTS
14 WITH LARGE-SCALE EMPLOYERS BASED ON THE ORGANIZATION'S DEMONSTRATED
15 NEED FOR PROGRAM PARTICIPANTS WHO WILL TRANSITION TO FULL-TIME
16 EMPLOYMENT FOLLOWING COMPLETION OF THE PROGRAM;

17 (4) A CENTRALIZED PROCESS TO FACILITATE EFFICIENT SCREENING
18 AND PLACEMENT OF PROGRAM PARTICIPANTS AS WELL AS EFFECTIVE
19 MEASUREMENT AND EVALUATION OF THE PARTICIPANT'S SERVICE EXPERIENCE;

20 (5) STIPENDS FOR PARTICIPANTS, INCLUDING:

21 (I) MONETARY PAYMENT OF AT LEAST \$15 PER HOUR, HEALTH
22 INSURANCE BENEFITS, AND THE POTENTIAL FOR WRAPAROUND SERVICES; AND

23 (II) FUNDS MATCHING REQUIREMENTS FOR LARGE-SCALE
24 EMPLOYERS;

25 (6) AN EDUCATION AWARD OF \$6,000 FOR PARTICIPANTS THAT
26 COMPLETE AT LEAST 9 MONTHS OF SERVICE, WHICH SHALL BE DEPOSITED INTO A
27 TAX-EXEMPT MARYLAND 529 ACCOUNT ESTABLISHED UNDER TITLE 18, SUBTITLE
28 19 OF THIS ARTICLE AND MAY ONLY BE USED FOR QUALIFIED HIGHER EDUCATION
29 EXPENSES, AS DEFINED IN § 18-1901 OF THIS ARTICLE;

30 (7) WORKFORCE DEVELOPMENT TRAINING AND WRAPAROUND
31 SERVICES PROVIDED TO PROGRAM PARTICIPANTS BY PARTICIPATING

1 ORGANIZATIONS;

2 (8) ADDITIONAL TRAINING AND SUPPORT SERVICES PROVIDED TO
3 PROGRAM PARTICIPANTS AFTER THE COMPLETION OF THE PARTICIPANT'S
4 SERVICE;

5 (9) ONGOING EVALUATION OF OPPORTUNITIES TO EXPAND SERVICE
6 IN THE STATE TO ADDRESS THE STATE'S WORKFORCE DEVELOPMENT NEEDS,
7 INCLUDING OPPORTUNITIES WITHIN STATE AGENCIES FOR THE CREATION AND
8 EXPANSION OF SERVICE OPPORTUNITIES WITHIN THE AGENCIES; AND

9 (10) ONGOING EVALUATION OF THE PROGRAM TO ENSURE ACCESS
10 AND EFFECTIVENESS, INCLUDING:

11 (I) DEMOGRAPHICS OF CORPS PARTICIPANTS, INCLUDING
12 RACE, ETHNICITY, AGE, EDUCATION, AND GEOGRAPHY; AND

13 (II) POST-PROGRAM TRAJECTORIES OF CORPS PARTICIPANTS.

14 (C) THE BOARD MAY:

15 (1) SUE AND BE SUED;

16 (2) ADOPT A SEAL;

17 (3) ACQUIRE, HOLD, AND DISPOSE OF PROPERTY FOR ITS
18 CORPORATE PURPOSES;

19 (4) SELL, LEASE, OR OTHERWISE CONVEY, IN ANY MANNER THAT THE
20 BOARD CONSIDERS APPROPRIATE, ANY PROPERTY IT OWNS TO ACCOMPLISH THE
21 PURPOSES OF THIS SUBTITLE;

22 (5) ENTER INTO CONTRACTS AND LEASES AND EXECUTE ANY
23 INSTRUMENT NECESSARY OR CONVENIENT, ON THE TERMS AND FOR ANY
24 CORPORATE PURPOSE THAT THE BOARD CONSIDERS ADVISABLE;

25 (6) USE ANY OTHER MONEY AVAILABLE UNDER THIS SUBTITLE OR
26 ANY GRANT OR MONEY FROM THE STATE OR FEDERAL GOVERNMENT OR ANY OF
27 THEIR UNITS OR INSTRUMENTALITIES TO ACCOMPLISH THE PURPOSES OF THIS
28 SUBTITLE;

29 (7) BORROW MONEY FOR A CORPORATE PURPOSE AND MORTGAGE OR
30 OTHERWISE ENCUMBER ITS PROPERTY AS SECURITY FOR THE LOAN;

1 **(8) ACCEPT GIFTS, CONTRIBUTIONS, OR LOANS OF MONEY, SUPPLIES,**
2 **GOODS, AND SERVICES, AND ACCEPT APPROPRIATIONS, ALLOTMENTS, AND LOANS**
3 **OF MONEY FROM THE STATE OR FEDERAL GOVERNMENT, A FEDERAL**
4 **CORPORATION, A UNIT OR INSTRUMENTALITY OF THE FEDERAL GOVERNMENT, OR A**
5 **POLITICAL SUBDIVISION OR INSTRUMENTALITY OF THE STATE;**

6 **(9) EXERCISE A POWER USUALLY POSSESSED BY A PRIVATE**
7 **CORPORATION IN PERFORMING SIMILAR FUNCTIONS UNLESS TO DO SO WOULD**
8 **CONFLICT WITH STATE LAW; AND**

9 **(10) DO ALL THINGS NECESSARY OR CONVENIENT TO CARRY OUT THE**
10 **POWERS EXPRESSLY GRANTED BY THIS SUBTITLE.**

11 [24–1106.

12 A corps participant:

13 (1) Shall serve for at least 9 months with a nonprofit organization or
14 government agency that has a focus on community or other service, civic engagement,
15 volunteerism, or other activities or experiences with a similar mission; and

16 (2) Is eligible for a monetary stipend in an amount determined by the
17 Board of up to \$15,000.]

18 **24–1106.**

19 **(A) THE BOARD SHALL ACT AS AN INTERMEDIARY WITH THE AMERICORPS**
20 **PROGRAM TO SECURE FEDERAL FUNDING AND ALLEVIATE THE ADMINISTRATIVE**
21 **BURDEN ON STATE ORGANIZATIONS SEEKING TO PARTICIPATE IN AMERICORPS**
22 **PROGRAMMING.**

23 **(B) IN WORKING WITH THE AMERICORPS PROGRAM UNDER SUBSECTION**
24 **(A) OF THIS SECTION, THE BOARD SHALL FOCUS ON EXPANDING THE SERVICE**
25 **OPPORTUNITIES IN STATE AND LOCAL PARKS AND IN THE PUBLIC HEALTH SECTOR.**

27 (a) A corps participant who completes the Program is eligible for a one–time
28 scholarship award, as determined by the Board, in the amount of up to \$6,000.

29 (b) A scholarship awarded under subsection (a) of this section:

30 (1) May be used at an eligible institution as described under § 18–103 of
31 this article toward a vocational certificate, an associate’s degree, or a bachelor’s degree; and

1 (2) May not be construed to prohibit or impede the award of any other
2 financial aid for which the corps participant is eligible.]

4 (a) There is a Maryland Corps Program Fund.

5 (b) The purpose of the Fund is to:

6 (1) Provide stipends to corps participants;

7 (2) Provide scholarships to corps participants who have completed the
8 Program to be used at institutions of higher education in the State toward vocational
9 certificates, associate’s degrees, and bachelor’s degrees;

10 (3) Cover expenses incurred by the Board, including expenses incurred
11 [during the development, issuance, awarding, and funding of the RFP;

12 (4) Cover expenses incurred by the operator selected under § 24–1105 of
13 this subtitle, as determined by the Board to be relevant to the successful operation of the
14 Program;

15 (5) Cover expenses incurred] to study the potential use of the Program as
16 a workforce development tool in the State;

17 [(6)] (4) Cover expenses incurred to study how alumni of the Program
18 could be better positioned to meet the current and future needs of employers in the State;
19 and

20 [(7)] (5) Provide funding for the Program to match gifts or grants received
21 by the Board for the Fund.

22 (c) The Board shall administer the Fund.

23 (d) The Fund is a continuing, nonlapsing fund that is not subject to § 7–302 of the
24 State Finance and Procurement Article.

25 (e) (1) The State Treasurer shall hold the Fund separately and shall invest the
26 money in the Fund in the same manner as other State money may be invested.

27 (2) Any investment earnings of the Fund shall be credited to the Fund.

28 (f) The Comptroller shall account for the Fund.

29 (g) The Board:

- 1 (1) May accept any gift or grant from any person for the Fund;
- 2 (2) Shall use any gift or grant that it receives for the reasons stated under
3 subsection (b) of this section; and
- 4 (3) Shall deposit any gift or grant that it receives for the Fund with the
5 State Treasurer.
- 6 (h) The Fund consists of:
