1 AN ACT concerning

2 **St. Mary's County – Leonardtown – Alcoholic Beverages Licenses – Place of**
3 **Worship Distance Restriction**

4 FOR the purpose of exempting the Town of Leonardtown from a prohibition against issuing
5 an alcoholic beverages license to an establishment located within a certain distance
6 of a place of worship; and generally relating to alcoholic beverages licenses in St.
7 Mary's County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

2 This title applies only in St. Mary’s County.

3 28-1602.

4 (a) (1) Except as provided in subsection (b) of this section, the Board may not
5 issue a license for an establishment that is within 300 feet of a place of worship or a public
6 or nonpublic kindergarten, elementary, or secondary school.

7 (2) The distance from the establishment to the place of worship or the
8 public or nonpublic kindergarten, elementary, or secondary school is to be measured from
9 the nearest wall of the establishment in a direct line to the nearest point of the main
10 building of the place of worship or the school.

11 (b) The prohibition against issuing a license in subsection (a) of this section does
12 not apply:

13 (1) [to the issuance of a Class B (on-sale) beer, wine, and liquor license for
14 an establishment] in Leonardtown; or

15 (2) if a place of worship or school locates its building within 300 feet of a
16 premises that is already licensed.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
18 1, 2022.
