## A BILL ENTITLED

1 AN ACT concerning

2 **Calvert County – Hotel Rental Tax – Distribution of Revenue**

3 FOR the purpose of requiring hotel rental tax revenue in Calvert County to be distributed  
4 to the Tourism Development Incentive Fund; requiring funds in the Tourism  
5 Development Incentive Fund to be distributed for certain purposes; and generally  
6 relating to the hotel rental tax in Calvert County.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Local Government**

15 20–415.

16 **(E) (1) CALVERT COUNTY SHALL DISTRIBUTE THE REVENUE FROM THE**  
17 **HOTEL RENTAL TAX COLLECTED UNDER THIS PART TO THE TOURISM**  
18 **DEVELOPMENT INCENTIVE FUND, ESTABLISHED UNDER THIS SUBSECTION.**

19 **(2) THERE IS A TOURISM DEVELOPMENT INCENTIVE FUND.**

20 **(3) THE TOURISM DEVELOPMENT INCENTIVE FUND SHALL BE**  
21 **DISTRIBUTED AS FOLLOWS:**

1                   **(I) TO THE GENERAL FUND OF THE COUNTY, A REASONABLE**  
2 **AMOUNT FOR THE ADMINISTRATION OF THE HOTEL RENTAL TAX;**

3                   **(II) AFTER THE DISTRIBUTION REQUIRED UNDER ITEM (I) OF**  
4 **THIS PARAGRAPH, TO A MUNICIPALITY, THE REVENUE ATTRIBUTABLE TO A HOTEL**  
5 **LOCATED IN THE MUNICIPALITY; AND**

6                   **(III) THE REMAINDER TO:**

7                   **1. SUBJECT TO PARAGRAPH (4) OF THIS SUBSECTION,**  
8 **PROVIDE GRANTS TO BUSINESSES AND ORGANIZATIONS TO PAY THE APPLICATION**  
9 **AND PERMIT FEES REQUIRED BY THE COUNTY TO HOLD A SPECIAL EVENT IN THE**  
10 **COUNTY; AND**

11                   **2. MARKET CALVERT COUNTY TO POTENTIAL VISITORS.**

12                   **(4) GRANTS PROVIDED FOR UNDER PARAGRAPH (3)(III) OF THIS**  
13 **SUBSECTION MAY BE AWARDED ONLY TO APPLICANTS THAT MEET CRITERIA**  
14 **ADOPTED BY THE COUNTY.**

15                   **(5) AFTER THE DISTRIBUTIONS REQUIRED UNDER PARAGRAPH (3) OF**  
16 **THIS SUBSECTION, ANY UNEXPENDED FUNDS AT THE END OF EACH FISCAL YEAR**  
17 **SHALL BE DISTRIBUTED TO THE GENERAL FUND OF THE COUNTY.**

18                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
19 1, 2022.
