### CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **State Board of Examiners of Nursing Home Administrators – Renaming ~~and~~,**  
3 **Licensure of Assisted Living Managers, and Penalties**

4 FOR the purpose of renaming the State Board of Examiners of Nursing Home  
5 Administrators to be the State Board of Long-Term Care Administrators and  
6 establishing a licensing and regulatory system for assisted living managers under  
7 the Board; requiring the Office of Health Care Quality, beginning on a certain date,  
8 to notify the Board of the appointment of an assisted living program as a resident’s  
9 representative payee; establishing a civil penalty for taking certain actions related  
10 to practicing as a nursing home administrator or an assisted living manager without  
11 a license; and generally relating to ~~the licensing of assisted living managers and~~ the  
12 State Board of Long-Term Care Administrators.

12 (c) The Office of Health Care Quality shall notify the Division AND, BEGINNING  
13 OCTOBER 1, 2024, THE STATE BOARD OF LONG–TERM CARE ADMINISTRATORS of  
14 the appointment of an assisted living program as a resident’s representative payee within  
15 a reasonable time after being made aware of the appointment.

18 (a) (1) Except as provided in subsection (d) of this section, [by January 1,  
19 2006,] an assisted living manager who is employed by an assisted living program [that is  
20 licensed for 5 or more beds] shall have completed a manager training course that is  
21 approved by the Department and includes an examination.

22 (2) The manager training course shall:

23 (i) Consist of at least 80 hours;

24 (ii) Require attendance or participation at training programs that  
25 provide for direct interaction between faculty and participants; and

26 (iii) Authorize a maximum of 25 hours of training through Internet  
27 courses, correspondence courses, tapes, or other training methods that do not require direct  
28 interaction between faculty and participants.

29 (b) An assisted living manager employed [in] BY a program [that is licensed for  
30 5 or more beds] shall be required to complete 20 hours of Department–approved continuing  
31 education every 2 years.

27           **[(e)] (I) “Nursing home” means an institution or part of an institution that:**

(1) Is a “skilled nursing facility” or an “intermediate care facility” as those terms are defined by federal law and participates in a program under Title XVIII or Title XIX of the Social Security Act; or

(2) If it is licensed only by this State, otherwise meets the federal requirements for a “skilled nursing facility” or an “intermediate care facility” as those terms are defined by federal law.

**[(f)] (J)** “Nursing home administrator” means an individual who administers, manages, or is in general administrative charge of a nursing home whether or not the individual:

(1) Has an ownership interest in the nursing home; or

(2) Shares duties and functions with other individuals.

There is a State Board of **[Examiners of Nursing Home] LONG-TERM CARE** Administrators in the Department.

9–202.

(a) (1) The Board consists of **[14] 17** members.

(2) Of the **[14]** Board members:

(i) ~~Six~~ **FIVE** shall be licensed nursing home administrators, one of whom has experience with the Eden Alternative Green House or a similar program, if practicable;

(ii) Two shall be individuals who are not nursing home administrators **OR ASSISTED LIVING MANAGERS** but who are engaged actively in professions that are concerned with the care of chronically ill, infirm, or aged individuals;

**(III) 1. BEFORE OCTOBER 1, 2024, ~~THREE~~ FIVE SHALL BE ASSISTED LIVING MANAGERS INDIVIDUALS WHO HAVE:**

**A. COMPLETED THE MANAGER TRAINING COURSE REQUIRED UNDER ~~§ 19–1807~~ § 19–1807(A) OF THE HEALTH – GENERAL ARTICLE OR ARE EXEMPT FROM THE REQUIREMENT UNDER § 19–1807(D) OF THE HEALTH – GENERAL ARTICLE; AND**

13                   (4) A representative of the Office of Health Care Quality shall serve as an  
14 ex officio member.

15                   (b) (1) The Governor shall appoint the consumer members with the advice of  
16 the Secretary and the advice and consent of the Senate.

17                   (2) (i) Except for the consumer members and the State Long-Term  
18 Care Ombudsman, the Governor shall appoint each Board member, with the advice of the  
19 Secretary.

20                   (ii) The Secretary shall recommend a professional who:

21                   1. Is actively practicing;

22                   2. Has a minimum of 5 years of appropriate practice  
23 experience in the discipline of the vacancy to be filled; and

24                   3. Otherwise meets the requirements of this section.

25                   (c) Each Board member shall:

26                   (1) Be a United States citizen or have declared an intent to become a  
27 United States citizen; and

28                   (2) Have resided in this State for at least 1 year before appointment to the  
29 Board.

- 1 (d) (1) Each consumer member of the Board:
- 2 (i) Shall be a member of the general public;
- 3 (ii) May not be or ever have been a nursing home administrator **OR**  
4 **AN ASSISTED LIVING MANAGER** or in training to become a nursing home administrator  
5 **OR AN ASSISTED LIVING MANAGER**;
- 6 (iii) May not have a household member who is a nursing home  
7 administrator **OR AN ASSISTED LIVING MANAGER** or in training to become a nursing  
8 home administrator **OR AN ASSISTED LIVING MANAGER**;
- 9 (iv) May not participate or ever have participated in a commercial or  
10 professional field related to the practice of a nursing home administrator **OR ASSISTED**  
11 **LIVING MANAGER**;
- 12 (v) May not have a household member who participates in a  
13 commercial or professional field related to the practice of a nursing home administrator **OR**  
14 **AN ASSISTED LIVING MANAGER**; and
- 15 (vi) May not have had within 2 years before appointment a  
16 substantial financial interest in a person regulated by the Board.
- 17 (2) **OF THE CONSUMER MEMBERS:**
- 18 (I) One [consumer member] shall have presently or have had  
19 **WITHIN THE 5 YEARS IMMEDIATELY PRECEDING INITIAL APPOINTMENT** a family  
20 member living in a nursing home; **AND**
- 21 (II) **ONE SHALL HAVE PRESENTLY OR HAVE HAD WITHIN THE 5**  
22 **YEARS IMMEDIATELY PRECEDING INITIAL APPOINTMENT A FAMILY MEMBER WHO**  
23 **RECEIVES SERVICES LIVING IN AN ASSISTED LIVING PROGRAM.**
- 24 (e) While a member of the Board, a consumer member may not have a substantial  
25 financial interest in a person regulated by the Board.
- 26 (f) Before taking office, each appointee to the Board shall take the oath required  
27 by Article I, § 9 of the Maryland Constitution.
- 28 (g) (1) This subsection does not apply to the State Long-Term Care  
29 Ombudsman.
- 30 (2) The term of a member is 4 years.



1 (3) The terms of members are staggered as required by the terms provided  
2 for members of the Board on July 1, 1981.

3 (4) At the end of a term, a member continues to serve until a successor is  
4 appointed and qualifies.

5 (5) A member who is appointed after a term has begun serves only for the  
6 rest of the term and until a successor is appointed and qualifies.

7 (6) A member may not serve more than 2 consecutive full terms.

8 (7) To the extent practicable, the Governor shall fill any vacancy on the  
9 Board within 60 days of the date of the vacancy.

10 (h) (1) The Governor may remove a member for incompetence, misconduct,  
11 incapacity, or neglect of duty.

12 (2) Upon the recommendation of the Secretary, the Governor may remove  
13 a member whom the Secretary finds to have been absent from 2 successive Board meetings

16 (a) In this section, ["nursing home administrator rehabilitation"]  
17 "REHABILITATION committee" means a committee [that:

18 (1) Is defined in subsection (b) of this section; and

19 (2) Performs any of the functions listed in subsection (d) of this section.

20 (b) For purposes of this section, a nursing home administrator rehabilitation  
21 committee is a committee] of the Board or a committee of any association representing  
22 nursing home administrators **OR ASSISTED LIVING MANAGERS** that:

23 (1) Is recognized by the Board; [and]

24 (2) Includes but is not limited to nursing home administrators **AND**  
25 **ASSISTED LIVING MANAGERS; AND**

4 rehabilitation committee evaluates and provides assistance to any nursing home  
5 administrator **OR ASSISTED LIVING MANAGER**, and any other individual regulated by the  
6 Board, in need of treatment and rehabilitation for alcoholism, drug abuse, chemical  
7 dependency, or other physical, emotional, or mental condition.

8 [(e)] (D) (1) Except as otherwise provided in this subsection, the proceedings,  
9 records, and files of the [nursing home administrator] rehabilitation committee are not  
10 discoverable and are not admissible in evidence in any civil action arising out of matters  
11 that are being or have been reviewed and evaluated by the [nursing home administrator]  
12 rehabilitation committee.

13 (2) Paragraph (1) of this subsection does not apply to any record or  
14 document that is considered by the [nursing home administrator] rehabilitation committee  
15 and that otherwise would be subject to discovery or introduction into evidence in a civil  
16 action.

17 (3) For purposes of this subsection, civil action does not include a  
18 proceeding before the Board or judicial review of a proceeding before the Board.

19 [(f)] (E) A person who acts in good faith and within the scope of jurisdiction of  
20 [a nursing home administrator] **THE** rehabilitation committee is not civilly liable for any  
21 action as a member of the [nursing home administrator] rehabilitation committee or for  
22 giving information to, participating in, or contributing to the function of the [nursing home  
23 administrator] rehabilitation committee.
