CHAPTER _____

1 AN ACT concerning

2 **Election Law – Contested Elections**

3 FOR the purpose of altering certain definitions to allow a campaign finance entity to pay
4 expenses associated with contesting an election; prohibiting a recount under certain
5 circumstances; altering the circumstances under which a petitioner for a recount is
6 not liable for the costs of the recount; providing that a person who accepts certain
7 public campaign financing may accept a donation or make a disbursement related to
8 a contested election only if the person establishes a contested election committee and
9 makes certain disclosures; providing that a certain system of public campaign
10 financing established by the governing body of a county may include public financing
11 of a contested election committee; and generally relating to contested elections.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
8 That the Laws of Maryland read as follows:

9 **Article – Election Law**

10 1–101.

11 (a) In this article the following words have the meanings indicated unless a
12 different meaning is clearly intended from the context.

13 (o) (1) “Contribution” means the gift or transfer, or promise of gift or transfer,
14 of money or other thing of value to a campaign finance entity to:

15 (I) promote or assist in the promotion of the success or defeat of a
16 candidate, political party, question, or prospective question; AND

17 (II) ASSIST IN THE PAYMENT OF EXPENSES ASSOCIATED WITH
18 CONTESTING AN ELECTION UNDER TITLE 12 OF THIS ARTICLE.

19 (2) “Contribution” includes:

20 (i) proceeds from the sale of tickets to a campaign fund–raising
21 event; and

22 (ii) a coordinated expenditure as defined in § 13–249 of this article.

23 (3) “Contribution” does not include the costs associated with the
24 establishment, administration, or solicitation of voluntary contributions to a political action
25 committee established by a corporation, limited liability company, general partnership,
26 limited partnership, membership organization, trade association, cooperative, or
27 corporation without capital stock as long as the political action committee only solicits
28 contributions from employees of the organization that established the political action
29 committee, or members of the organization that established the political action committee,
30 and the employees or members are participating in a payroll deduction program established
31 by the employer of the employee or member.

32 (aa) “Expenditure” means a gift, transfer, disbursement, or promise of money or a
33 thing of value by or on behalf of a campaign finance entity to:

1 (1) promote or assist in the promotion of the success or defeat of a
2 candidate, political party, question, or prospective question at an election; [or]

3 **(2) PAY EXPENSES ASSOCIATED WITH CONTESTING AN ELECTION**
4 **UNDER TITLE 12 OF THIS ARTICLE; OR**

8 (a) **(1) [A] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
9 **SUBSECTION, A** candidate for public or party office who has been defeated based on the
10 certified results of any election conducted under this article may petition for a recount of
11 the votes cast for the office sought.

12 **(2) A CANDIDATE MAY NOT PETITION FOR A RECOUNT IF THE MARGIN**
13 **OF DIFFERENCE BETWEEN THE NUMBER OF VOTES RECEIVED BY AN APPARENT**
14 **WINNER AND THE LOSING CANDIDATE WITH THE HIGHEST NUMBER OF VOTES FOR**
15 **THE OFFICE IS GREATER THAN 5% OF THE TOTAL VOTES CAST FOR THOSE**
16 **CANDIDATES.**

18 (a) **(1) [A] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
19 **SUBSECTION, A** petition for a recount based on the certified results of a question on the
20 ballot in an election conducted under this article may be filed by a registered voter eligible
21 to vote for that question.

22 **(2) A REGISTERED VOTER MAY NOT FILE A PETITION FOR A RECOUNT**
23 **IF THE MARGIN OF DIFFERENCE BETWEEN THE NUMBER OF VOTES CAST FOR AND**
24 **THE NUMBER OF VOTES CAST AGAINST THE QUESTION IS GREATER THAN 5%.**

26 (a) In this section, "petitioner" includes a counterpetitioner.

27 (b) (1) Except as provided in paragraph (2) of this subsection, each petitioner
28 shall pay the cost of a recount requested under this subtitle and the petitioner's bond is
29 liable for the cost.

30 (2) The petitioner is not liable for the costs of the recount if:

31 (i) the outcome of the election is changed;

(ii) the petitioner has gained a number of votes, for the petitioner's candidacy or for or against the question that is the subject of the petition, equal to 2% or more of the total votes cast for the office or on the question, in all precincts being recounted; or

(iii) 1. the margin of difference in the number of votes received by an apparent winner and the losing candidate with the highest number of votes for an office is [0.1%] **0.25%** or less of the total votes cast for those candidates; or

2. in the case of a question, the margin of difference between the number of votes cast for and the number cast against the question is [0.1%] **0.25%** or less.

(c) If the petitioner is not liable for the costs of the recount as provided in subsection (b) of this section, a county shall pay the costs of the recount in that county.

SUBTITLE 3. CONTESTED ELECTION COMMITTEE.

(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(B) (1) "CONTESTED ELECTION" MEANS AN ELECTION SUBJECT TO:

(I) A RECOUNT UNDER SUBTITLE 1 OF THIS TITLE; OR

(II) A JUDICIAL CHALLENGE UNDER SUBTITLE 2 OF THIS TITLE.

(2) "CONTESTED ELECTION" INCLUDES AN ELECTION THAT MAY BE SUBJECT TO A RECOUNT UNDER SUBTITLE 1 OF THIS TITLE, BUT FOR WHICH A RECOUNT DOES NOT OCCUR BECAUSE NEITHER CANDIDATE FILES A FORMAL RECOUNT PETITION OR INITIATES A JUDICIAL ACTION.

(C) "CONTESTED ELECTION COMMITTEE" MEANS AN ENTITY FORMED FOR THE EXCLUSIVE PURPOSE OF RECEIVING DONATIONS AND MAKING DISBURSEMENTS RELATING TO A CONTESTED ELECTION.

19 **(B) DISBURSEMENTS OF A CONTESTED ELECTION COMMITTEE SHALL:**

20 **(1) PASS THROUGH THE HANDS OF THE TREASURER; AND**

21 **(2) BE IN ACCORDANCE WITH THE PURPOSE OF THE ENTITY.**

28 **§ 13-505 OF THIS ARTICLE MAY NOT SOLICIT OR ACCEPT A DONATION ON BEHALF**

1 OF A CONTESTED ELECTION COMMITTEE IN EXCESS OF THE CONTRIBUTION LIMITS
2 ESTABLISHED IN LAW BY THE GOVERNING BODY OF THE COUNTY IN ACCORDANCE
3 WITH § 13-505 OF THIS ARTICLE.

4 (B) (1) A CONTESTED ELECTION COMMITTEE MAY NOT ACCEPT A LOAN
5 OTHER THAN A LOAN FROM:

6 (I) A FINANCIAL INSTITUTION OR OTHER ENTITY IN THE
7 BUSINESS OF MAKING LOANS; OR

8 (II) THE PERSONAL FUNDS OF A CANDIDATE OR THE
9 CANDIDATE'S SPOUSE IF THE CONTESTED ELECTION COMMITTEE WAS ESTABLISHED
10 TO FINANCE A RECOUNT OF AN ELECTION IN WHICH THE CANDIDATE WAS ON THE
11 BALLOT.

12 (2) A LOAN UNDER THIS SUBSECTION MAY BE OF ANY AMOUNT.

13 12-306.

14 (A) THE TREASURER OF A CONTESTED ELECTION COMMITTEE SHALL
15 MAINTAIN DETAILED AND ACCURATE RECORDS OF ALL:

16 (1) DONATIONS RECEIVED BY THE CONTESTED ELECTION
17 COMMITTEE;

18 (2) DISBURSEMENTS MADE BY THE CONTESTED ELECTION
19 COMMITTEE; AND

20 (3) OUTSTANDING OBLIGATIONS OF THE CONTESTED ELECTION
21 COMMITTEE.

22 (B) A CONTESTED ELECTION COMMITTEE SHALL RETAIN THE RECORDS
23 REQUIRED TO BE MAINTAINED UNDER SUBSECTION (A) OF THIS SECTION FOR A
24 PERIOD OF 2 YEARS AFTER FILING A FINAL REPORT.

10 **THE REPORTING PERIOD.**

11 **(B) (1) IF THE PERSON WHO ESTABLISHED THE CONTESTED ELECTION**
12 **COMMITTEE HAS FILED A PETITION FOR A RECOUNT UNDER SUBTITLE 1 OF THIS**
13 **TITLE OR HAS FILED A COMPLAINT IN THE CIRCUIT COURT UNDER SUBTITLE 2 OF**
14 **THIS TITLE, THE TREASURER OF THE CONTESTED ELECTION COMMITTEE SHALL**
15 **FILE THE CONTESTED ELECTION COMMITTEE'S FIRST REPORT ON OR BEFORE THE**
16 **FIRST DAY AFTER THE EARLIER OF:**

17 **(I) THE DAY THE PERSON WHO ESTABLISHED THE CONTESTED**
18 **ELECTION COMMITTEE FILED THE PETITION FOR A RECOUNT; OR**

19 **(II) THE DAY THE PERSON WHO ESTABLISHED THE CONTESTED**
20 **ELECTION COMMITTEE FILED THE COMPLAINT IN THE CIRCUIT COURT.**

21 **(2) IF THE PERSON WHO ESTABLISHED THE CONTESTED ELECTION**
22 **COMMITTEE HAS NOT FILED A PETITION FOR A RECOUNT UNDER SUBTITLE 1 OF**
23 **THIS TITLE OR FILED A COMPLAINT IN THE CIRCUIT COURT UNDER SUBTITLE 2 OF**
24 **THIS TITLE, THE TREASURER OF THE CONTESTED ELECTION COMMITTEE SHALL**
25 **FILE THE CONTESTED ELECTION COMMITTEE'S FIRST REPORT ON OR BEFORE THE**
26 **DAY THAT IS 7 DAYS AFTER THE DAY THAT THE CONTESTED ELECTION COMMITTEE**
27 **OF THE OPPOSING CANDIDATE OR OPPOSING PARTY FILED ITS FIRST REPORT**
28 **UNDER PARAGRAPH (1) OF THIS SUBSECTION.**

29 **(C) THE TREASURER OF A CONTESTED ELECTION COMMITTEE SHALL FILE**
30 **SUBSEQUENT REPORTS ON OR BEFORE:**

31 **(1) THE MONDAY THAT IS 30 DAYS AFTER THE DUE DATE OF THE**
32 **FIRST REPORT FILED BY THE CONTESTED ELECTION COMMITTEE UNDER**
33 **SUBSECTION (B) OF THIS SECTION;**

1 **(2) THE MONDAY THAT IS 60 DAYS AFTER THE DUE DATE OF THE**
2 **FIRST REPORT FILED BY THE CONTESTED ELECTION COMMITTEE UNDER**
3 **SUBSECTION (B) OF THIS SECTION; AND**

4 **(3) THE THIRD WEDNESDAY IN JANUARY OF EACH YEAR THAT THE**
5 **CONTESTED ELECTION COMMITTEE REMAINS IN EXISTENCE.**

6 **(D) THE STATE BOARD SHALL, BY REGULATION, ESTABLISH THE**
7 **REPORTING PERIODS FOR EACH OF THE REPORTS REQUIRED UNDER THIS**
8 **SUBTITLE.**

9 **(E) IF THE TREASURER OF A CONTESTED ELECTION COMMITTEE FAILS TO**
10 **PROVIDE ALL THE INFORMATION REQUIRED ON A REPORT UNDER THIS SUBTITLE:**

11 **(1) THE STATE BOARD SHALL NOTIFY THE TREASURER IN WRITING**
12 **OF THE PARTICULAR DEFICIENCIES; AND**

13 **(2) THE TREASURER SHALL FILE AN AMENDED REPORT THAT**
14 **INCLUDES ALL THE INFORMATION REQUIRED WITHIN 30 DAYS AFTER SERVICE OF**
15 **THE NOTICE.**

17 **(A) (1) THE STATE BOARD SHALL ASSESS LATE FILING FEES FOR**
18 **FAILURE TO PROPERLY FILE A REPORT UNDER THIS SUBTITLE.**

19 **(2) THE STATE BOARD SHALL ASSESS THE FEES IN THE FOLLOWING**
20 **AMOUNTS FOR EACH DAY OR PART OF A DAY THAT A REPORT UNDER THIS SUBTITLE**
21 **IS OVERDUE:**

22 **(I) \$20 FOR EACH OF THE FIRST 7 DAYS;**

23 **(II) \$35 FOR EACH OF THE FOLLOWING 7 DAYS; AND**

24 **(III) \$50 FOR EACH DAY THEREAFTER.**

25 **(3) THE MAXIMUM FEE PAYABLE FOR A REPORT IS \$1,000.**

26 **(B) (1) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, A**
27 **LATE FILING FEE UNDER THIS SECTION SHALL BE PAID BY THE CONTESTED**
28 **ELECTION COMMITTEE.**

1 **(II) IF THE CONTESTED ELECTION COMMITTEE HAS**
2 **INSUFFICIENT FUNDS WITH WHICH TO PAY THE FULL AMOUNT OF THE LATE FILING**
3 **FEE IN A TIMELY MANNER, AFTER THE ACCOUNT OF THE CONTESTED ELECTION**
4 **COMMITTEE IS EXHAUSTED THE BALANCE OF THE LATE FILING FEE IS THE**
5 **LIABILITY OF THE TREASURER.**

6 **(2) LATE FILING FEES SHALL BE DISTRIBUTED TO THE FAIR**
7 **CAMPAIGN FINANCING FUND ESTABLISHED UNDER § 15-103 OF THIS ARTICLE.**

8 **(3) (I) THE STATE BOARD SHALL ACCEPT AN OVERDUE REPORT**
9 **THAT IS SUBMITTED WITHOUT PAYMENT OF THE LATE FILING FEE, BUT THE REPORT**
10 **IS NOT CONSIDERED FILED UNTIL THE FEE HAS BEEN PAID.**

11 **(II) AFTER AN OVERDUE REPORT IS RECEIVED UNDER**
12 **SUBPARAGRAPH (I) OF THIS PARAGRAPH, NO FURTHER LATE FILING FEE SHALL BE**
13 **INCURRED.**

1 **(B) A TREASURER WHO FAILS, WITHOUT CAUSE, TO FILE THE REPORT AND**
2 **PAY THE LATE FILING FEE WITHIN 30 DAYS AFTER SERVICE OF THE NOTICE**
3 **REQUIRED UNDER SUBSECTION (A)(2) OF THIS SECTION IS GUILTY OF A**
4 **MISDEMEANOR AND ON CONVICTION IS SUBJECT TO THE PENALTIES PRESCRIBED IN**

9 **ON OR BEFORE THE DEADLINE FOR DECLINING THE NOMINATION SPECIFIED UNDER**
10 **§ 5-801(B) OF THIS ARTICLE MAY NOT BE ISSUED A CERTIFICATE OF NOMINATION**
11 **UNDER § 5-705 OF THIS ARTICLE.**

12 **(B) A CANDIDATE WHOSE CONTESTED ELECTION COMMITTEE HAS FAILED**
13 **TO FILE A REPORT OR PAY A LATE FILING FEE THAT IS DUE UNDER THIS SUBTITLE**
14 **MAY NOT, UNTIL THE REPORT IS FILED OR THE LATE FILING FEE IS PAID:**

15 **(1) BE DEEMED TO BE ELECTED TO A PUBLIC OR PARTY OFFICE IN**
16 **THE STATE;**

17 **(2) TAKE THE OATH OR OTHERWISE ASSUME THE DUTIES OF THE**
18 **OFFICE; OR**

19 **(3) RECEIVE A SALARY OR COMPENSATION FOR THE OFFICE.**

20 **(C) AN OFFICIAL OF THE STATE OR ANY OF ITS POLITICAL SUBDIVISIONS**
21 **MAY NOT ISSUE A COMMISSION OR ADMINISTER AN OATH OF OFFICE TO AN**
22 **INDIVIDUAL UNTIL THAT OFFICIAL RECEIVES CERTIFICATION FROM THE STATE**
23 **BOARD THAT ALL REPORTS DUE UNDER THIS SUBTITLE FROM OR ON BEHALF OF**
24 **THAT INDIVIDUAL HAVE BEEN FILED.**

32 **§ 12-313 OF THIS SUBTITLE;**

1 **(3) FAILURE TO MAINTAIN THE RECORDS REQUIRED UNDER § 12-306**
2 **OF THIS SUBTITLE; OR**

3 **(4) FAILURE TO REPORT ALL DONATIONS, DISBURSEMENTS, AND**
4 **OUTSTANDING OBLIGATIONS AS REQUIRED UNDER § 12-308 OF THIS SUBTITLE.**

5 **(B) A CIVIL PENALTY IMPOSED UNDER THIS SECTION SHALL BE ASSESSED**
6 **IN THE AMOUNT AND IN THE MANNER SPECIFIED IN § 13-604.1 OF THIS ARTICLE.**

7 **(C) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A CIVIL**
