CHAPTER _____

1 AN ACT concerning

2 **Maryland Energy Administration – Resiliency Hub Grant Program and Fund**

3 FOR the purpose of establishing the Resiliency Hub Grant Program in the Maryland
4 Energy Administration; requiring the Administration to establish certain procedures
5 and criteria for the Program; establishing the Resiliency Hub Grant Program Fund
6 as a special, nonlapsing fund; requiring interest earnings of the Resiliency Hub
7 Grant Program Fund to be credited to the Resiliency Hub Grant Program Fund;
8 requiring that certain fines and penalties be credited to the Resiliency Hub Grant
9 Program Fund rather than the General Fund of the State; requiring the
10 Administration to provide certain Maryland Strategic Energy Investment Fund
11 funding to the Resiliency Hub Grant Program Fund; and generally relating to the
12 Resiliency Hub Grant Program and Fund.

31 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
32 That the Laws of Maryland read as follows:

35 (a) There is a Public Utility Regulation Fund.

36 (b) The Fund consists of:

1 (1) all revenue received through the imposition and collection of
2 assessments under § 2–110 of this subtitle;

3 (2) fees received by the Commission under § 2–123 of this subtitle for
4 filings and for other services rendered by the Commission;

5 (3) income from investments that the State Treasurer makes for the Fund;
6 and

7 (4) any other fee, examination assessment, or revenue received by the
8 Commission under this division.

9 (c) Notwithstanding subsection (b) of this section, the Commission shall pay all
10 fines and penalties collected by the Commission under this article into the [General Fund
11 of the State] **RESILIENCY HUB GRANT PROGRAM FUND ESTABLISHED UNDER §**
12 **9–2011 OF THE STATE GOVERNMENT ARTICLE.**

14 (a) (1) In this section the following words have the meanings indicated.

15 (3) “Community solar energy generating system” means a solar energy
16 system that:

17 (i) is connected to the electric distribution grid serving the State;

18 (ii) is located in the same electric service territory as its subscribers;

19 (iii) is attached to the electric meter of a subscriber or is a separate
20 facility with its own electric meter;

21 (iv) credits its generated electricity, or the value of its generated
22 electricity, to the bills of the subscribers to that system through virtual net energy
23 metering;

24 (v) has at least two subscribers but no limit to the maximum number
25 of subscribers;

26 (vi) does not have subscriptions larger than 200 kilowatts
27 constituting more than 60% of its subscriptions;

28 (vii) has a generating capacity that does not exceed 2 megawatts as
29 measured by the alternating current rating of the system’s inverter; and

30 (viii) may be owned by any person.

1 (a) This section does not apply to a violation of the following provisions of this
2 article:

- 3 (1) Title 5, Subtitle 4;
- 4 (2) Title 7, Subtitle 1;
- 5 (3) § 7–213 as it applies to electric cooperatives;
- 6 (4) Title 8, Subtitles 1 and 3;
- 7 (5) Title 9, Subtitle 3; and
- 8 (6) Title 8, Subtitle 4.

9 (b) (1) Except as provided in paragraph (2) of this subsection, the Commission
10 may impose a civil penalty not exceeding \$25,000 against a person who violates a provision
11 of this division, or an effective and outstanding direction, ruling, order, rule, or regulation
12 of the Commission.

13 (2) The civil penalty that the Commission may impose on a common carrier
14 for each violation may not exceed \$2,500.

15 (c) (1) A civil penalty may be imposed in addition to any other penalty
16 authorized by this division.

17 (2) Each violation is a separate offense.

18 (3) Each day or part of a day the violation continues is a separate offense.

19 (d) The Commission shall determine the amount of any civil penalty after
20 considering:

21 (1) the number of previous violations of any provision of this article;

22 (2) the gravity of the current violation;

23 (3) the good faith efforts of the violator in attempting to achieve compliance
24 after notification of the violation; and

25 (4) any other matter that the Commission considers appropriate and
26 relevant.

27 (e) (1) Except as provided in paragraphs (2) and (3) of this subsection, a civil
28 penalty collected under this section shall be paid into the [General Fund of the State]

30 (3) **“LOW-INCOME” MEANS A HOUSEHOLD WITH AN ANNUAL**
31 **ADJUSTED GROSS INCOME AT OR BELOW 175% OF THE FEDERAL POVERTY LEVEL.**

1 **(4) “MICROGRID” MEANS TECHNOLOGY THAT:**

2 **(I) COMBINES CLEAN, DISTRIBUTED POWER GENERATION**
3 **WITH ADVANCED CONTROL EQUIPMENT; AND**

4 **(II) ENABLES PORTIONS OF THE ELECTRIC GRID TO REMAIN**
5 **ONLINE WHEN THE WIDER GRID IS DOWN.**

6 **(5) “MODERATE-INCOME” MEANS A HOUSEHOLD WITH AN ANNUAL**
7 **ADJUSTED GROSS INCOME AT OR BELOW 80% OF THE LOCAL MEDIAN INCOME, AS**
8 **DETERMINED BY THE LATEST MARYLAND DEPARTMENT OF HOUSING AND**

24 **THAT SERVE LOW-INCOME AND MODERATE-INCOME HOUSEHOLDS AT NO COST TO**
25 **THE HOUSEHOLDS.**

26 **(D) (1) BY REGULATION, THE ADMINISTRATION SHALL SET THE TERMS**
27 **AND CONDITIONS FOR THE ISSUANCE OF GRANTS UNDER THE PROGRAM**
28 **CONSISTENT WITH THIS SUBTITLE.**

29 **(2) THE REGULATIONS SHALL INCLUDE:**

1 (I) A COMPETITIVE APPLICATION PROCESS FOR THE
2 PROGRAM; AND

3 (II) CRITERIA AND PROCEDURES FOR AWARDING GRANTS TO
4 ELIGIBLE RECIPIENTS THAT GIVE PRIORITY TO AWARDING GRANTS TO PROJECTS
5 FOR MICROGRIDS THAT:

6 1. USE A COMMUNITY SOLAR ENERGY GENERATING
7 SYSTEM, AS DEFINED IN § 7-306.2 OF THE PUBLIC UTILITIES ARTICLE; AND

8 2. PROVIDE MORE THAN 30% OF THE SYSTEM'S
9 KILOWATT OUTPUT TO LOW-INCOME AND MODERATE-INCOME SUBSCRIBERS.

10 (E) THE FOLLOWING PERSONS ARE ELIGIBLE FOR A GRANT UNDER THE

14 (3) UNITS OF STATE GOVERNMENT; AND

15 (4) LOCAL GOVERNMENTS.

16 (F) A PROJECT IS ELIGIBLE FOR A GRANT UNDER THE PROGRAM IF THE
17 PROJECT:

18 (1) PROPOSES TO DEVELOP A RESILIENCY HUB;

19 (2) WILL OPERATE THE RESILIENCY HUB FOR A PERIOD OF AT LEAST
20 ~~10~~ 5 YEARS; AND

21 (3) WILL SERVE A COMMUNITY OF MAJORITY LOW-INCOME OR
22 MODERATE-INCOME HOUSEHOLDS.

23 (G) THE ADMINISTRATION SHALL:

18 **(G) THE FUND MAY BE USED ONLY FOR:**

19 **(1) GRANTS AWARDED UNDER THE PROGRAM; AND**

20 **(2) COSTS ASSOCIATED WITH ADMINISTERING THE PROGRAM AND**
21 **THE FUND.**

22 **(H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND**
23 **IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.**

24 **(2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO**
25 **THE FUND.**

26 **(I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE**

6 **UNIT OF STATE GOVERNMENT, SHALL IDENTIFY AND APPLY FOR GRANT FUNDING,**

9 (f) The Administration shall use the Fund:

10 (10) subject to subsections (f–2) and (f–3) of this section, to invest in
11 pre–apprenticeship, youth apprenticeship, and registered apprenticeship programs to
12 establish career paths in the clean energy industry under § 11–708.1 of the Labor and
13 Employment Article, as follows:

14 (i) \$1,250,000 for grants to pre–apprenticeship jobs training
15 programs under § 11–708.1(c)(3) of the Labor and Employment Article starting in fiscal
16 year 2021 until all amounts are spent;

17 (ii) \$6,000,000 for grants to youth apprenticeship jobs training
18 programs and registered apprenticeship jobs training programs under § 11–708.1(c)(5) of

25 **(11) TO PROVIDE AT LEAST \$500,000 EACH YEAR TO THE RESILIENCY**
26 **HUB GRANT PROGRAM FUND UNDER § 9–2011 OF THIS TITLE; AND**

27 **[(11)] (12)** to pay the expenses of the Program.

28 (i) (1) In this subsection, “low–income” means having an annual household
29 income that is at or below 175% of the federal poverty level.

30 (2) Except as provided in paragraph (3) of this subsection, compliance fees
31 paid under § 7–705(b) of the Public Utilities Article may be used only to make loans and
32 grants to support the creation of new Tier 1 renewable energy sources in the State that are
33 owned by or directly benefit low–income residents of the State.

1 (3) Compliance fees paid under § 7-705(b)(2)(i)2 of the Public Utilities
2 Article shall be accounted for separately within the Fund and may be used only to make
3 loans and grants to support the creation of new solar energy sources in the State that are
4 owned by or directly benefit low-income residents of the State.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
6 October 1, 2022.
