1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – State Finance and Procurement**

4 **4–322.**

5 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
6 INDICATED.

7 (2) “BROKER REBATE FEE” IS A COMMISSION SHARING PAYMENT
8 BASED ON AN ESTABLISHED COMMISSION REBATE PERCENTAGE.

9 (3) “FUND” MEANS THE DEPARTMENT OF GENERAL SERVICES
10 BROKER REBATE FEE FUND.

11 (B) THERE IS A DEPARTMENT OF GENERAL SERVICES BROKER REBATE
12 FEE FUND.

13 (C) THE PURPOSE OF THE FUND IS TO PROVIDE FUNDING TO SUPPORT THE
14 ACTIONS OF THE SECRETARY IN IMPLEMENTING, REGULATING, ADMINISTERING,
15 AND ENFORCING THIS PART.

16 (D) THE SECRETARY SHALL:

17 (1) ADMINISTER THE FUND; AND

18 (2) DIRECT ANY BROKER REBATE FEES COLLECTED UNDER THIS
19 PART TO THE FUND.

20 (E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT
21 SUBJECT TO § 7–302 OF THIS ARTICLE.

22 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,
23 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

24 (F) THE FUND CONSISTS OF:

25 (1) REVENUE DISTRIBUTED TO THE FUND FROM BROKER REBATE
26 FEES RECEIVED IN CONNECTION WITH ANY LEASE OF BUILDING SPACE BY THE
27 STATE UNDER THIS PART;

28 (2) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;

1 **(3) INTEREST EARNINGS; AND**

2 **(4) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR**
3 **THE BENEFIT OF THE FUND.**

4 **(G) THE FUND MAY BE USED ONLY TO COVER THE EXPENSES, INCLUDING**
5 **ADMINISTRATIVE EXPENSES, OF THE DEPARTMENT IN CARRYING OUT THE**
6 **REQUIREMENTS OF THIS TITLE.**

7 **(H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND**
8 **IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.**

9 **(2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO**
10 **THE FUND.**

11 **(I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE**
12 **WITH THE STATE BUDGET.**

14 (a) (2) (i) Notwithstanding any other provision of law, and unless
15 inconsistent with a federal law, grant agreement, or other federal requirement or with the
16 terms of a gift or settlement agreement, net interest on all State money allocated by the
17 State Treasurer under this section to special funds or accounts, and otherwise entitled to
18 receive interest earnings, as accounted for by the Comptroller, shall accrue to the General
19 Fund of the State.

20 (ii) The provisions of subparagraph (i) of this paragraph do not apply
21 to the following funds:

22 144. the Health Equity Resource Community Reserve Fund;
23 **[and]**

24 145. the Access to Counsel in Evictions Special Fund; **AND**

25 **146. THE DEPARTMENT OF GENERAL SERVICES BROKER**
26 **REBATE FEE FUND.**

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
28 1, 2022.
