## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Carroll County – County Commissioner Districts – Redistricting Plan**

3 FOR the purpose of altering the boundaries for the county commissioner districts in Carroll  
4 County; and generally relating to the county commissioner districts in Carroll  
5 County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

2 each of the two Houses of the General Assembly, and shall take effect from the date it is  
3 enacted.
