AMENDMENTS TO HOUSE BILL 784  
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, after “**Class B**” insert “**and Class C**”; in line 5, after “license” insert “, a Class C (fraternal/sororal/service organization) beer, wine, and liquor license, and a Class C (veterans’ organization or club) beer, wine, and liquor license”; and in lines 20 and 22, in each instance, after “Promotion” insert “and the Leveraging of Alcoholic Beverages Licenses”.

On page 2, in line 2, strike “and” and substitute a comma; in the same line, after “26–902(a)” insert “, 26–1011(a), and 26–1017(a)”; and in line 7, after “26–902(c)” insert “, 26–1011(c), and 26–1017(c)”.

AMENDMENT NO. 2

On page 2, after line 31, insert:

“26–1011.

(a) There is a Class C (fraternal/sororal/service organization) beer, wine, and liquor license.

(c) (1) The license authorizes the license holder to sell beer, wine, and liquor **BY THE GLASS OR BY THE BOTTLE** for on–premises consumption by a member or guest accompanied by a member.

(2) The license holder may allow a person that has leased a private room or other area of the licensed premises for a private social gathering to bring beer, wine, and liquor onto the licensed premises for on–premises consumption.

(a)    There is a Class C (veterans' organization or club) beer, wine, and liquor license.

(c)    The license authorizes the license holder to sell beer, wine, and liquor **BY THE GLASS OR BY THE BOTTLE** at retail at the place described in the license for on-premises consumption.”.

On page 8, strike beginning with “**EXCEPT**” in line 16 down through “**WITHIN**” in line 17 and substitute “**WITHIN**”.

On page 9, in line 4, after “Promotion” insert “and the Leveraging of Alcoholic Beverages Licenses”; in line 17, after “(6)” insert “the Director of the Board of License Commissioners for Prince George’s County, or the Director’s designee;

(7)”;

and in line 25, strike “(7)” and substitute “(8)”.

On page 10, strike beginning with “Chair” in line 3 down through “of” in line 4 and substitute “Chair of the Board of License Commissioners for Prince George’s County, or the Chair’s designee, shall chair”; in line 5, strike “Prince George’s County House Delegation” and substitute “Board of License Commissioners for Prince George’s County”; in line 18, strike the second “and”; and in line 20, after “County” insert “; and

(5)    examine how other counties in the State leverage alcoholic beverages licenses to generate revenue for their county”.
