A BILL ENTITLED

1 AN ACT concerning

2 **Public Safety – Safe Neighborhoods Pilot Program**

3 FOR the purpose of requiring the Governor’s Office of Crime Prevention, Youth, and Victim
4 Services to establish a Safe Neighborhoods Pilot Program to provide doorbell
5 cameras or security systems with doorbell cameras to residents of high-crime areas;
6 and generally relating to the Safe Neighborhoods Pilot Program.

8 Article – Public Safety

9 Section 4-1601 to be under the new subtitle “Subtitle 16. Safe Neighborhoods Pilot
10 Program”

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Public Safety**

16 **SUBTITLE 16. SAFE NEIGHBORHOODS PILOT PROGRAM.**

17 **4-1601.**

18 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
19 **INDICATED.**

20 **(2) “HOME” MEANS A SINGLE-FAMILY DWELLING, SEMIDETACHED**
21 **DWELLING, MULTIFAMILY DWELLING, OR TOWNHOME.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(3) “OFFICE” MEANS THE GOVERNOR’S OFFICE OF CRIME**
2 **PREVENTION, YOUTH, AND VICTIM SERVICES.**

3 **(4) “PROGRAM” MEANS THE SAFE NEIGHBORHOODS PILOT**
4 **PROGRAM.**

5 **(5) “RESIDENT” MEANS AN INDIVIDUAL WHO RESIDES IN A HOME IN A**
6 **DESIGNATED HIGH-CRIME AREA.**

7 **(B) THE GOVERNOR’S OFFICE OF CRIME PREVENTION, YOUTH, AND**
8 **VICTIM SERVICES SHALL ESTABLISH A SAFE NEIGHBORHOODS PILOT PROGRAM**
9 **TO:**

10 **(1) PURCHASE DOORBELL CAMERAS OR SECURITY SYSTEMS WITH**
11 **DOORBELL CAMERAS AND INSTALL THE CAMERAS OR SYSTEMS IN THE HOMES OF**
12 **RESIDENTS WHO APPLY TO PARTICIPATE IN THE PROGRAM;**

13 **(2) ENGAGE COMMUNITY ORGANIZATIONS AND RESIDENTS TO**
14 **PROMOTE COMMUNITY PARTICIPATION IN THE PROGRAM;**

15 **(3) PROVIDE TRAINING FOR RESIDENTS ON THE USE OF A DOORBELL**
16 **CAMERA OR SECURITY SYSTEM WITH A DOORBELL CAMERA, INCLUDING HOW TO**
17 **ACCESS VIDEO PRODUCED BY THE CAMERA;**

18 **(4) ESTABLISH A PROCESS FOR RESIDENTS TO CONTACT LAW**
19 **ENFORCEMENT IN ORDER TO SUBMIT VIDEO OBTAINED BY A DOORBELL CAMERA AS**
20 **EVIDENCE; AND**

21 **(5) PROVIDE INFORMATION TO RESIDENTS ON THE PROCESS FOR THE**
22 **SUBMISSION OF VIDEO CAPTURED BY A DOORBELL CAMERA TO LAW ENFORCEMENT.**

23 **(C) THE OFFICE, IN COORDINATION WITH LOCAL LAW ENFORCEMENT**
24 **AGENCIES, SHALL:**

25 **(1) IDENTIFY HIGH-CRIME AREAS WITHIN LOCAL COMMUNITIES IN**
26 **THE STATE;**

27 **(2) ESTABLISH A PROCESS FOR RESIDENTS OF HIGH-CRIME AREAS**
28 **IDENTIFIED BY THE OFFICE TO APPLY TO PARTICIPATE IN THE PROGRAM; AND**

29 **(3) FACILITATE TRAINING FOR RESIDENTS ON THE USE OF DOORBELL**
30 **CAMERAS AND SECURITY SYSTEMS WITH DOORBELL CAMERAS.**

1 **(D) (1) ON OR BEFORE DECEMBER 31, 2025, THE OFFICE SHALL REPORT**
2 **TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2-1257 OF THE STATE**
3 **GOVERNMENT ARTICLE, ON:**

4 **(I) THE CRIME RATE WITHIN THE IDENTIFIED HIGH-CRIME**
5 **AREAS FOLLOWING THE IMPLEMENTATION OF THE PROGRAM;**

6 **(II) THE TOTAL NUMBER OF CRIMES SOLVED WITH THE AID OF**
7 **EVIDENCE OBTAINED BY CAMERAS PROVIDED THROUGH THE PROGRAM;**

8 **(III) THE SENSE OF SECURITY AMONG RESIDENT PARTICIPANTS**
9 **OF THE PROGRAM;**

10 **(IV) THE TOTAL NUMBER OF PARTICIPANTS IN THE PROGRAM;**
11 **AND**

12 **(V) THE USEFULNESS AND VIABILITY OF THE PROGRAM BASED**
13 **ON A COST-BENEFIT ANALYSIS.**

14 **(2) THE OFFICE SHALL PUBLICLY POST THE REPORT REQUIRED**
15 **UNDER PARAGRAPH (1) OF THIS SUBSECTION ON ITS WEBSITE.**

16 **(E) THE OFFICE SHALL ADOPT REGULATIONS TO IMPLEMENT THIS**
17 **SECTION, INCLUDING REGULATIONS THAT:**

18 **(1) ENSURE THAT A DOORBELL CAMERA OR SECURITY SYSTEM WITH**
19 **A DOORBELL CAMERA THAT IS PROVIDED TO A RESIDENT OF A HIGH-CRIME AREA**
20 **INCLUDES 2 YEARS OF SERVICE AT NO COST TO THE RESIDENT;**

21 **(2) PROHIBIT A LAW ENFORCEMENT AGENCY FROM COMPELLING A**
22 **RESIDENT TO SHARE FOOTAGE OBTAINED BY A DOORBELL CAMERA OR SECURITY**
23 **SYSTEM WITH A DOORBELL CAMERA PROVIDED THROUGH THE PROGRAM; AND**

24 **(3) INCLUDE MEASURES THAT PROTECT THE PRIVACY OF RESIDENTS**
25 **AND ENSURE THAT ANY DATA COLLECTED IS SECURELY STORED AND PROTECTED**
26 **FROM UNAUTHORIZED ACCESS OR BREACHES.**

27 **(F) BEGINNING IN FISCAL YEAR 2025 AND EACH FISCAL YEAR THEREAFTER,**
28 **THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION**
29 **OF \$5,000,000 FOR THE PROGRAM TO BE USED ONLY TO:**

30 **(1) CARRY OUT THE PURPOSES OF THE PROGRAM; AND**

1 **(2) COVER EXPENSES INCURRED BY THE OFFICE THAT ARE**
2 **ATTRIBUTABLE TO THE PROGRAM, INCLUDING PERSONNEL HIRED BY THE OFFICE**
3 **AND ASSIGNED TO THE PROGRAM.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2023. It shall remain effective for a period of 3 years and, at the end of September
6 30, 2026, this Act, with no further action required by the General Assembly, shall be
7 abrogated and of no further force and effect.
